Test Graphs of Occupied Bandwidth and -26dB Bandwidth for band 5.47-5.725 GHz



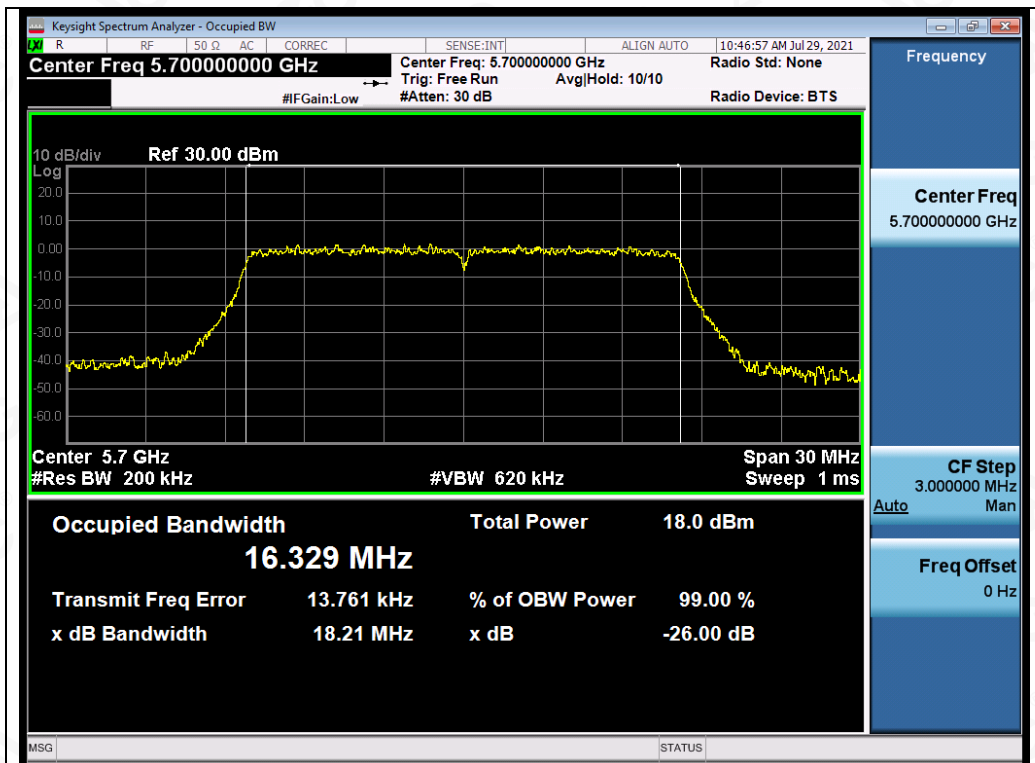
