DETEMINATION OF MPE EXEMPTION

2.1 Single RF Source

As per §1.1307(b)(3)(i),

- (A) The available maximum time-averaged power is no more than 1 mW, regardless of separation distance. This exemption may not be used in conjunction with other exemption criteria other than those in paragraph (b)(3)(ii)(A) of this section. Medical implant devices may only use this exemption and that in paragraph (b)(3)(ii)(A);
- (B) Or the available maximum time-averaged power or effective radiated power (ERP), whichever is greater, is less than or equal to the threshold P_{th} (mW) described in the following formula. This method shall only be used at separation distances (cm) from 0.5 centimeters to 40 centimeters and at frequencies from 0.3 GHz to 6 GHz (inclusive). P_{th} is given by:

$$P_{th} \; (\text{mW}) = \begin{cases} ERP_{20 \; cm} (d/20 \; \text{cm})^x & d \leq 20 \; \text{cm} \\ \\ ERP_{20 \; cm} & 20 \; \text{cm} < d \leq 40 \; \text{cm} \end{cases}$$

 and f is in GHz;

and

$$ERP_{20~cm}~(\text{mW}) = \begin{cases} 2040f & 0.3~\text{GHz} \le f < 1.5~\text{GHz} \\ \\ 3060 & 1.5~\text{GHz} \le f \le 6~\text{GHz} \end{cases}$$

d = the separation distance (cm);

Note: when 10-g extremity SAR applies, SAR test exemption may be considered by applying a factor of 2.5 to the SAR-based exemption thresholds.

(C) Or using Table 1 and the minimum separation distance (R in meters) from the body of a nearby person for the frequency (f in MHz) at which the source operates, the ERP (watts) is no more than the calculated value prescribed for that frequency. For the exemption in Table 1 to apply, R must be at least $\lambda/2\pi$, where λ is the free-space operating wavelength in meters. If the ERP of a single RF source is not easily obtained, then the available maximum time-averaged power may be used in lieu of ERP if the physical dimensions of the radiating structure(s) do not exceed the electrical length of $\lambda/4$ or if the antenna gain is less than that of a half-wave dipole (1.64 linear value).


2.3 1-mW Test Exemption result for Single Source


2.3.1 Bluetooth

Bluetooth packets are broadcast with a hardcoded sleep cycle will ensure the duty cycle does not exceed the limits shown below.

The Maximum RF packet transmission duration is 1.024 milliseconds.

Software sleeps for a minimum duration of 100ms after every transmission.





Therefore:

Maximum duty cycle = (1.024 / 100) = 1.024%

Maximum specified output power = 8 dBm (6.310 mW)

Antenna peak gain = 1 dBi

Thus, the maximum available time-averaged output power = 6.310 mW x 1.024% = 0.0646 mW (= -11.89dBm)

So BT is SAR test exemption because maximum available time-averaged output power is less than 1 mW.
