
3. submit such completed and signed, on MBSA's behalf, to the the Federal Communication Commission (FCC) or such other entity to which such application might be required to be submitted from time to time, provided that MBSA, prior to each such submission and in respect of each such certificate, has had sight of and has approved the content thereof.
4. To discuss and resolve any queries raised by the the Federal Communication Commission in relation to the submitted form to ensure that the application is approved.

Save as provided for and subject to the rights of approval as reserved herein, the aforementioned company nor its employees shall not have any authority or power to bind MBSA, in whatever manner, and/or found any liability of whatever nature, howsoever arising, or do anything, on behalf of MBSA without the prior written consent of no less than two of the directors of MBSA.

The nomination, constitution and appointment effected hereby, and the powers accordingly conferred, shall pertain to the stated period in numbered paragraph 1 above, and shall take effect:

1. from the date of signature hereof, and shall automatically terminate after a period of one (1) calendar year from the date of signature hereof without the need for any express revocation or termination by MBSA, without precluding at all, MBSA's rights at law or otherwise to revoke and otherwise terminate such nomination, constitution and appointment, and the powers accordingly conferred, at any earlier time; and
