IMPORTANT SAFETY INFORMATION

These warnings apply to the appliance, and where applicable, to all tools, accessories, chargers or mains adaptors.

Follow these safety instructions when using or handling your Atom hard hat and accessories to reduce the risk of fire, electric shock and injury to persons or property.

Use only as described in this XYZ Reality User Manual. Do not carry out any maintenance other than that shown in this manual or advised by XYZ Reality customer support.

Do not disassemble / customise this product or accompanying accessories in any way.

Always be aware of your environment. Only use the product when the surrounding area is safe and in accordance with existing site risk assessments and procedures.

Use extra care while operating the product without supervision. Objects in augmented reality can appear real and can distract from the real world. Ensure that the working area is clear of any trip hazards.

Use only XYZ Reality approved accessories and replacement parts.

Take care to keep the product dry and in the event of the product and/or any accessory becoming wet, do not use and contact your XYZ Reality customer representative.

Do not use or charge this product within 3 meters of a pool or body of water. Do not use on wet, muddy or greasy surfaces. Do not expose to moisture, rain or snow.

If liquid has been sprayed, splashed or poured on the product, or any component of the product has been dropped or damaged, or the product exhibits any distinct change in performance, disconnect power from product and do not use further. Contact your XYZ Reality customer representative.

Keep the product clean in accordance with the instructions in this user manual. Only clean using non-aggressive cleaning products such as lens cleaner cloth and the microfibre cloth provided in your box.

Do not use a battery pack or appliance that is damaged or modified. Damaged or modified batteries may exhibit unpredictable behaviour resulting in fire, explosion or risk of injury. Do not expose battery pack or appliance to fire or excessive temperatures. Exposure to fire or temperatures above 60°C (140°F) may cause explosion.



NOTE

The Atom is primarily designed to provide protection to the wearer against falling objects and airborne particulates, preventing consequential brain and eye injuries in accordance with harmonized standards EN 397 and EN 166.

Safety performance of the product is assessed using harmonized standard EN 397. The standard mandates testing across a range of temperatures, UV radiation and water exposures.

In each of the tests the force transmitted through the hard hat that is less than 5kN.

The Atom is designed for use in conventional construction sites and should not be used while working from heights.



IMPORTANT SAFETY INFORMATION

The battery is a sealed unit and under normal circumstances poses no safety concerns. In the unlikely event that liquid leaks from the battery, do not touch the liquid as it may cause irritation or burns, and observe the following precautions:

- Skin contact – can cause irritation. Wash with soap and water.
- Inhalation – can cause respiratory irritation. Expose to fresh air and seek medical advice.
- Eye contact – can cause irritation. Immediately wash eyes thoroughly with water for at least 15 minutes. Seek medical attention.
- Disposal – wear gloves to handle the battery and dispose of immediately, following local ordinances or regulations.

Follow all charging instructions and do not charge the battery pack or the appliance outside of the temperature range specified in the instructions. Charging improperly or at a temperature outside of the specified range may damage the battery and increase the risk of fire. To ensure maximum battery life, XYZ Reality recommends the following:

- When not in use, the appliance should be stored at room temperature. Recommended range: -10°C (14°F) to +40°C (104°F).
- The ambient temperature range for operation should be 0°C (32°F) to +40°C (104°F). For charging, the ambient temperature range should be 0°C (32°F) to +40°C (104°F).

NOTE: Proper functionality is not guaranteed when operating outside of the recommended temperature range.

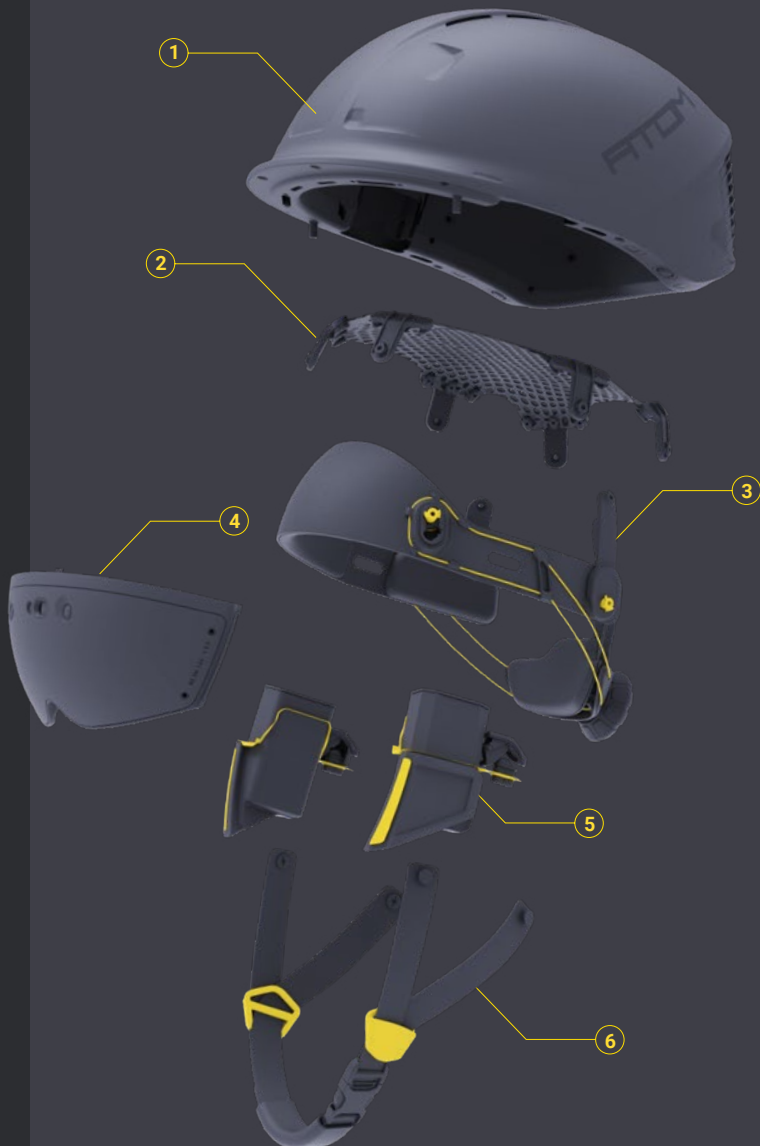

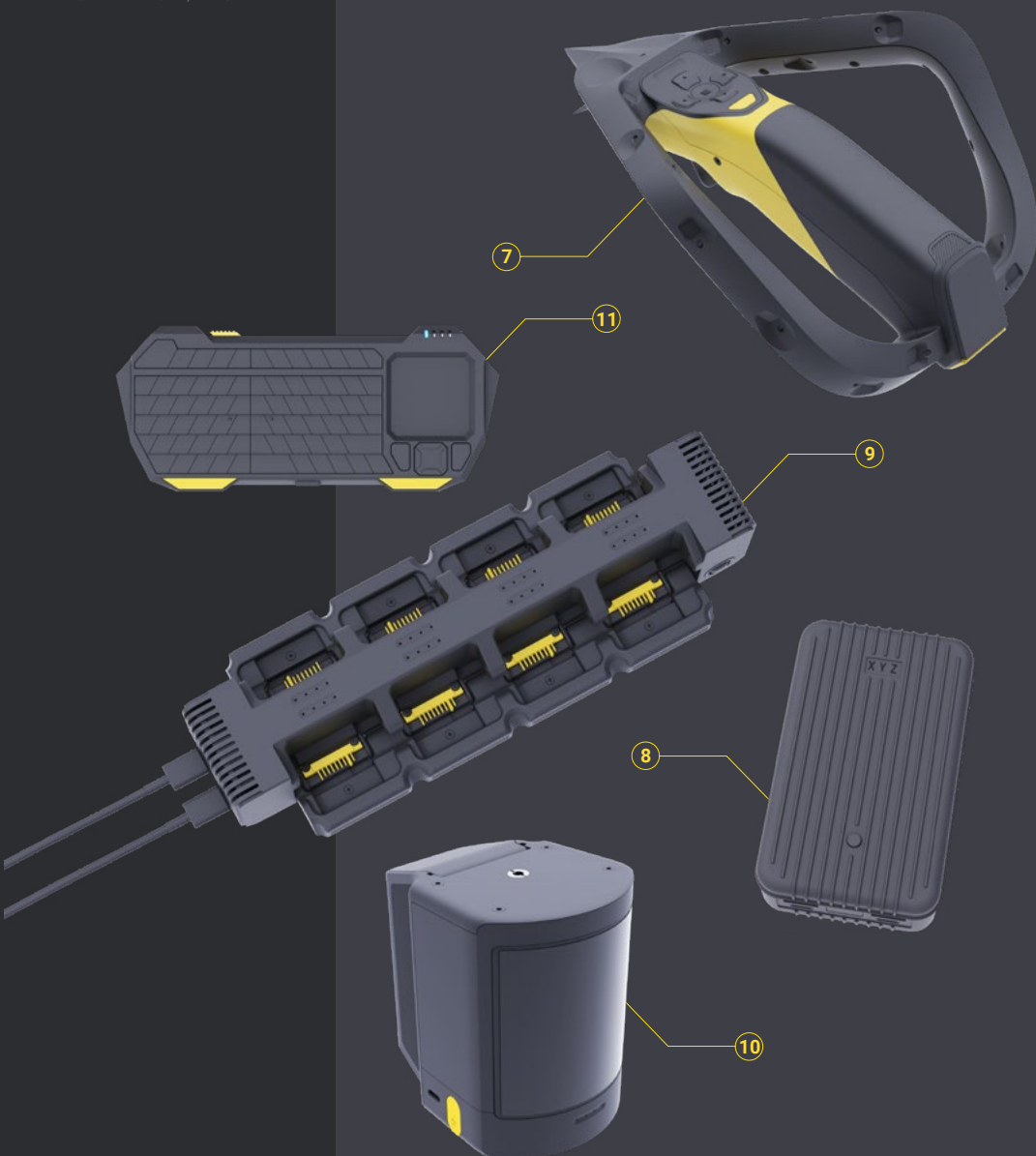

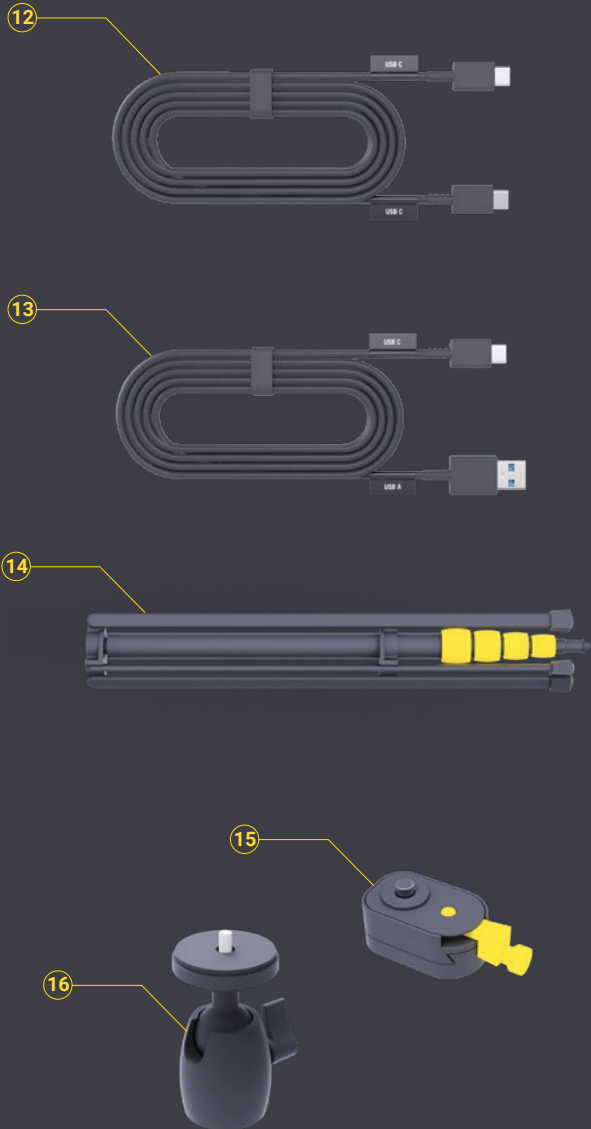

Checking the Charge.

Press and hold the Charge State check button on the battery to check the charge status.

Up to four LEDs will illuminate corresponding to the charge remaining in the battery.

NOTE

A battery with 25% LED flashing should not be used before being recharged.

PREPARING THE HARD HAT

Inspecting the Visor and Hard Hat Shell.

Visually inspect the Hard Hat prior to each use for signs of dents, cracks, penetration, and any damage due to impact, rough treatment, or wear that might reduce the degree of protection originally provided. A helmet with worn, damaged or defective parts should be removed from service.

Cleaning the Visor and Hard Hat Shell.

Wipe down front surface of the AR Visor (B) using the microfiber cloth provided in your XYZ Reality case.

The secondary dry wipe cloth can be used on the Outer Shell (A). Ensure all reflective windows are clean and free from dirt or dust collected on site.

Do not apply chemical or liquid cleaners directly to the Visor and Hard Hat Shell or use abrasive materials.

Only clean using non-aggressive cleaning products such as lens cleaner cloth and the microfiber cloth provided in your box.



Replacing the Batteries.

Remove the battery wings from the Hard Hat using the battery wing release buttons (A).

Check that your internal battery packs are charged using the battery check button (B).

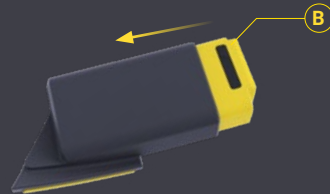
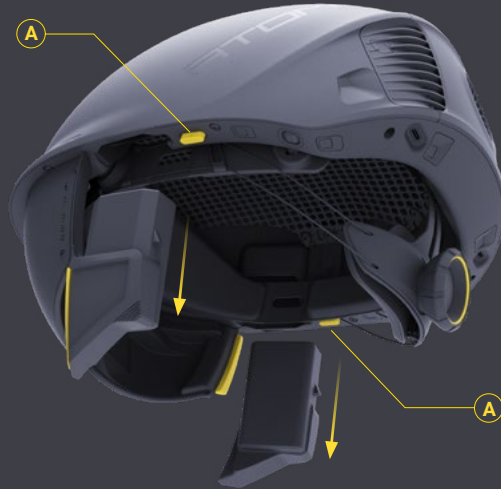
Insert the internal battery pack into each wing and reinsert into the hard hat until a positive click is felt indicating the wing is locked.

NOTE

Internal battery contact pins should be checked and free of moisture and dust before being inserted into the Hard Hat. Wet/Soiled contact may cause damage to your Atom.



USE OF THE INTERNAL BATTERIES



Adjusting nape tension.

Use rotary ratchet dial at the back of your hard hat to adjust the size of the halo.

This hard hat conforms to a head size range of 52cm - 62cm.



ADJUSTMENT OF THE NAPE SUPPORT



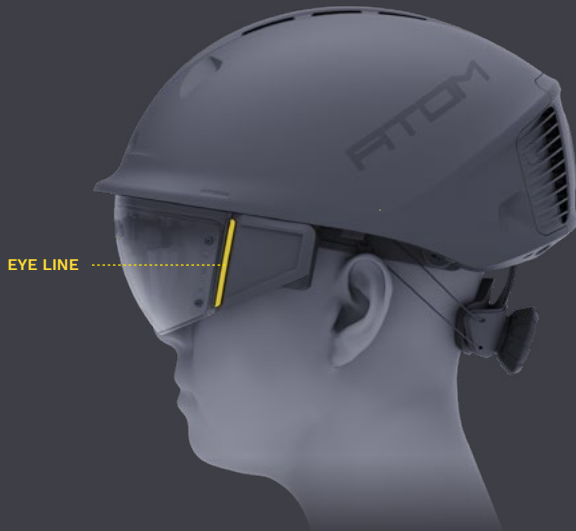
Checking Eye Line.

Position hard hat onto your head, ensure the centre of the lenses of the AR visor line up with the centre of your eyes.

Tighten ratchet strap accordingly.

Final Checks.

Make sure everything is set up as shown here and that you have followed your construction site's health and safety procedures before heading out on site.

NOTE

If using the External Battery Module (A) this can be worn on either side of the hip. The battery cable should wrap around the back of the waist.

If using internal batteries, the external battery module is not required.

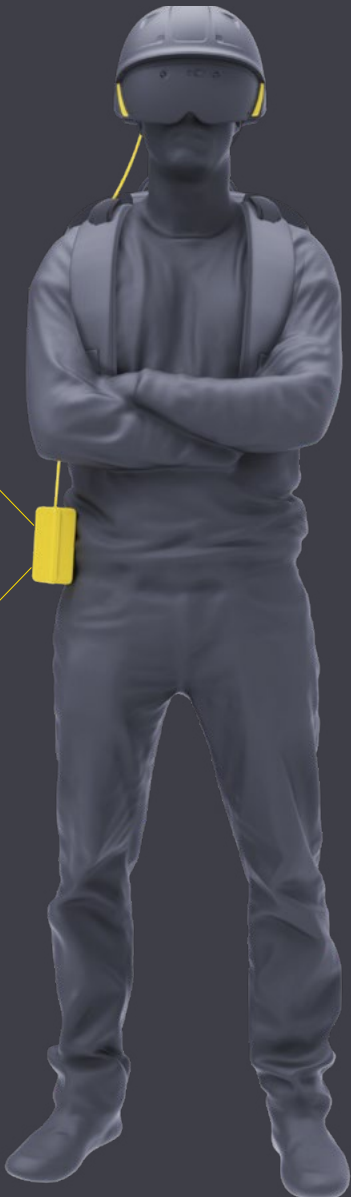

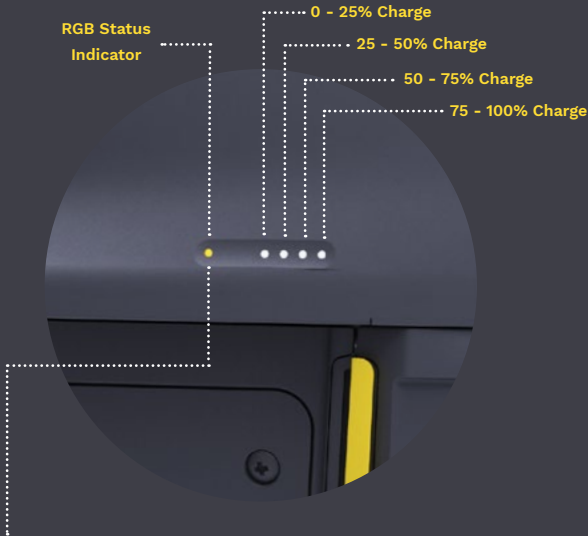

Plugging In.

If you do not have internal batteries available, the external power pack can be used as an alternative power source.

Take out the XYZ Reality provided USB Type-C cable and plug into the back of the hard hat.

Both the left and right USB Type-C ports can be used to power the hard hat.



Only use XYZ Reality supplied USB Type-C cables. Do not use alternative cables.

USING THE ALTERNATIVE POWER PACK

Connecting the pack.

Plug you hard hat into the 100 Watt USB C port of the XYZ Reality External Battery Module (A), using the other end of the USB Type-C cable.

Powering up.

Before attempting to power on the hard hat, press the power button (B) on the external battery to activate it. The digital display (C) will show the remaining battery percentage - if it does not illuminate, you must charge the power pack before use.

NOTE

This step is only necessary if not using the XYZ Reality internal battery packs.

Do not use the 60 Watt USB-C port to power The Atom hard hat.



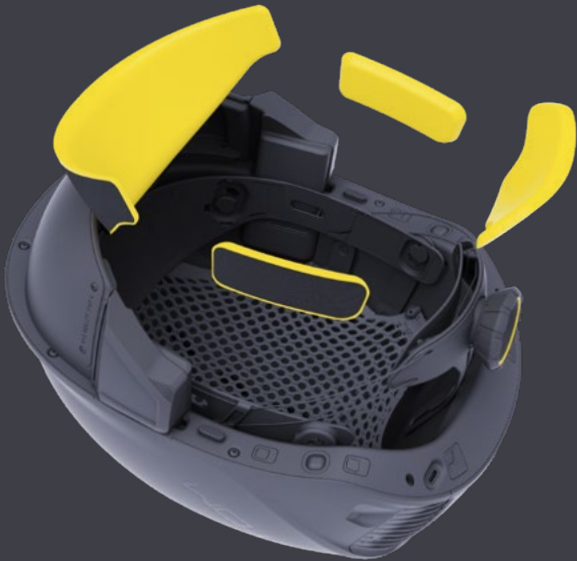
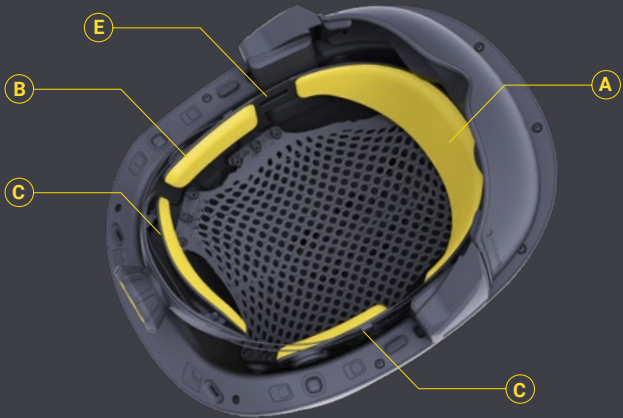
Comfort Foam

The foam pads (A,B,C,D) are washable. It is recommended to wash foam pads once every week.

The comfort foam on the halo (E) can be detached by peeling back against the VELCRO™ back.

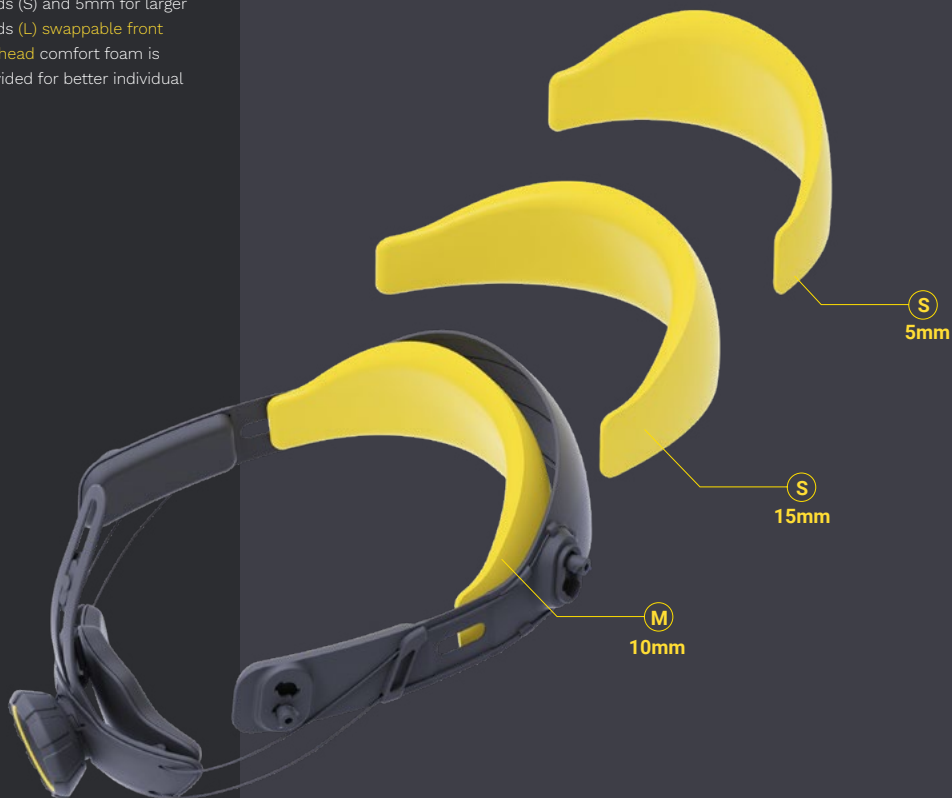

Comfort Foam

The Atom headset will come preinstalled with a 10mm (M) thick front forehead comfort foam.

Additional 15mm for smaller heads (S) and 5mm for larger heads (L) swappable front forehead comfort foam is provided for better individual fit.



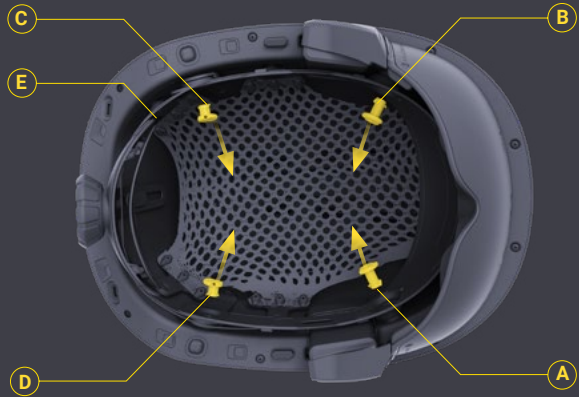
Removing the Halo

The Halo (E) can be swapped out and replaced if required to further support hygiene requirements of a site.

To do so first twist and then pull the 4 connection pins (A,B,C,D) located under the 4 comfort foam pads.



ADDITIONAL SIZE ADJUSTMENT STEPS



Height adjust (1 of 2)

For larger head forms, the internal wearing height of the hard hat can be adjusted.

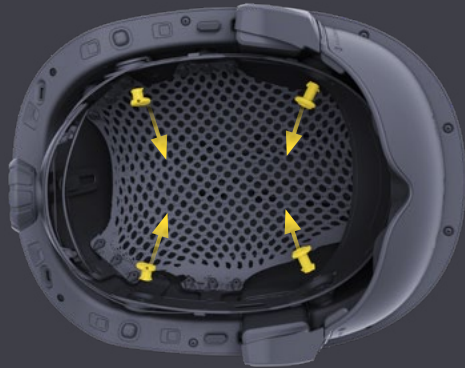
To adjust the wearing height of your hard hat, first remove the halo (E).

The halo (E) can be disconnected from the hard hat by the 4 connection pins (A,B,C,D) highlighted in the top image.

Rotate and twist out the pins with a light force to pop out the cradle from each of the connection tabs.



ADDITIONAL SIZE ADJUSTMENT STEPS



Height adjust (2 of 2).

Lower the halo (E) by 10mm and reconnect the 4 connection pins into the top hole of the Halo.

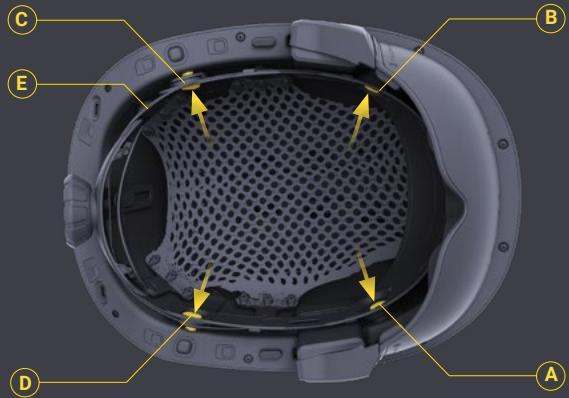
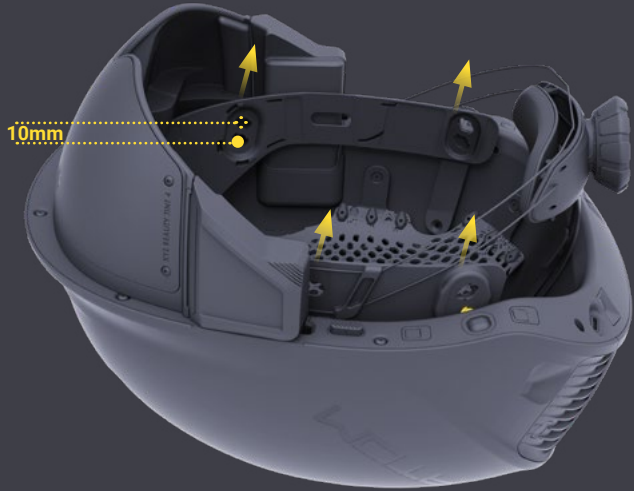
Insert each pin (A,B,C,D) and gently twist until you feel a small click, this indicates that the pin is correctly inserted and locked.

NOTE

Take care when performing these steps, Incorrectly installing the halo, or failure to correctly lock the pins may compromise the safety of the hard hat.



ADDITIONAL SIZE ADJUSTMENT STEPS





CHIN STRAP

Chin strap removal.

The chin strap (D) can be removed by hand through 4 thumb screws.

Step 1.

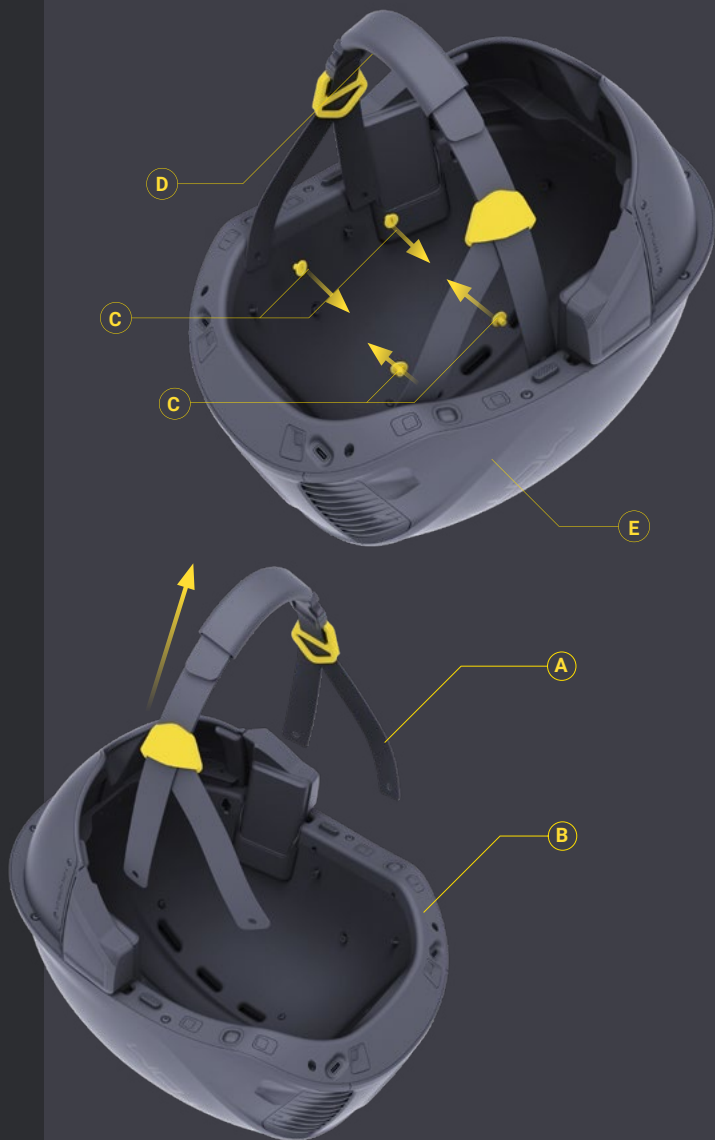
First remove the halo as demonstrated on page 15.

Step 2.

Unscrew the 4 thumb screws (C) that connect the chin straps (D) to the inner shell of the hard hat (I).

Step 3.

Remove chin strap and replace thumb screws back into the inner shell of the hard hat (E).



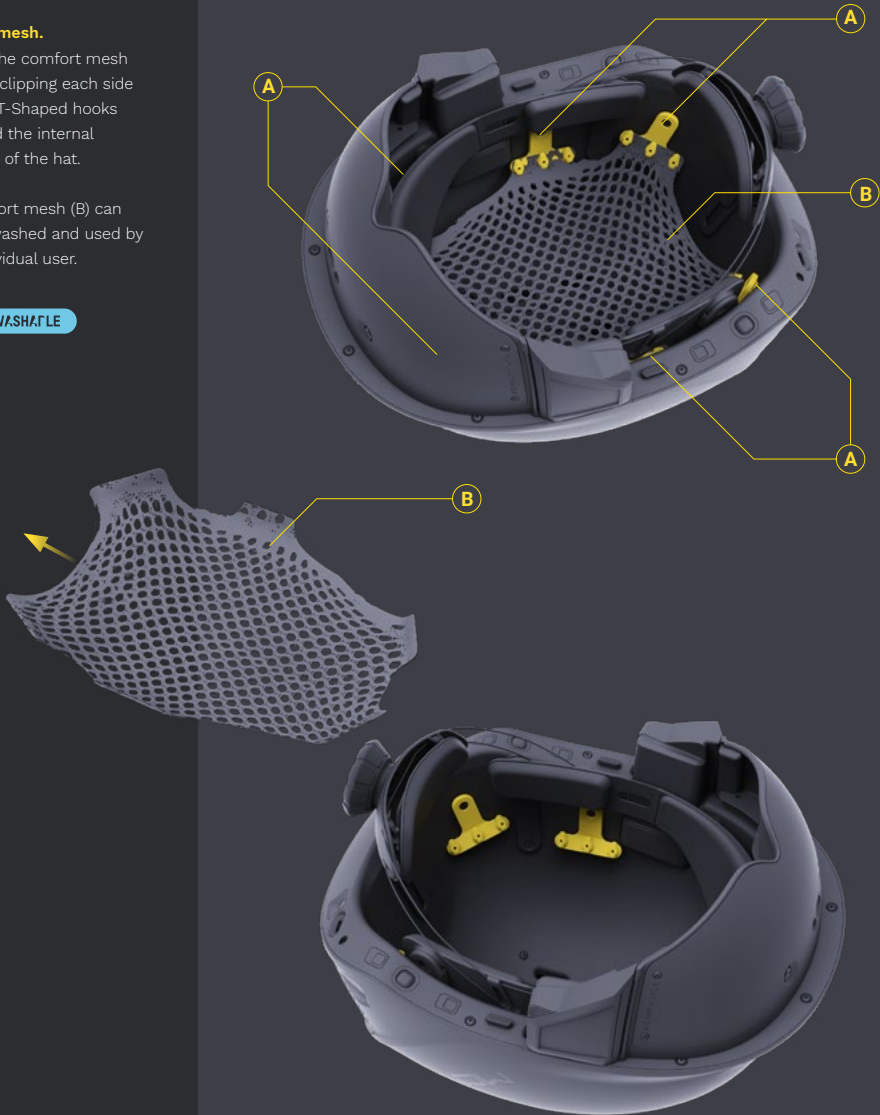
Comfort mesh.

Remove the comfort mesh (B) by un-clipping each side from the T-Shaped hooks (A) around the internal perimeter of the hat.

The comfort mesh (B) can then be washed and used by each individual user.



COMFORT MESH REMOVAL





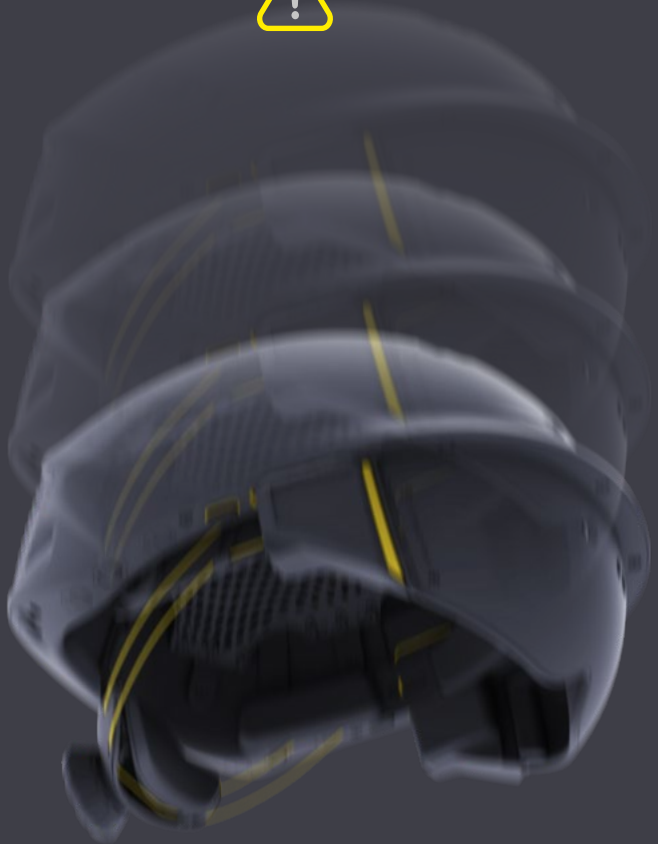
LIMITATION OF PROTECTION

Safety awareness.

Users are cautioned that if unusual conditions prevail (for example, higher or lower extremes of temperature than those described), or if there are signs of abuse of or damage to the helmet or of any component, the degree of protection may be reduced. Any helmet that has received an impact should be removed from service, since the impact may have substantially reduced the ability of the helmet to continue to offer protection.

NOTE

Certain helmet materials may be susceptible to damage from ultraviolet light and chemical degradation. Periodic examinations should be made of all protective helmets and, in particular, those worn or stored in areas exposed to sunlight for long periods. Ultraviolet degradation may first manifest itself in a loss of surface gloss, called chalking or discoloration. Upon further degradation, the surface will craze or flake away, or both. At the first appearance of any of these phenomena, the shell should be replaced.





ADDITIONAL PRECAUTIONS

Because the Hard Hat can be damaged, they should not be abused. They should be kept free from abrasions, scrapes, and nicks and should not be dropped, thrown, or used as supports. This applies especially to helmets that are intended to afford protection against electrical hazards.

The Hard Hat should not be stored or carried on the rear window shelf of an automobile, since sunlight and extreme heat may cause degradation that will adversely affect the degree of protection they provide. Also, in the case of an emergency stop or accident, the helmet might become a hazardous impactor.

Users should exercise care in the selection and installation of additional accessories. Any additional accessories to the helmet may adversely affect the level of protection. The user should make sure that any accessory is compatible with the helmet. Contact the helmet or accessory manufacturer for compatibility information.

Users should never alter or modify the helmet (e.g. drill, glue, cut, etc.) to accept accessories unless instructed to do so by the helmet manufacturer. Helmet decorations should not be used to obscure dents, cracks, non-manufactured holes, other penetrations, burns or other damages.

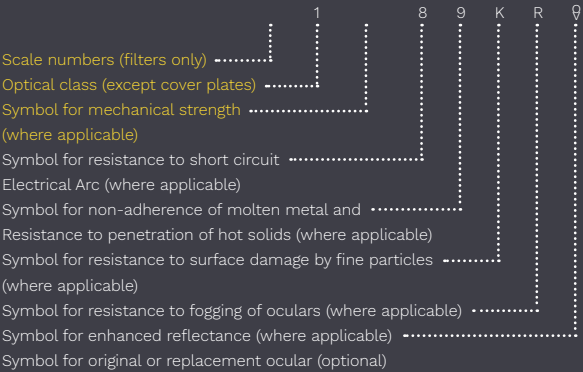
HARD HAT APPROVALS

The XYZ Reality Atom hard hat has been tested and approved by BSI, conforming to the European standards of EN 397 and EN 166 for health and safety compliance.

The European Standard EN 397 specifies physical and performance requirements for industrial safety helmets. The mandatory requirements apply to helmets for general use in industry. Industrial safety helmets are intended primarily to provide protection to the wearer against falling objects and consequential brain injury and skull fracture.

The European Standard EN 166 specifies functional requirements for various types of personal eye-protectors used against various hazards, as encountered in industry, laboratories, educational establishments, DIY activities, etc. which are likely to damage the eye or impair vision, with the exception of nuclear radiation, X-rays, laser beams and low temperature infrared (IR) radiation emitted by low temperature sources.

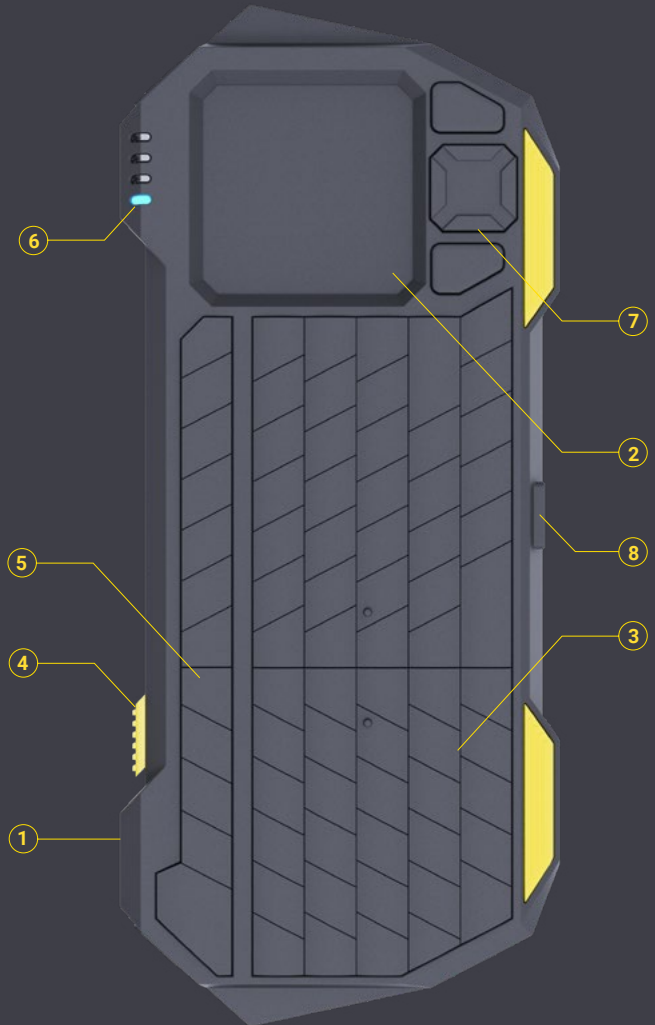

POWERING THE KEYBOARD ON/OFF

Powering on.

To turn on the keyboard, slide the top slider (A) into the "ON" position (B).

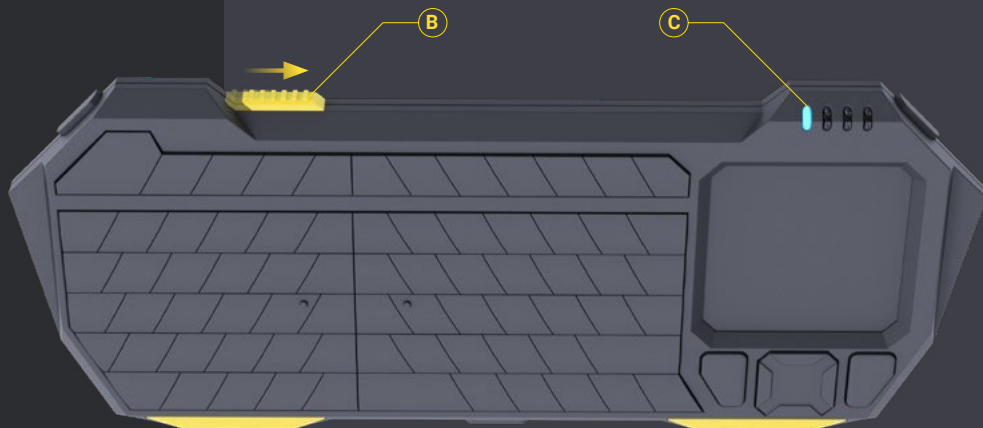
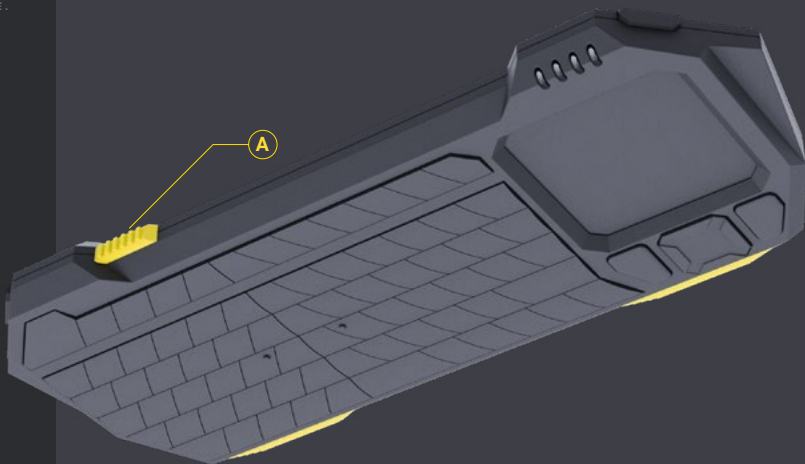
When turned on, the power/bluetooth LED (C) should illuminate with a solid blue light.

Powering off.

To turn off the keyboard, slide the top slider (A) into the "OFF" position.

NOTE

If the keyboard power LED does not illuminate, the keyboard may need charging. Please refer to the 'Charging the Keyboard' page for details.






Only perform this step if asked to do so:

Each keyboard supplied comes pre-configured to its hard hat, please do not attempt to re-pair the keyboard unless instructed to do so by an XYZ Reality representative.

Bluetooth pairing.

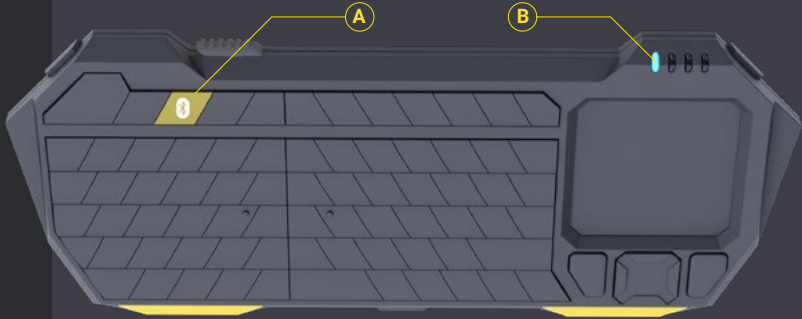
To activate pairing mode, press the bluetooth button on the top row of the keyboard. (A) 

When pairing mode is active the power/bluetooth LED will constantly flash blue. (B)

You can pair the hard hat with the keyboard from within The Atom software.

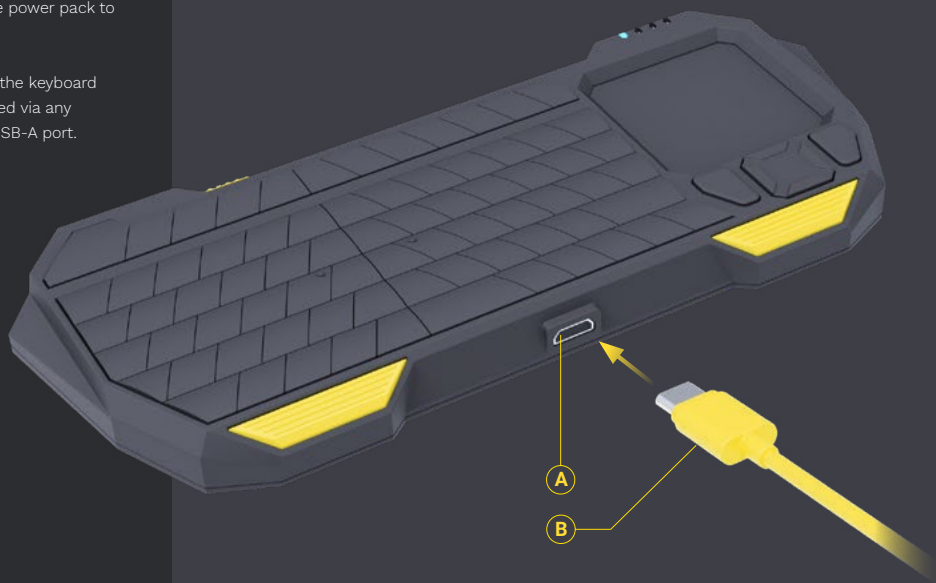
CHARGING THE KEYBOARD

Plugging in power.

To charge the controller, plug the a compatible Micro USB cable (B) into the Micro USB charging port on the bottom of the keyboard (A).

Plug the other end of the cable into the power output port of The Atom's external power pack and push the button on the power pack to activate it.

Alternatively, the keyboard can be charged via any compatible USB-A port.

CHECKING FOR SOILING

Checking for Dirt.

Before using the controller, check all surfaces for dust or dirt covering the sensor surfaces.

Dirt or dust covering these sensors could negatively affect the accuracy and precision of the system and compromise effective operation of The Atom.

Cleaning Dirt.

Only use clean microfiber cloths to gently remove loose dirt and dust from the controller. Do not apply chemical or liquid cleaner directly to the controller surfaces, or use abrasive materials.

NOTE

If the level of soiling is such that the controller cannot be effectively cleaned, or has become physically damaged do not attempt to use the controller and seek a replacement.





REPLACING CONTROLLER BATTERY

Remove Battery Door.

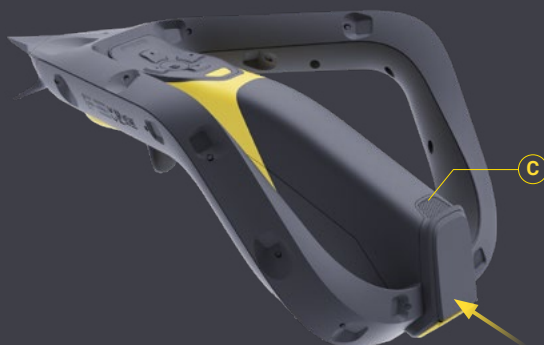
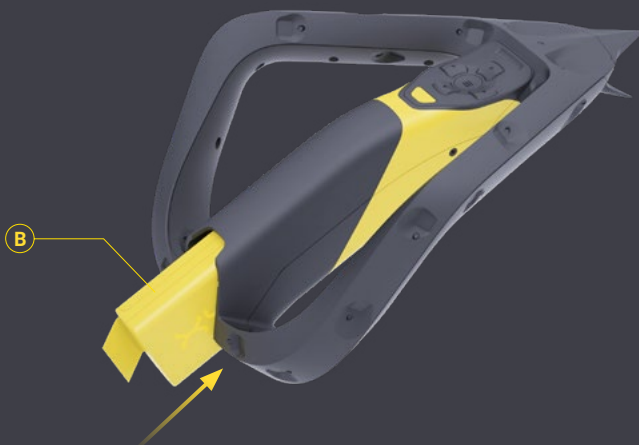
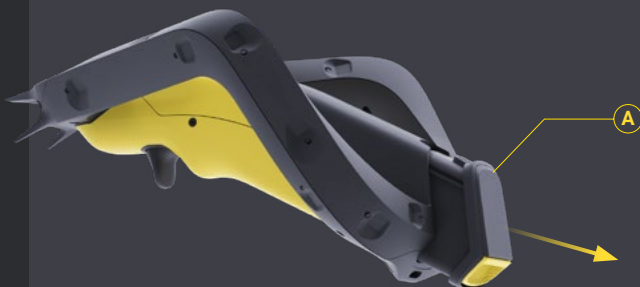
Release the battery door (A) latch and pull the door out of the controller body.

Insert Battery.

Insert a charged battery into the controller body (B).

Replace Battery Door.

Push the battery door back into the body (C) until the latch clicks down and the door is locked in place.





POWERING ON/OFF THE CONTROLLER

Powering ON.

Press and hold the power button (A) on the controller, the status LED should illuminate (B).

Powering OFF.

To power OFF the controller, please press and hold the power button (A) for 2 seconds. The LEDs will switch off when the controller powers OFF.

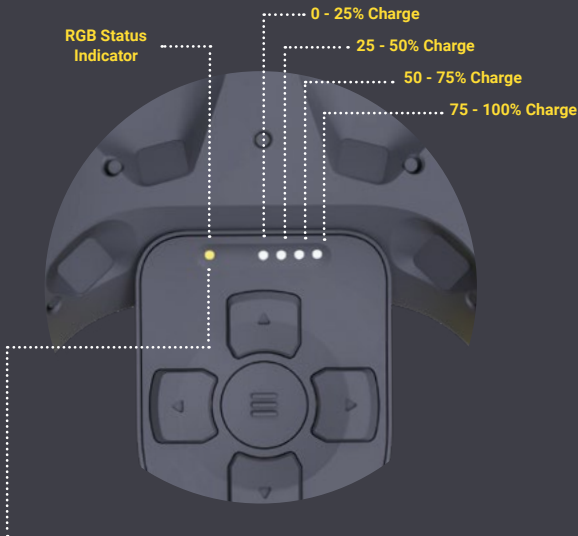

If the controller does not power on when the button is pressed, please check the battery is charged. If the controller still does not power on please contact customer support.

Stabilising.

When touching-on retromarkers during calibration, first place the two stability legs (A) onto the surface just below the retromarker.

Touching-on.

Once stable, gently roll the tip into the centre of the retromarker (B) then hold in place and calibrate the marker's position (as instructed in The Atom's augmented reality interface). If the tip does not touch dead-centre reposition the stability legs and retry.

REPLACING BEACON BATTERIES

Step 1.

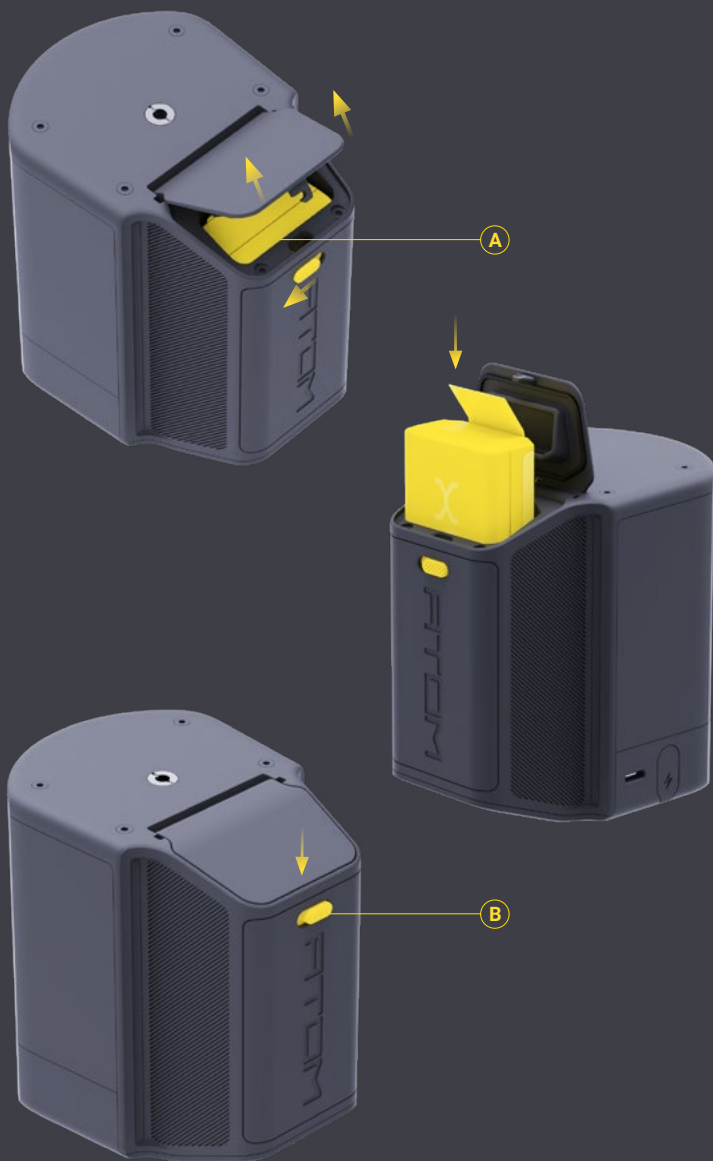
Slide the battery door release (A) to open the battery compartment cover.

Step 2.

Insert a charged XYZ Reality internal battery into the battery compartment.

Step 3.

Close the battery door until the release button (B) clicks closed and locked.



Powering ON.

Press and hold the power button (A) on the beacon, the LCD display (B) and the battery LEDs (C) should illuminate (if external power is in use these LEDs will not illuminate).

Powering OFF.

To power OFF the beacon, please press and hold the power button (A) for 2 seconds. The LEDs and display will switch off when the beacon powers OFF.

Battery Level.

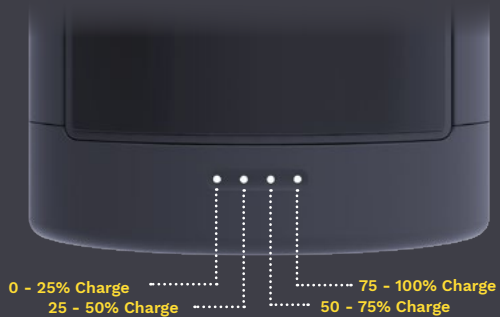
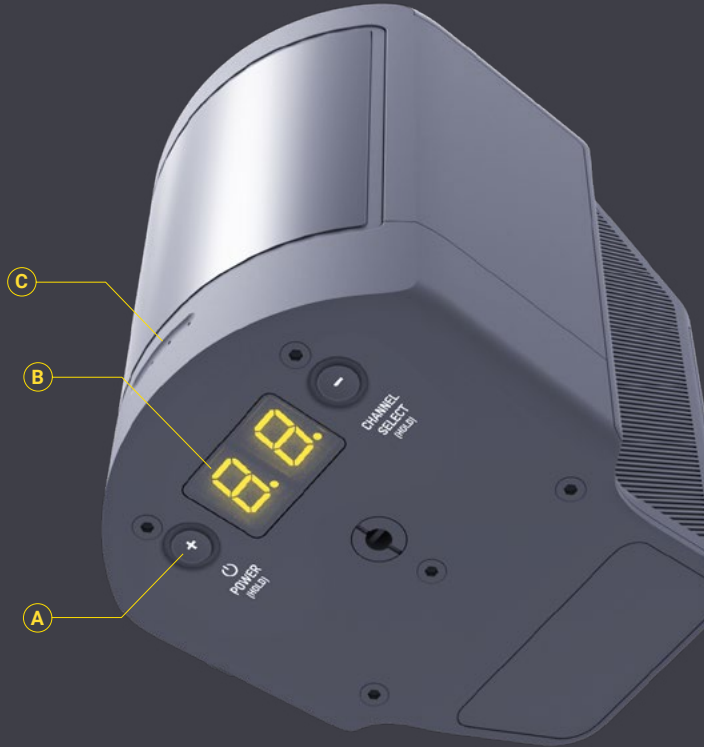
When powered on, the four frontal LEDs will display battery remaining.

NOTE

If the tracking beacon does not power on when the button is pressed, please check the battery is charged. If the tracking beacon still does not power on please contact customer support.



POWERING ON/OFF THE BEACON



Depending on the use case, the tracking beacons will need to be in different channels.

Activating Channel Mode.

Press and hold the channel select button (B) for two seconds. The display will indicate the current channel selection.

Select Channel.

Once the changing mode is active, push the + or - buttons (A & B) to select the operating channel of the tracking beacon.

Confirm Channel.

Press and hold the channel select button (B) for two seconds to confirm channel selection.



SELECTING TRACKING CHANNELS

All Tracking Beacons covering a given tracking zone must each be set to **different channel (example below)**

Power OFF.

To clear errors, first power OFF the beacon, please press and hold the power button (A) for 2 seconds. The LEDs and digital display will switch off when the beacon powers OFF.

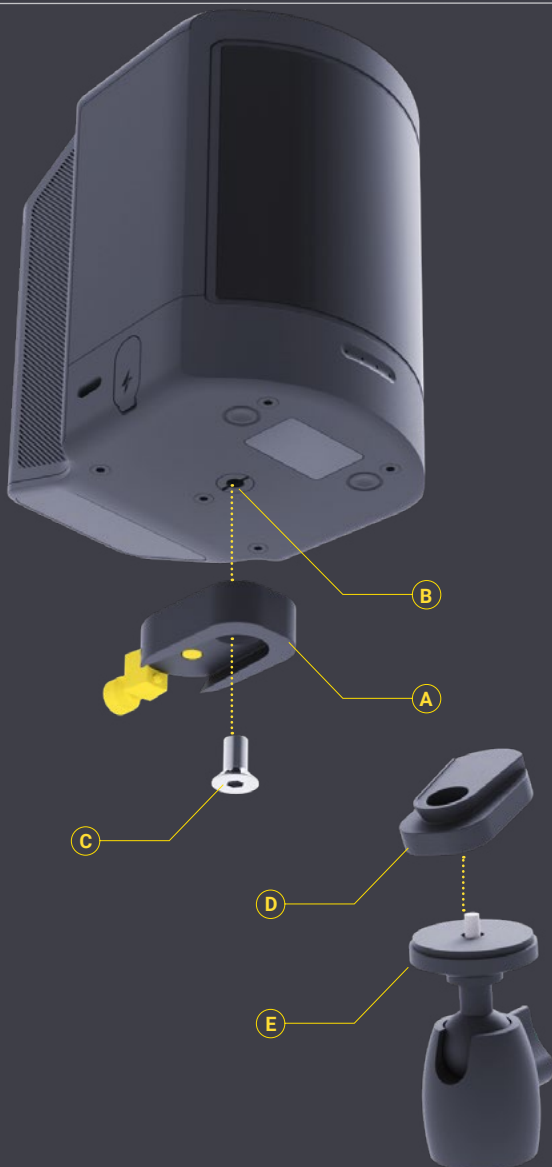
