# 1 Information For Users

Before using this product, please read the instructions in this manual thoroughly. Thank you for your understanding and cooperation, wish you a happy life!

## Attention

- It is recommended to soak the filter in water and wash it well before use, please do not use hot water to scald it.
- For clean pet water, the filter should be replaced once in 30 days by default, the water reservoir should be cleaned once in 3 days, and the water pump and sponge should be checked and cleaned regularly.
- Please cover or store the data cable well to prevent pets from tearing the cable and causing dangerous situations such as electric shock.
- The amount of water is recommended not to exceed the MAX line.
- Please do not disassemble or modify the machine by yourself, otherwise it will not be covered by the warranty policy.

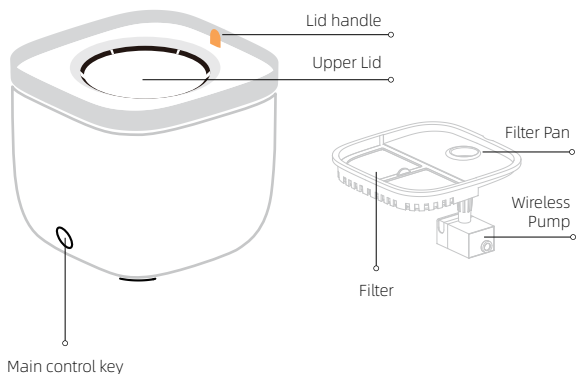

## 3 Product Information



### Manual Button:

Main Light On/Off: Click the Manual Button

Reset filter: Press and hold the button for 5 seconds until a “beep” sound

Device Untethering: Press and hold the button for 10 seconds until two “beep” sounds

### Indicator light:

- ❶ White flashing: network unpaired
- ❷ White on: device functioning
- ❸ Yellow on: filter expiration
- ❹ Red on: lack of water
