


The Transmitter was operated in the normal operating mode. The TX frequency was fixed which was for the purpose of the measurements.


Radiated Emission Configure:







Test_Graph_LE1M_ANT1_2480_1Mbps_Peak Power




Test_Graph_LE2M_ANT1_2402_2Mbps_Peak Power

Test_Graph_LE2M_ANT1_2402_2Mbps_OBW







Test Graphs of DTS Bandwidth



Test Graphs of Conducted Output Power Spectral Density







10. Conducted Band Edge and Out-of-Band Emissions


10.1 Provisions Applicable

The limit for out-of-band spurious emissions at the band edge is 20dB below the fundamental emission level, as determined from the in-band power measurement of the DTS channel performed in a 100kHz bandwidth per the PSD procedure.

10.2 Measurement Procedure

- Reference level measurement
 1. Set instrument center frequency to DTS channel center frequency
 2. Set the span to ≥ 1.5 times the DTS bandwidth
 3. Set the RBW = 100 kHz
 4. Set the VBW $\geq 3 \times$ RBW
 5. Detector = peak
 6. Sweep time = auto couple
 7. Trace mode = max hold
 8. Allow trace to fully stabilize
 9. Input compensation coefficient (dB) = Cable Loss (dB) + Attenuator attenuation value (dB)
- Emission level measurement
 1. Set the center frequency and span to encompass frequency range to be measured
 2. RBW = 100kHz
 3. VBW = 300kHz
 4. Detector = Peak
 5. Trace mode = max hold
 6. Sweep time = auto couple
 7. The trace was allowed to stabilize
 8. Input compensation coefficient (dB) = Cable Loss (dB) + Attenuator attenuation value (dB)

Test_Graph_LE1M_ANT1_2402_1Mbps_Higher Band Emissions







Test_Graph_LE1M_ANT1_2480_1Mbps_Higher Band Emissions




