Installation and Operation:

Plug in the charging stand with USB-C to USB-A cable (Adapter sold separately). Place the device on the charging stand with lenses facing up. Wait 6 seconds for the pulsing light to turn orange. If it blinks red, re-adjust the position of the device. Put the device on and download the Alexa app to complete the setup.

Download the Companion App

Download the Alexa App to your iOS or Android tablet or phone. The Alexa companion App registers the device to an access point for internet access for digital media streaming for audio sources.
