#### 4.4 TEST METHODOLOGY

All measurements contained in this report were conducted with ANSI C63.10-2013, American National Standard of Procedures for Compliance Testing of Unlicensed Wireless Devices.

The radiated testing was performed at an antenna-to-EUT distance of 3 meters. All radiated and conducted emissions measurement was performed at Dongguan Yaxu (AiT) Technology Limit.

### **EUT Configuration**

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

#### **EUT Exercise**

The EUT was operated in the normal operating mode for Hopping Numbers and Dwell Time test and a continuous transmits mode for other tests.

According to its specifications, the EUT must comply with the requirements of the Section 15.203, 15.205, 15.207, 15.209, 15.247 under the FCC Rules Part 15 Subpart C, ANSI C63.10-2013.

#### **General Test Procedures**

#### Conducted Emissions

The EUT is placed on the turntable, which is 0.8 m above ground plane. According to the requirements in Section 6.2.1 of ANSI C63.10-2013 Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using Quasi-peak and average detector modes.

#### Radiated Emissions

The EUT is placed on a turn table, which is 0.8 m above ground plane. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the maximum emissions, exploratory radiated emission measurements were made according to the requirements in Section 6.3 of ANSI C63.10-2013.



### 4.5 Description of Test Modes

The EUT has been tested under operating condition.

AC main conducted emission pre-test voltage at both AC 120V/60Hz and AC 240V/50Hz, recorded worst case;

AC main conducted emission pre-test at charge from power adapter modes, recorded worst case;

Worst-case mode and channel used for 150 KHz-30 MHz power line conducted emissions was the mode and channel with the highest output power that was determined to be TX (1Mbps).

Worst-case mode and channel used for 9 KHz-1000 MHz radiated emissions was the mode and channel with the highest output power, that was determined to be TX(3Mbps-Low Channel).

This test was performed with EUT in X, Y, Z position and the worst case was found when EUT in X position.

In section 15.31(m), regards to the operating frequency range over 10 MHz, the Lowest frequency, the middle frequency, and the highest frequency of channel were selected to perform the test, and the selected channel see below:

## 6 Test results and Measurement Data

### 6.1 Antenna requirement

#### 6.1.1 Standard requirement:

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this Section. The manufacturer may design the unit so that a broken antenna can be re-placed by the user, but the use of a standard antenna jack or electrical connector is prohibited. This requirement does not apply to carrier current devices or to devices operated under the provisions of Sections 15.211, 15.213, 15.217, 15.219, or 15.221. Further, this requirement does not apply to intentional radiators that must be professionally installed, such as perimeter protection systems and some field disturbance sensors, or to other intentional radiators which, in accordance with Section 15.31(d), must be measured at the installation site. However, the installer shall be responsible for ensuring that the proper antenna is employed so that the limits in this Part are not exceeded. And according to §15.247(4)(1), system operating in the 2400-2483.5MHz bands that are used exclusively for fixed, point-to-point operations may employ transmitting antennas with directional gain greater than 6dBi provided the maximum peak output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6dBi.



- 2. Set the span=0MHz, RBW=8MHz, VBW=50MHz, Sweep time=20.27ms;
- 3. Detector = peak;
- 4. Trace mode = Single hold

### 6.3 Maximum Conducted Output Peak Power Measurement

### 6.3.1 Standard requirement:

According to §15.247(b): For systems using digital modulation in the 2400-2483.5 MHz and 5725-5850 MHz band, the limit for maximum peak conducted output power is 30dBm. The limited has to be reduced by the amount in dB that the gain of the antenna exceeds 6dBi. In case of point-to-point operation, the limit has to be reduced by 1dB for every 3dB that the directional gain of the antenna exceeds 6dBi.

Systems operating in the 5725-5850 MHz band that are used exclusively for fixed, point-to-point operations may employ transmitting antennas with directional gain greater than 6dBi without any corresponding reduction in transmitter peak output power.


The transmitter output (antenna port) was connected to the spectrum analyzer.

According to KDB558074 D01 DTS Measurement Guidance Section 9.1 Maximum peak conducted output power 9.1.1.

This procedure shall be used when the measurement instrument has available a resolution bandwidth that is greater than the DTS bandwidth.

- a) Set the RBW ≥ DTS bandwidth.
- b) Set VBW  $\geq$  3 × RBW. Set span  $\geq$  3 x RBW.
- c) Sweep time = auto couple.
- d) Detector = peak.
- e) Trace mode = max hold.
- f) Allow trace to fully stabilize.
- g) Use peak marker function to determine the peak amplitude level.



According to §15.247(e): For digitally modulated systems, the power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission.



#### 6.5.3 Test Procedures

- 1. Use this procedure when the maximum peak conducted output power in the fundamental emission is used to demonstrate compliance.
- 2. The power was monitored at the coupler port with a Spectrum Analyzer. The power level was set to the maximum level.
- 3. Set the RBW = 3 kHz.
- 4. Set the VBW ≥ 3\*RBW
- 5. Set the span to 1.5 times the DTS channel bandwidth.
- 6. Detector = peak.
- 7. Sweep time = auto couple.
- 8. Trace mode = max hold.
- 9. Allow trace to fully stabilize.
- 10. Use the peak marker function to determine the maximum power level.
- 11. If measured value exceeds limit, reduce RBW (no less than 3 kHz) and repeat.
- 12. The resulting peak PSD level must be 8 dBm.

According to §15.247 (d): In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement. Attenuation below the general limits specified in Section 15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in Section 15.205(a), must also comply with the radiated emission limits specified in Section 15.209(a) (see Section 15.205(c)).



### 6.7 Restrict-band Band-edge Measurements

### 6.7.1 Standard requirement:

According to §15.247(d)/§15.209/ §15.205 or RSS-247§5.5/RSS-Gen

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in §15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in §15.205(a), must also comply with the radiated emission limits specified in §15.209(a) (see §15.205(c)).

According to KDB 558074 D01 for Antenna-port conducted measurement. Antenna-port conducted measurements may also be used as an alternative to radiated measurements for demonstrating compliance in the restricted frequency bands. If conducted measurements are performed, then proper impedance matching must be ensured and an additional radiated test for cabinet/case spurious emissions is required.

- 1). Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.
- 2). Remove the antenna from the EUT and then connect to a low loss RF cable from the antenna port to an EMI test receiver, then turn on the EUT and make it operate in transmitting mode. Then set it to Low Channel and High Channel within its operating range, and make sure the instrument is operated in its linear range.
- 3). Set both RBW and VBW of spectrum analyzer to 100 kHz with a convenient frequency span including 100kHz bandwidth from band edge, for Radiated emissions restricted band RBW=1MHz, VBW=3MHz for peak detector and RBW=1MHz, VBW=1/B for AV detector.
- 4). Measure the highest amplitude appearing on spectral display and set it as a reference level. Plot the graph with marking the highest point and edge frequency.
- 5). Repeat above procedures until all measured frequencies were complete.
- 6). Measure the conducted output power (in dBm) using the detector specified by the appropriate regulatory agency (see 12.2.2, 12.2.3, and 12.2.4 for guidance regarding measurement procedures for determining quasi-peak, peak, and average conducted output power, respectively).
- 7). Add the maximum transmit antenna gain (in dBi) to the measured output power level to determine the EIRP level (see 12.2.5 for guidance on determining the applicable antenna gain)
- 8). Add the appropriate maximum ground reflection factor to the EIRP level (6 dB for frequencies ≤ 30 MHz, 4.7 dB for frequencies between 30 MHz and 1000 MHz, inclusive and 0 dB for frequencies > 1000 MHz).
- 9). For devices with multiple antenna-ports, measure the power of each individual chain and sum the



EIRP of all chains in linear terms (e.g., Watts, mW).

10). Convert the resultant EIRP level to an equivalent electric field strength using the following relationship:

$$E = EIRP - 20log D + 104.77 = EIRP + 95.23$$



EIRP = equivalent isotropic radiated power in dBm

D = specified measurement distance in meters.

- 11). Since the out-of-band characteristics of the EUT transmit antenna will often be unknown, the use of a conservative antenna gain value is necessary. Thus, when determining the EIRP based on the measured conducted power, the upper bound on antenna gain for a device with a single RF output shall be selected as the maximum in-band gain of the antenna across all operating bands, or 2 dBi, whichever is greater. However, for devices that operate in multiple frequency bands while using the same transmit antenna, the highest gain of the antenna within the operating band nearest in frequency to the restricted band emission being measured may be used in lieu of the overall highest gain when the emission is at a frequency that is within 20 percent of the nearest band edge frequency, but in no case shall a value less than 2 dBi be used.
- 12). Compare the resultant electric field strength level to the applicable regulatory limit.
- 13). Perform radiated spurious emission test duress until all measured frequencies were complete.



According to §15.207 (a): For an intentional radiator which is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed 250 microvolts (The limit decreases linearly with the logarithm of the frequency in the range 0.15 MHz to 0.50 MHz). 


