

Choosing the right adapter



Using multiple ports on the same adapter can slow down charging.
* A QC3.0 adapter in the package content not included.

- Only for iPhone 12 or later Series (MagSafe Case Friendly)
- Please use case with official MagSafe or third-party case, not applicable to other phone cases.
