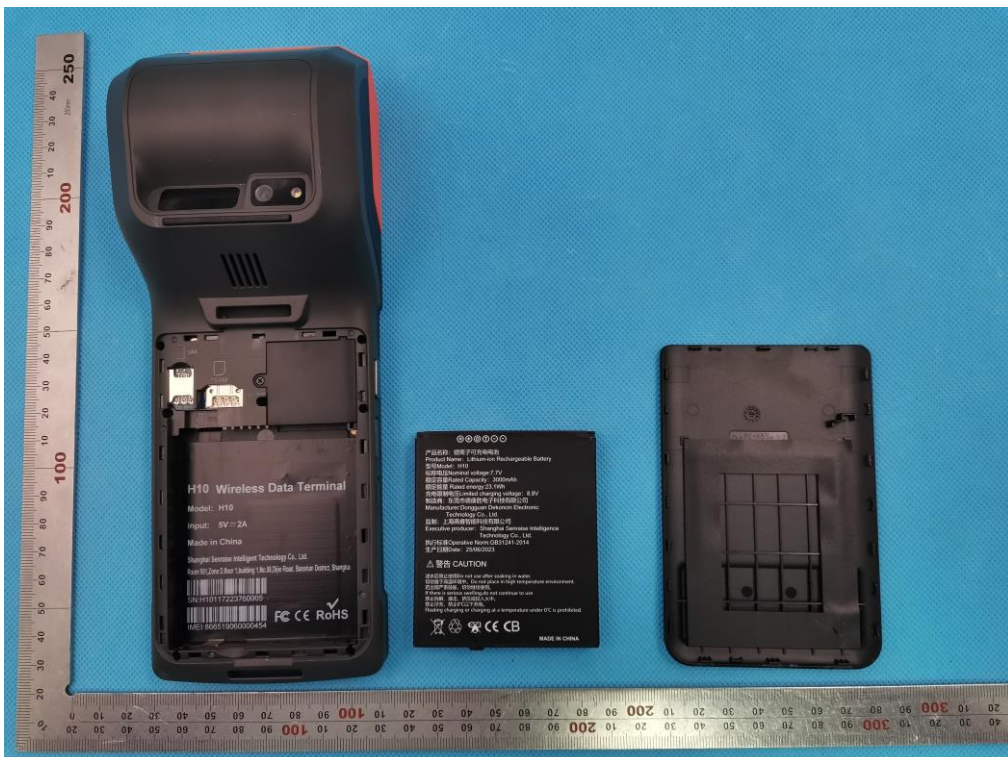

OPEN VIEW OF EUT (FIGURE 2)

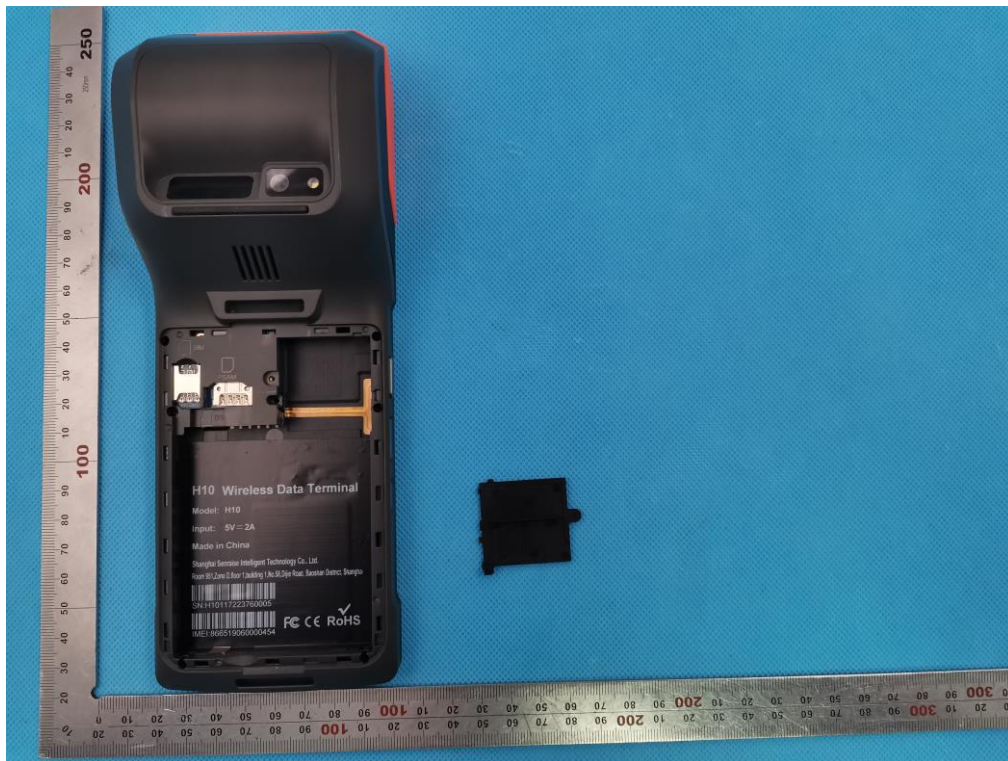

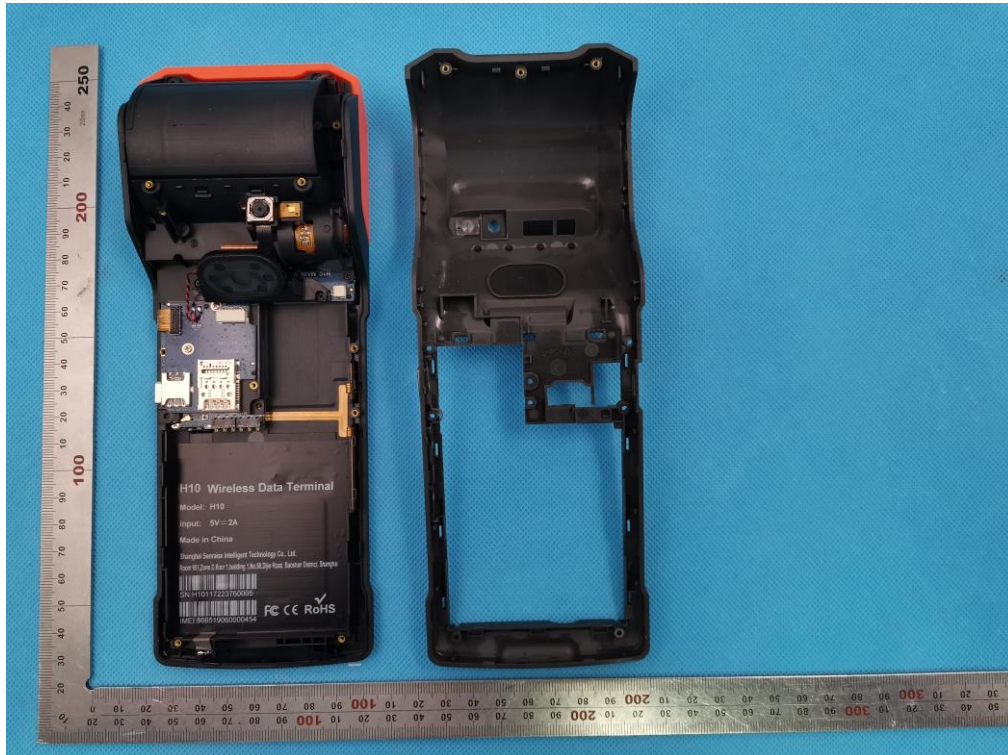

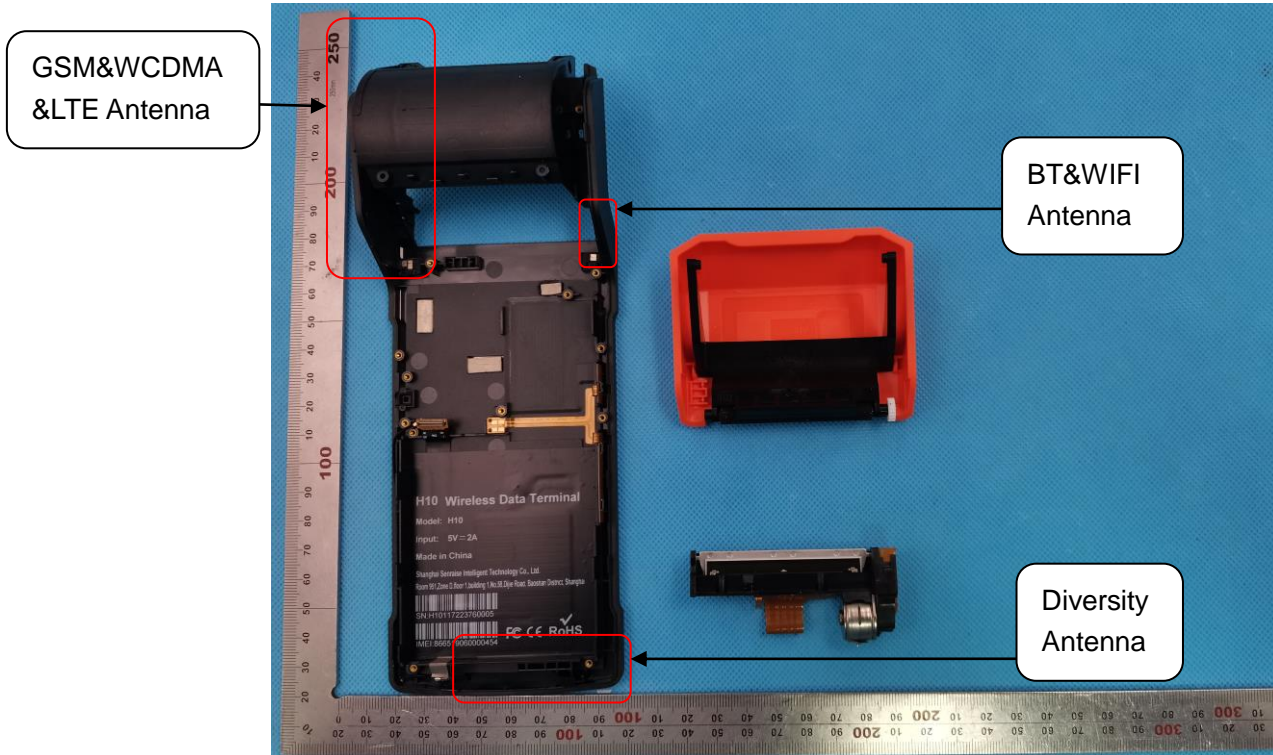

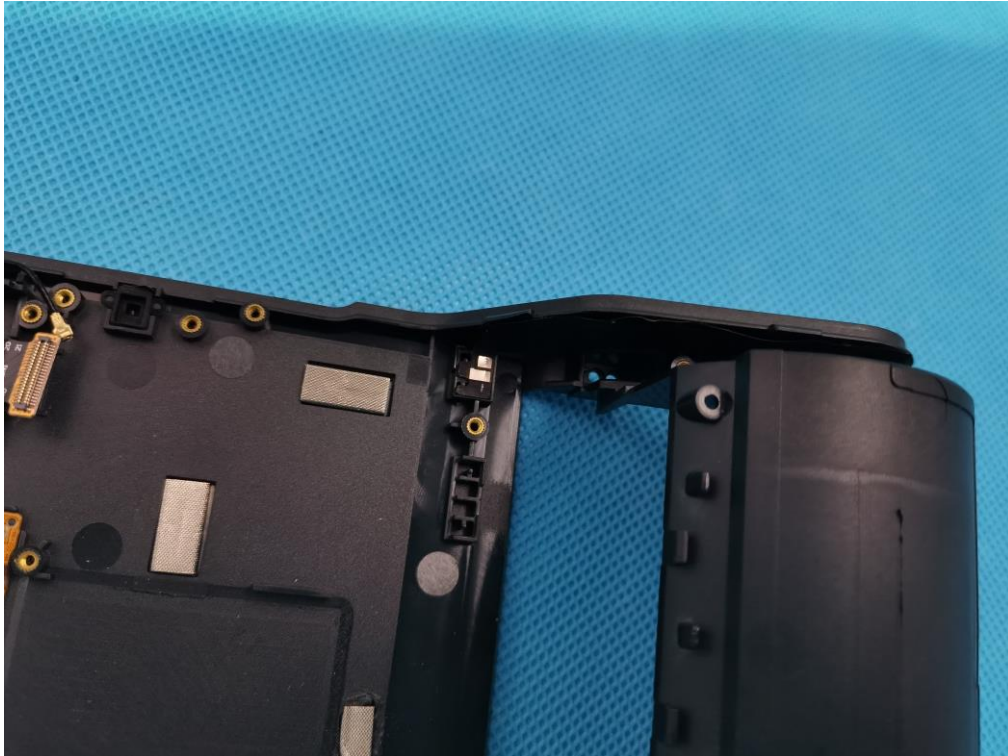

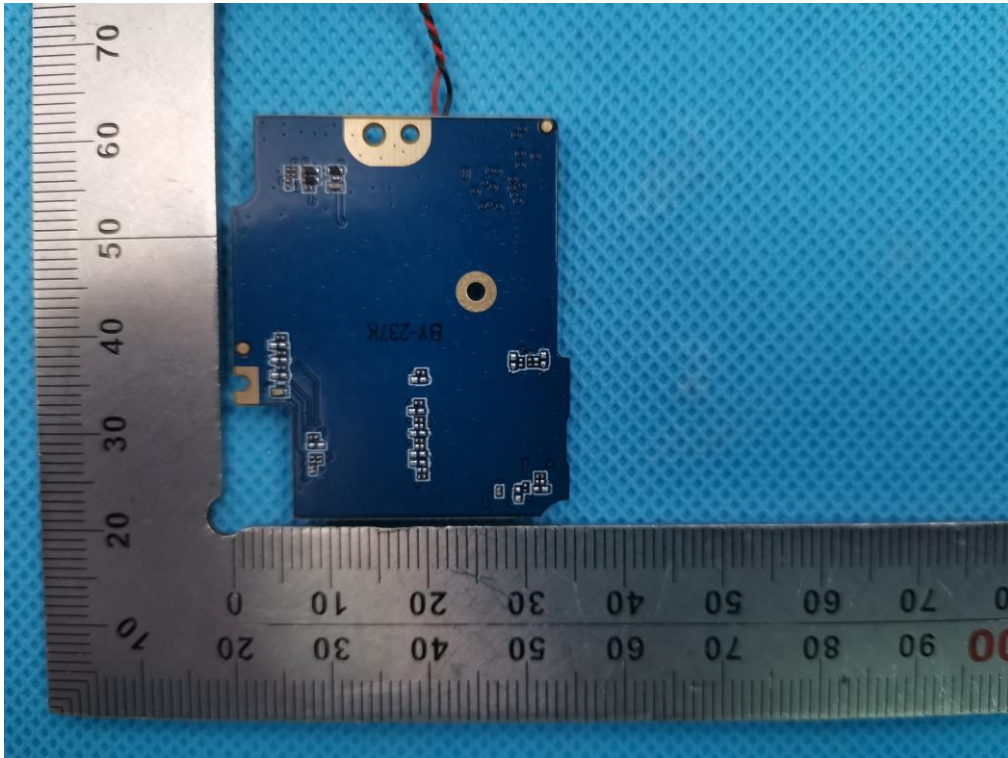

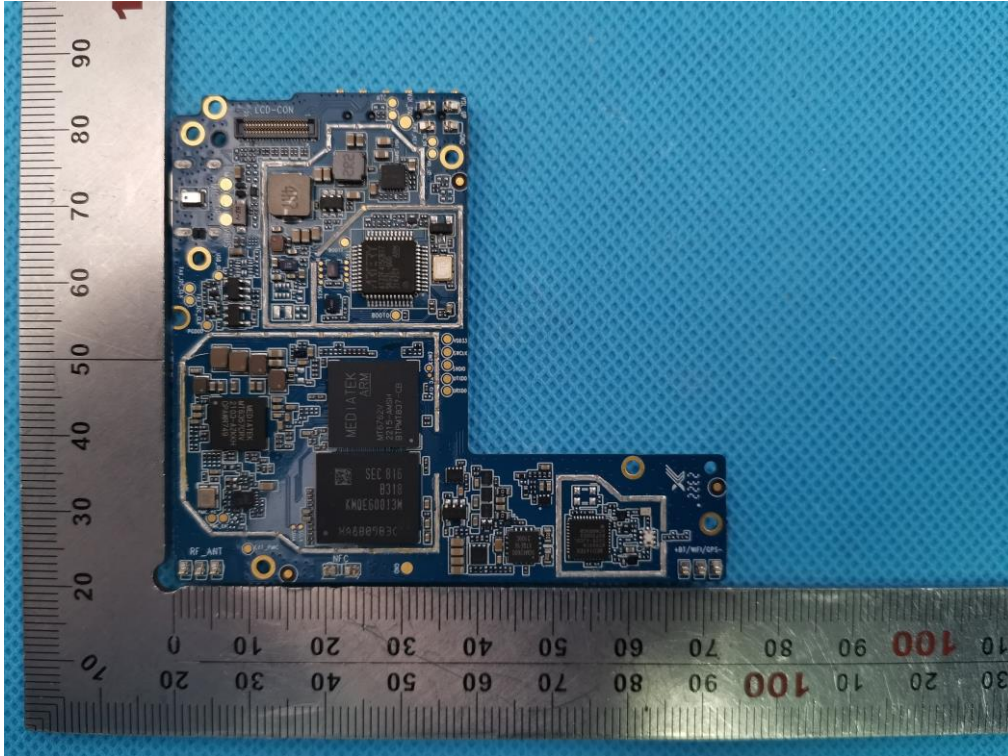

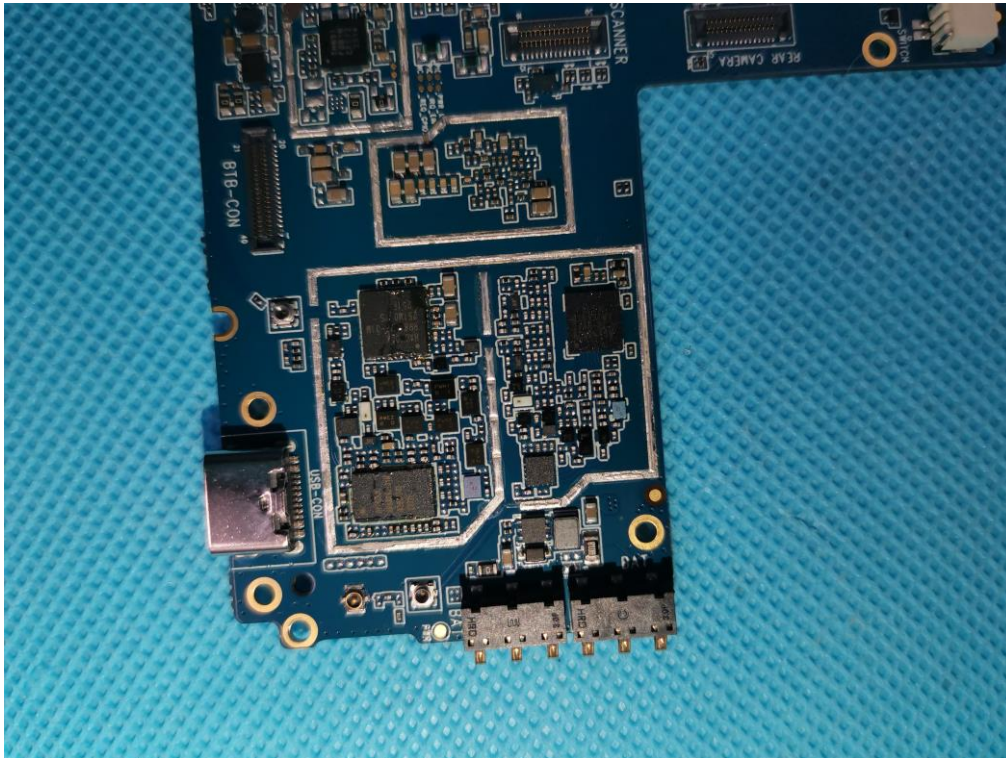

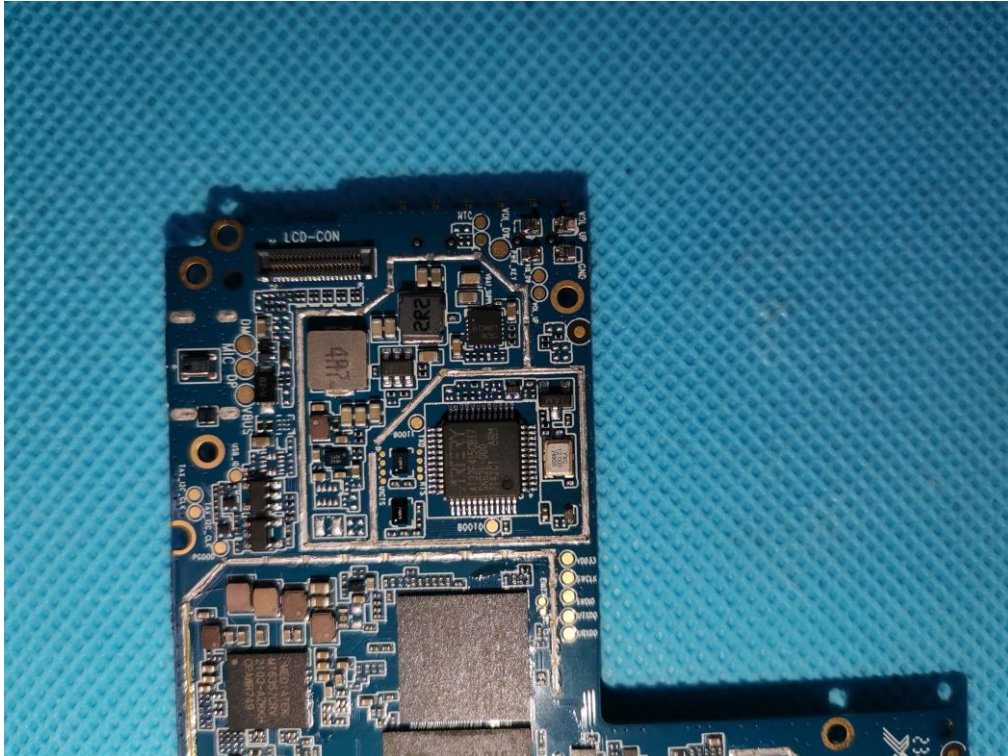


INTERNAL VIEW OF EUT (FIGURE 7)

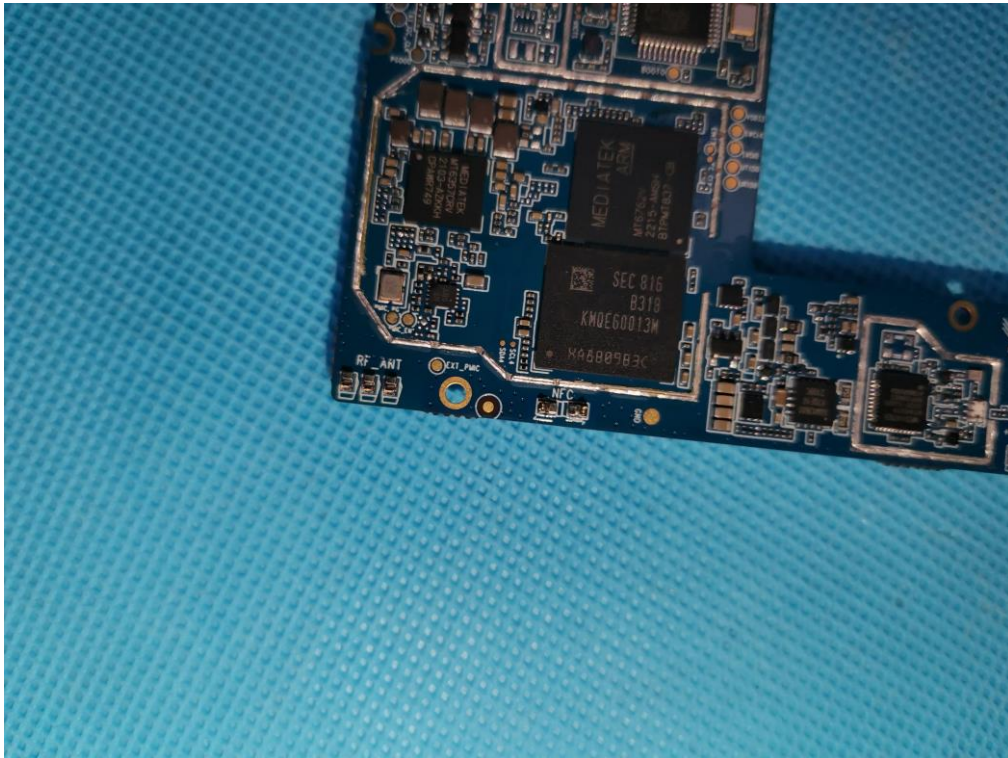

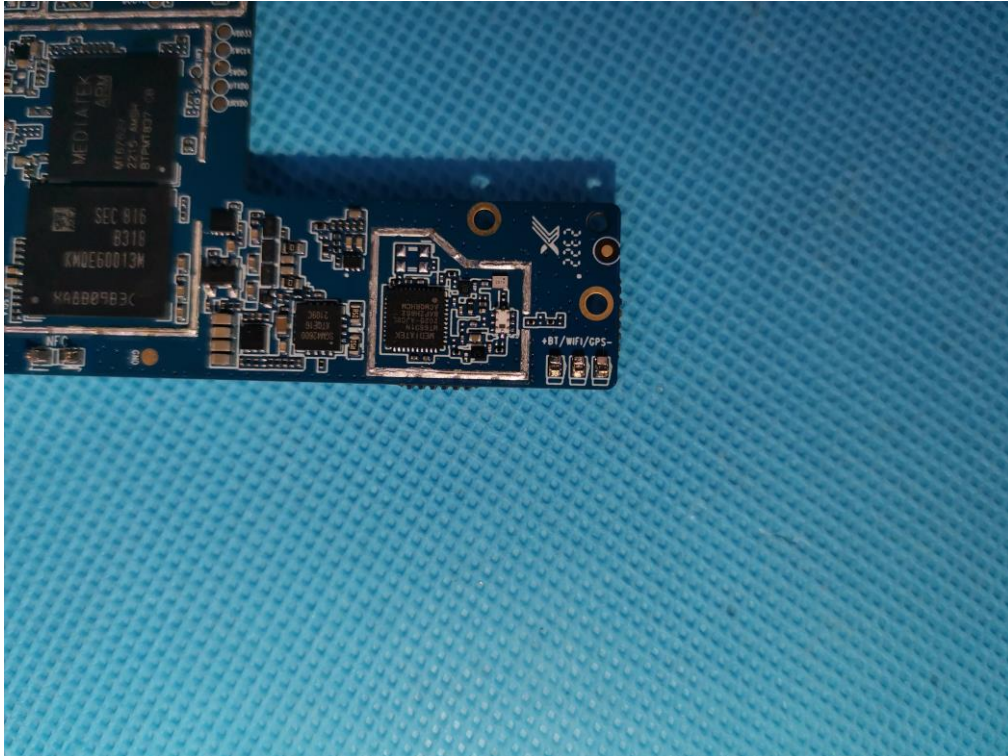


INTERNAL VIEW OF EUT (FIGURE 9)
