2DH5_Ant1_Low_Hop



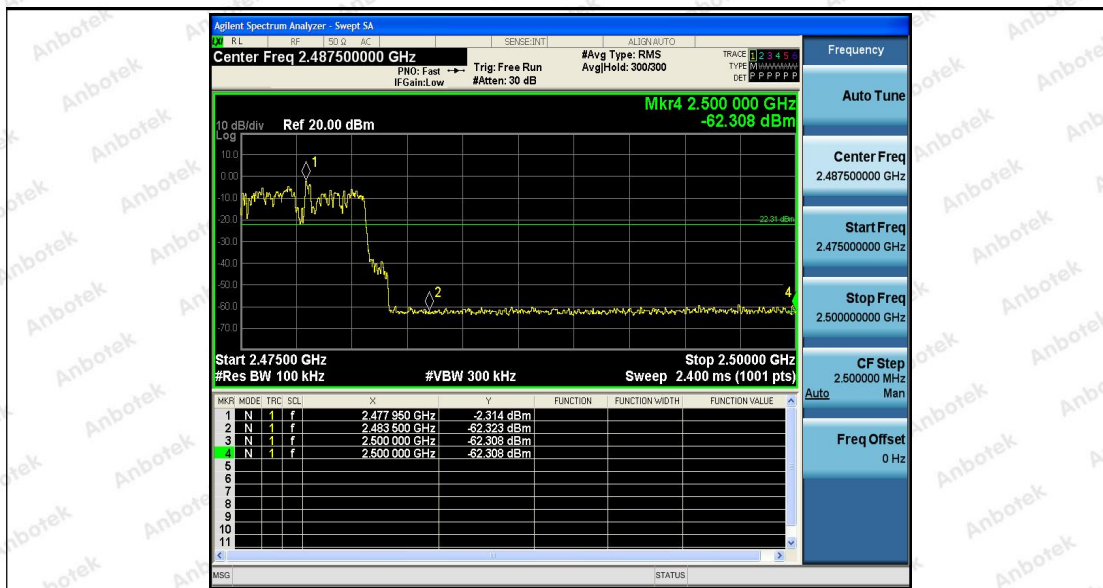

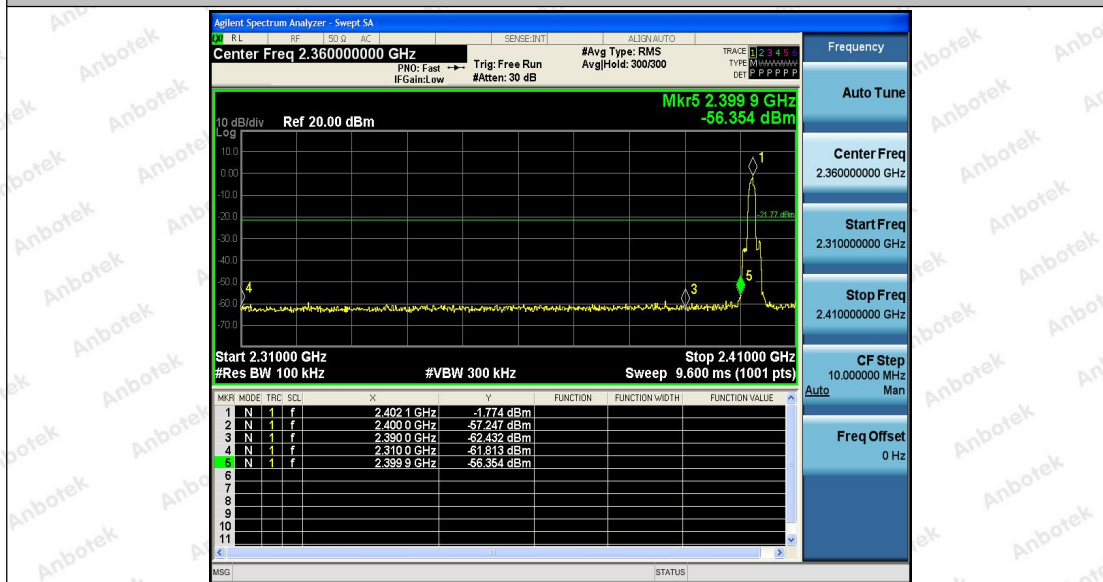

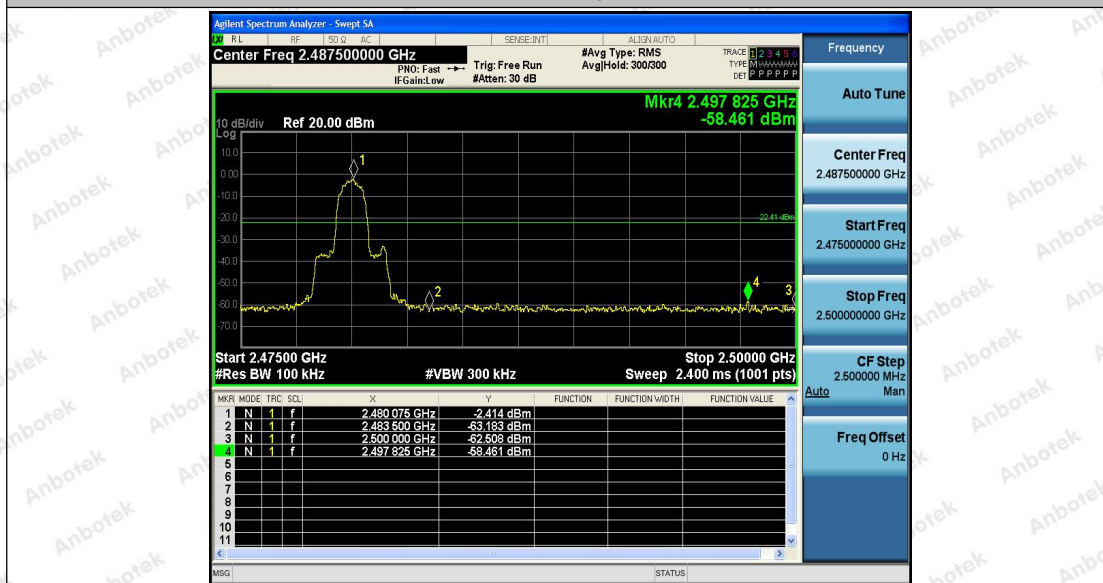

3DH5_Ant1_High_2480

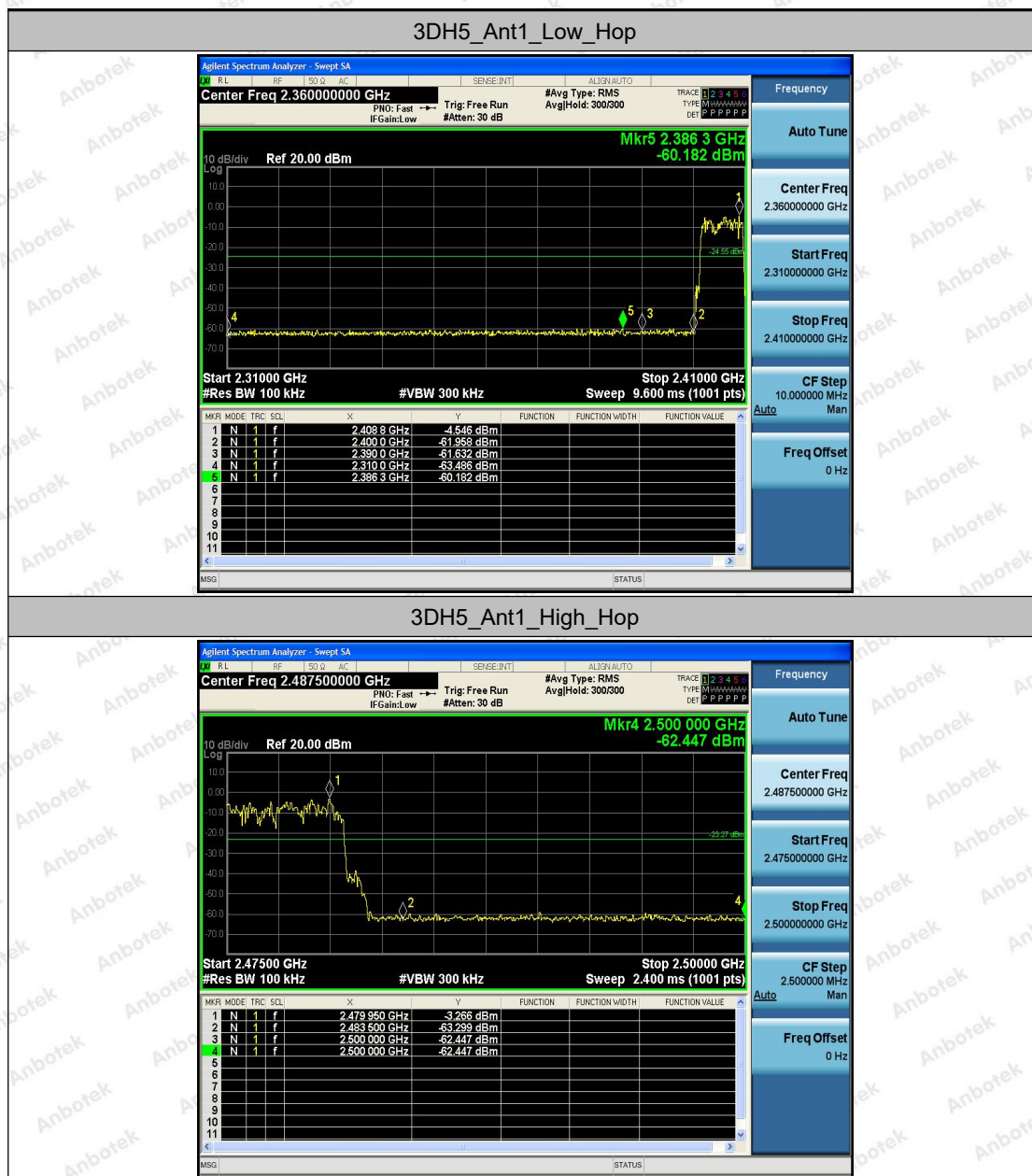
