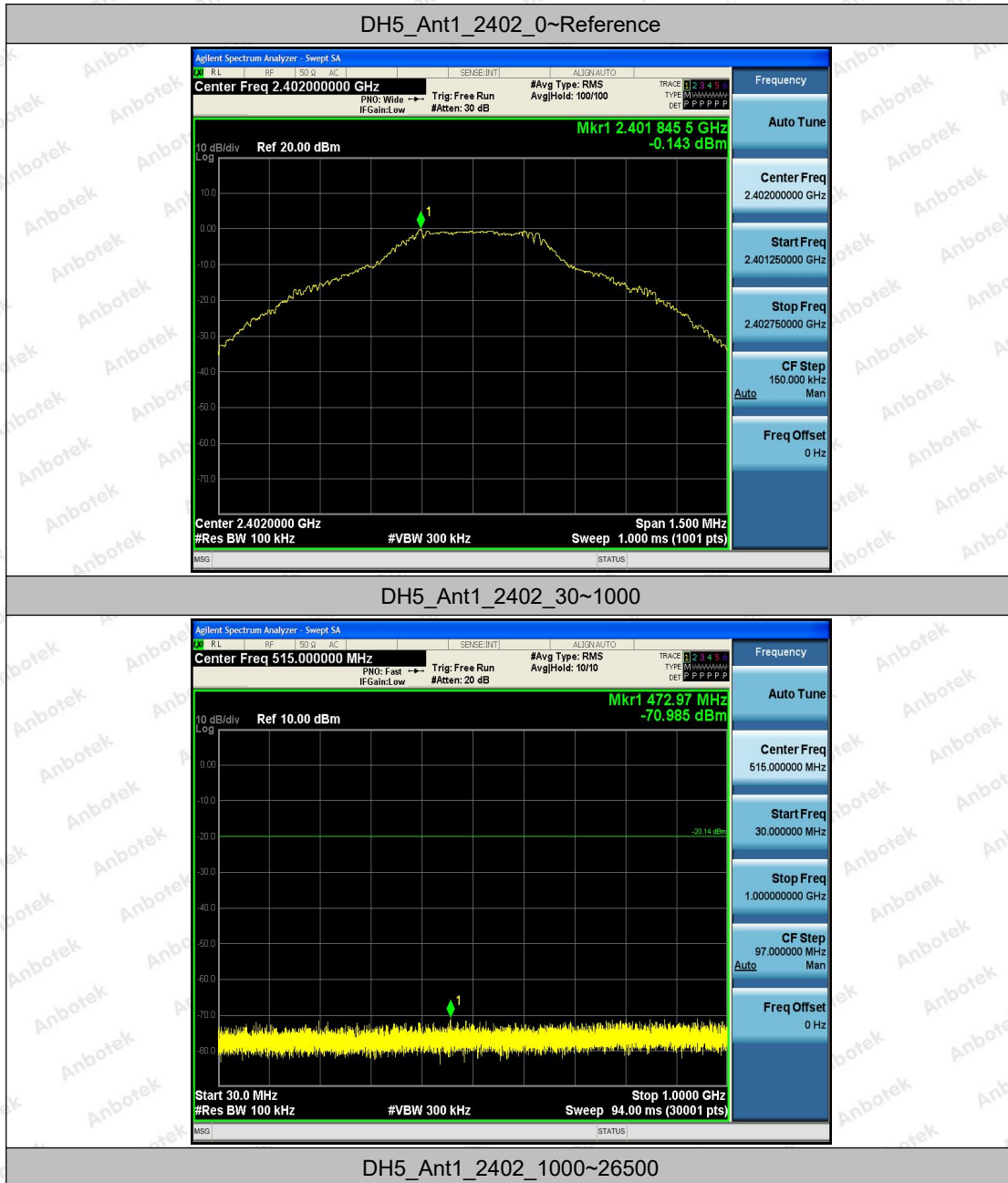


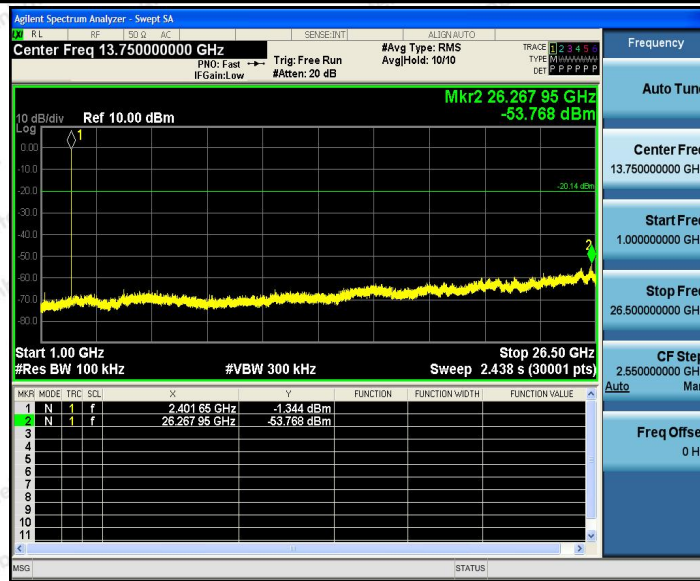

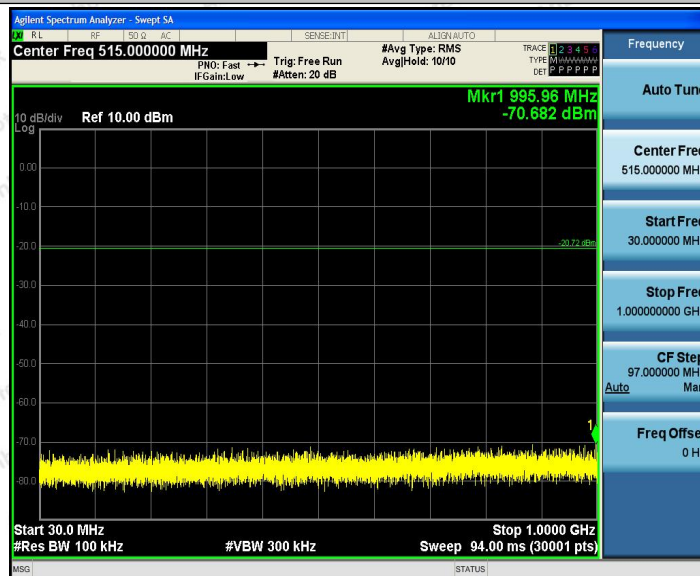




DH5\_Ant1\_2441\_0~Reference



DH5\_Ant1\_2441\_30~1000

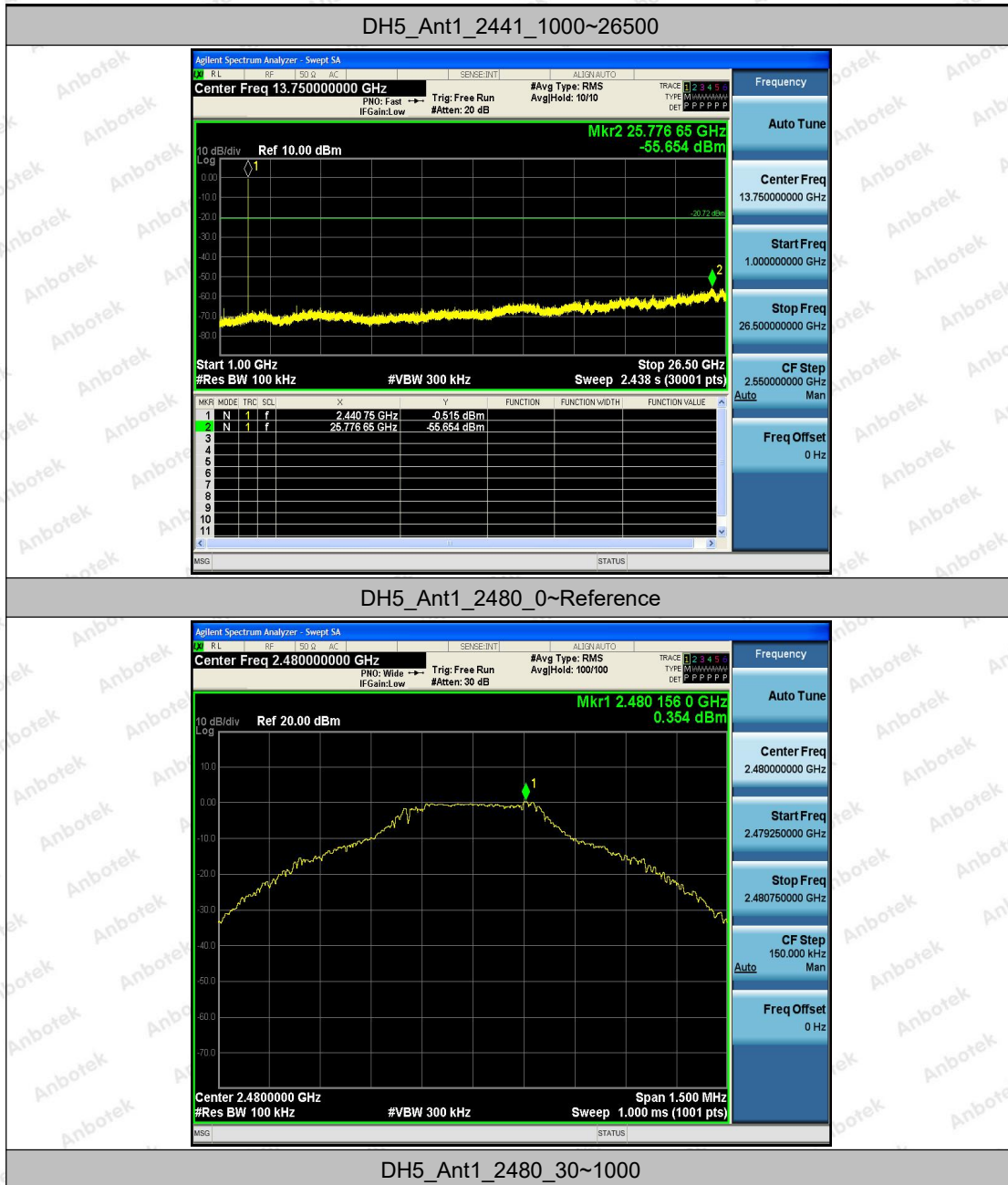

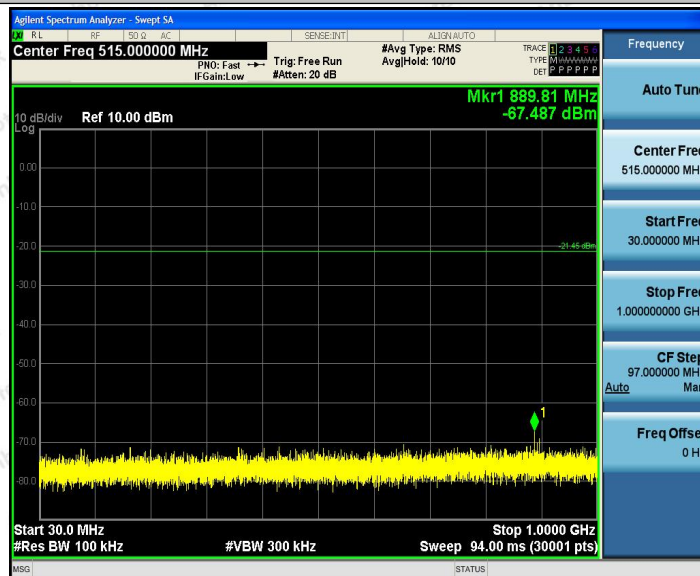




3DH5\_Ant1\_2402\_0~Reference



3DH5\_Ant1\_2402\_30~1000

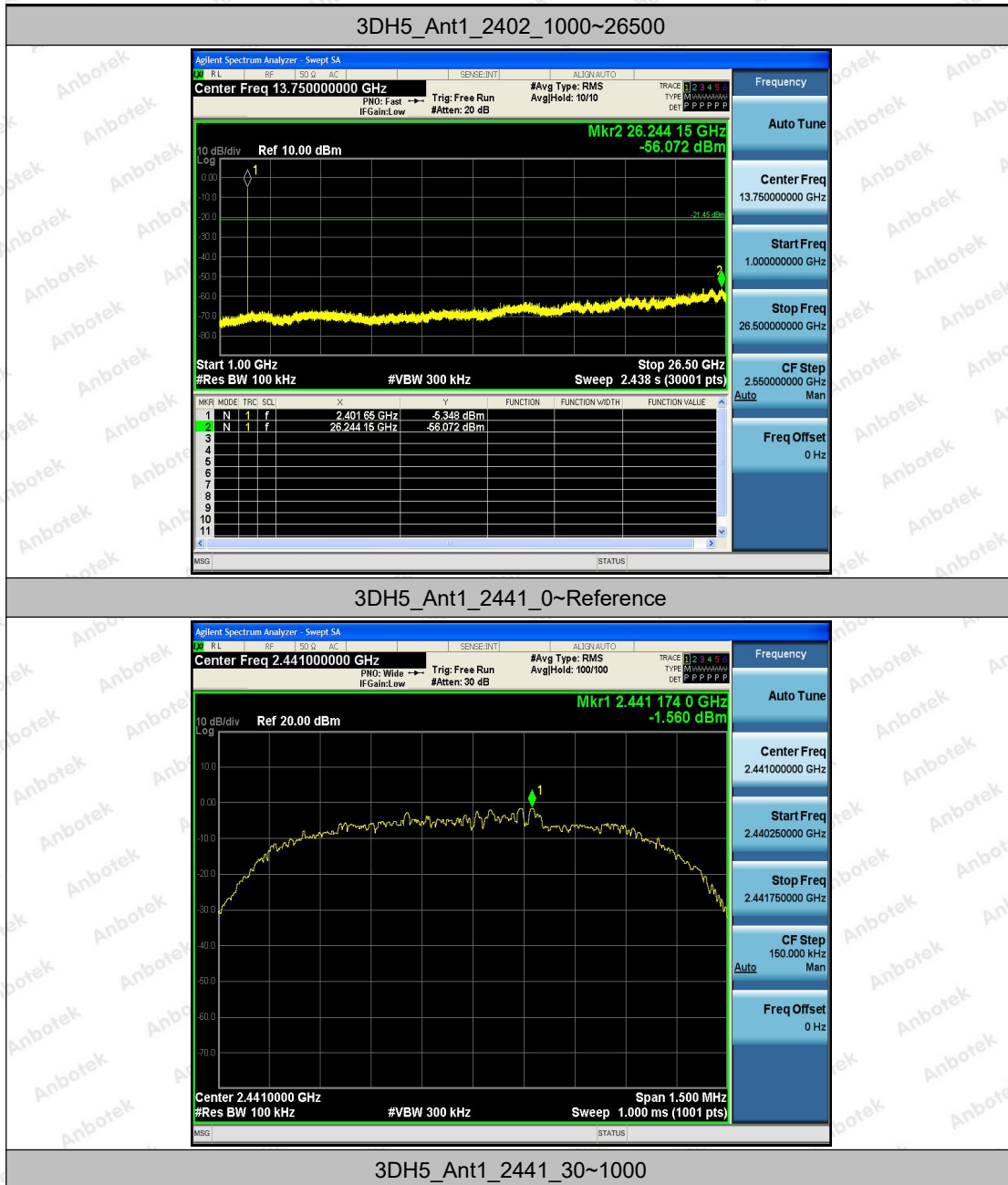

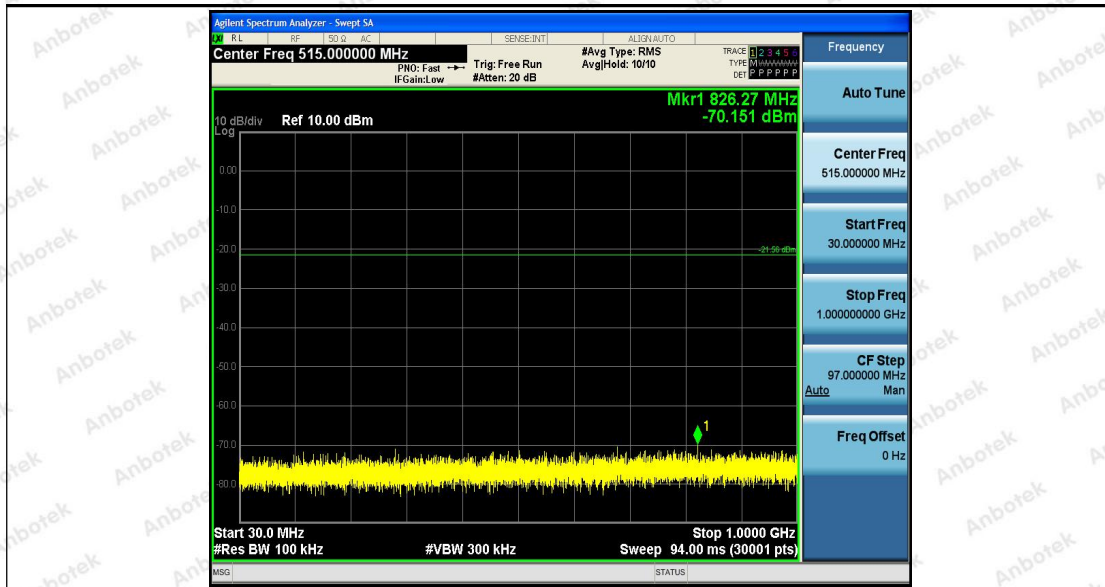

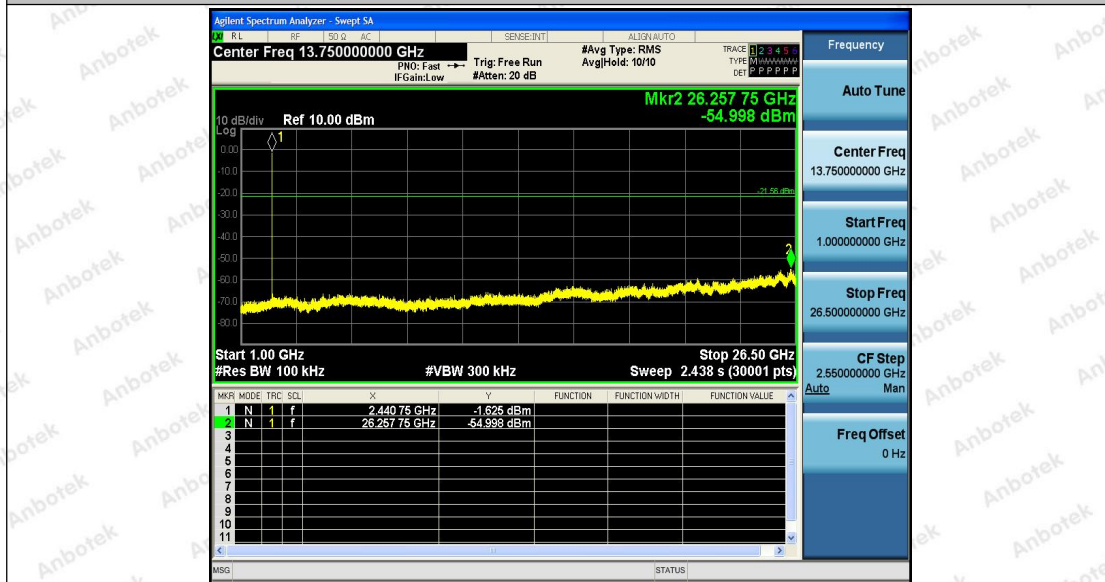

3DH5\_Ant1\_2441\_1000~26500



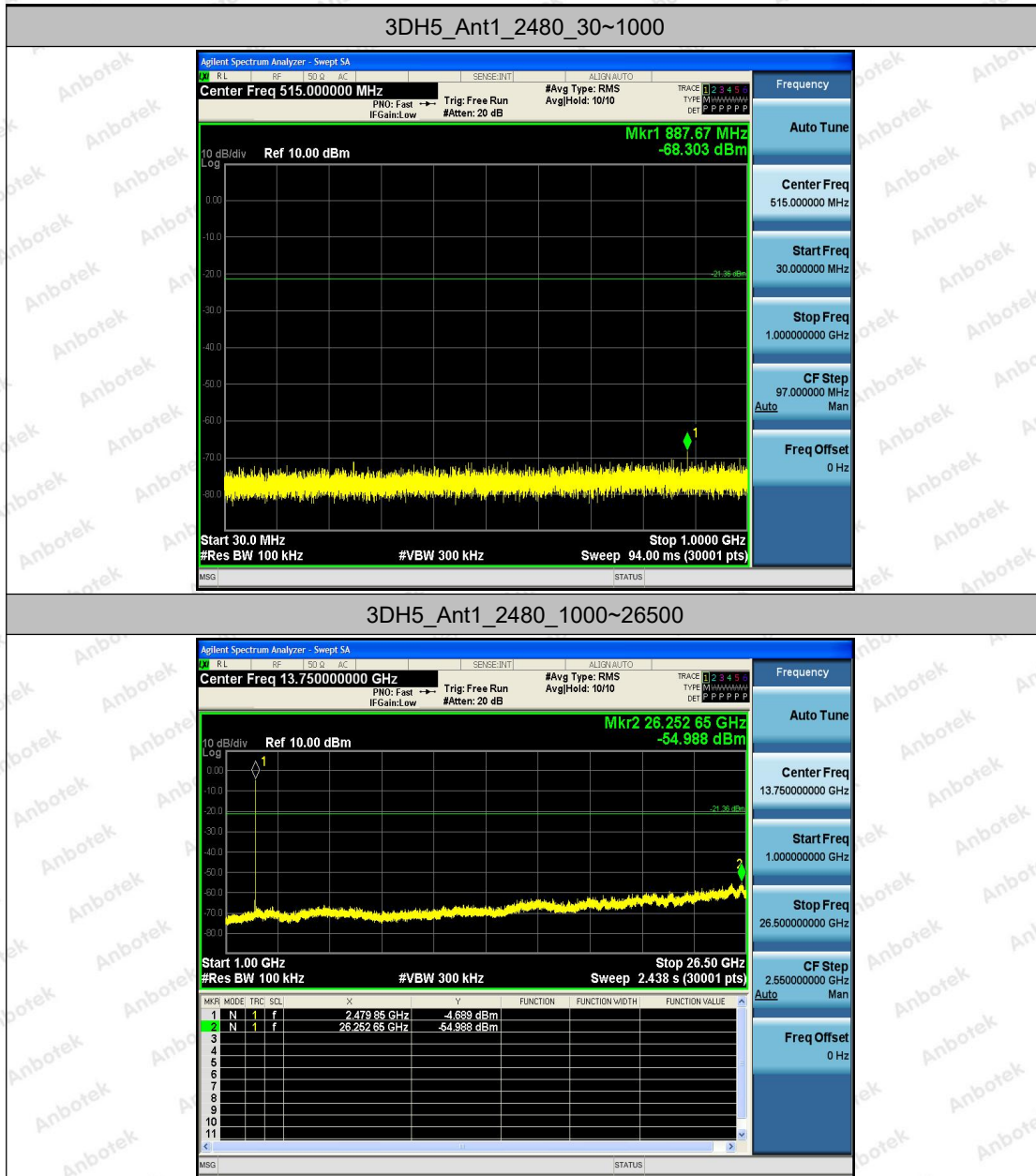

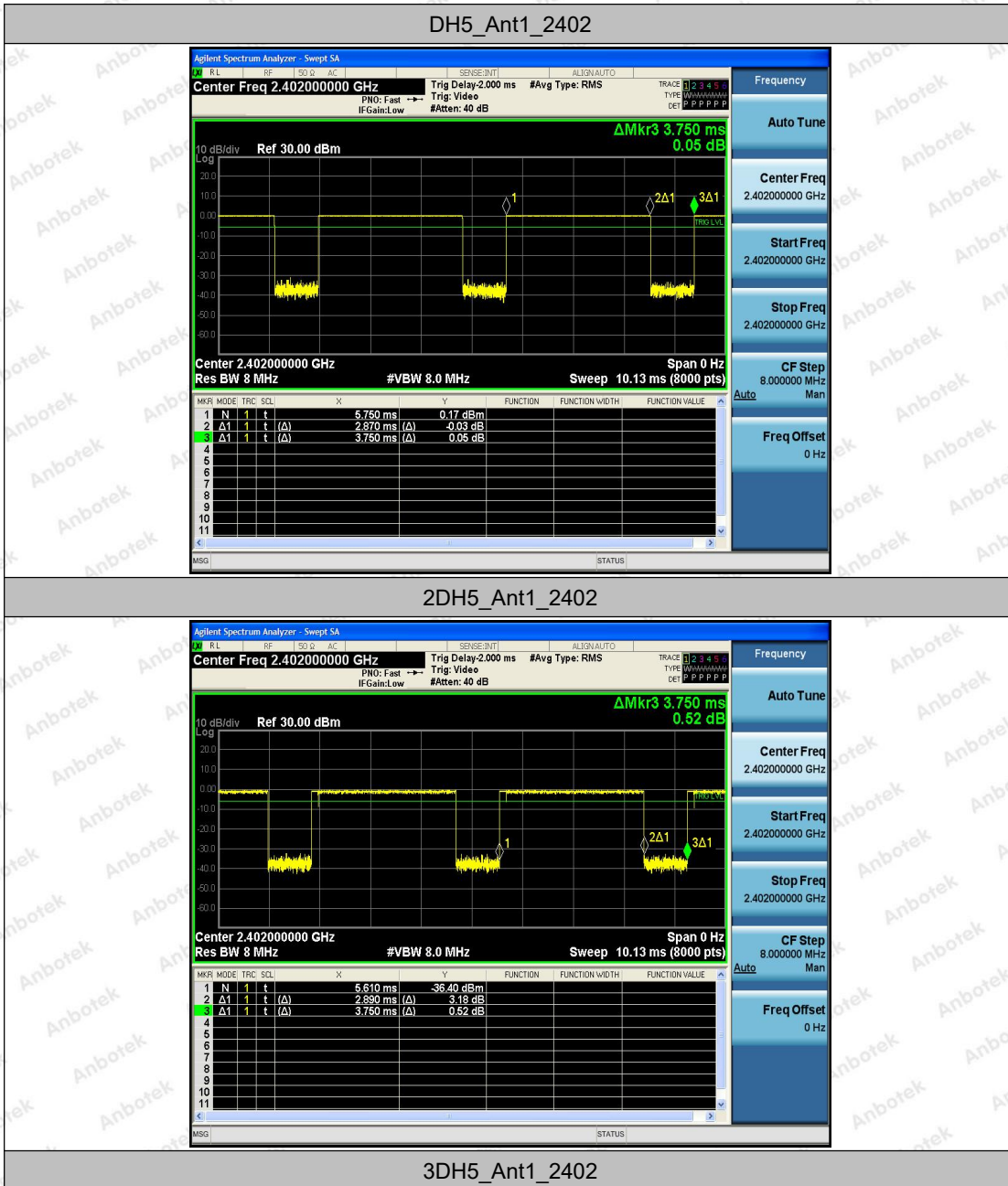

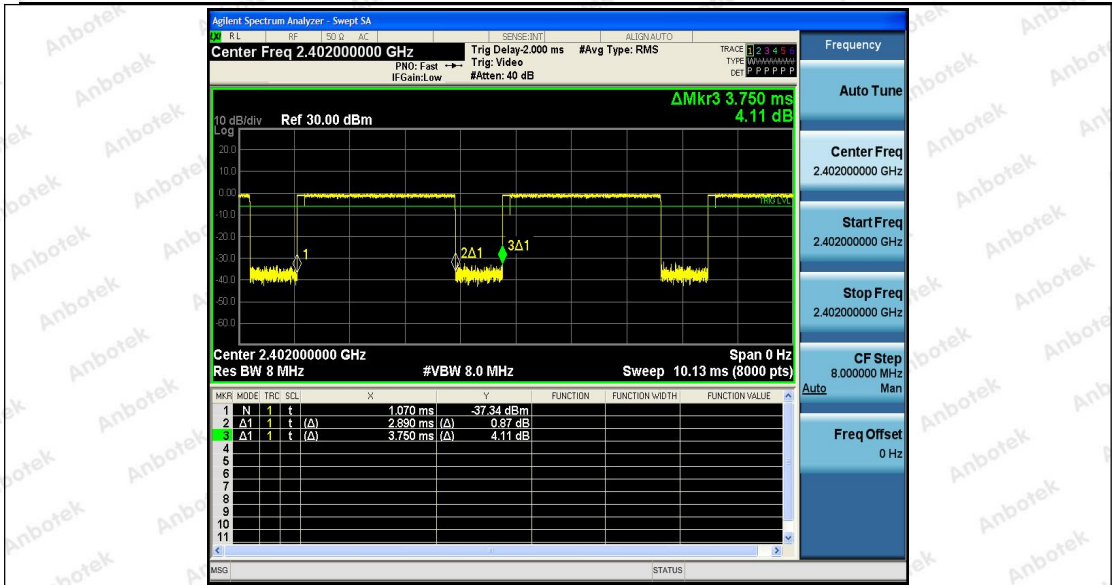
