**Band4-20MHz-QPSK-20175-100RB#0**

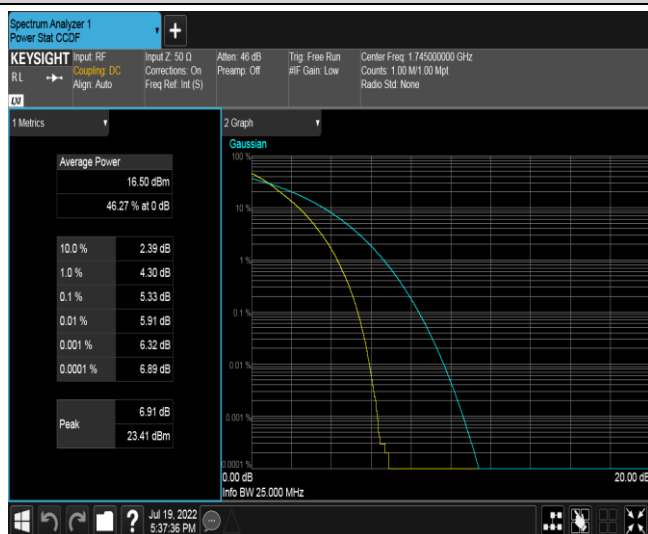

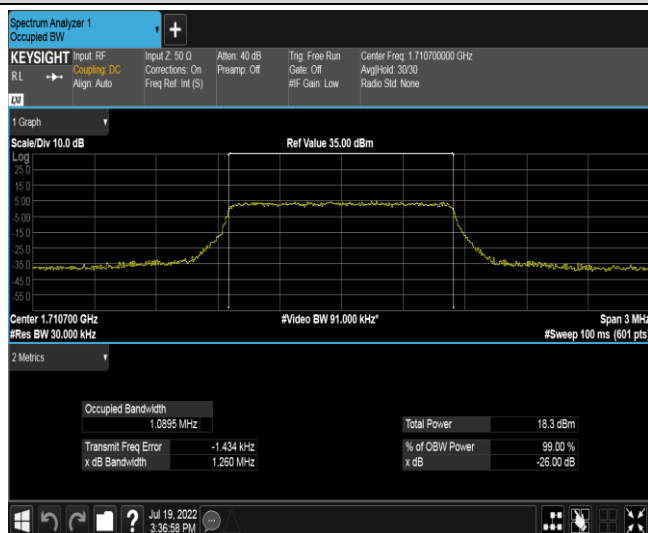
