The antenna is a PCB antenna which permanently attached, and the best case gain of the antenna is 1.89dBi. It complies with the standard requirement.



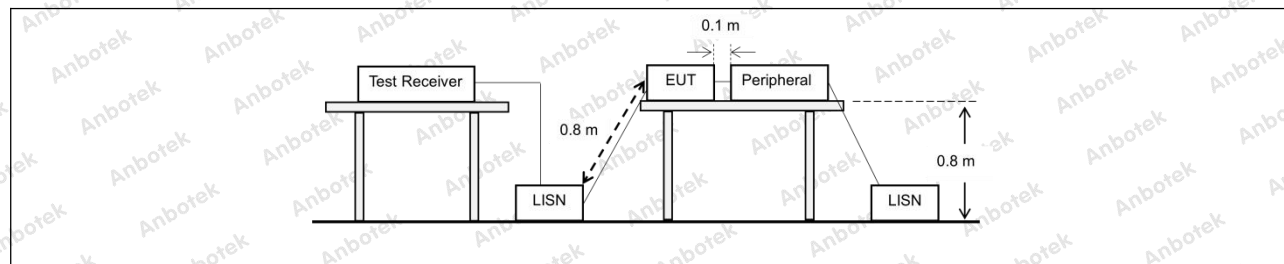
