The EUT is a Bluetooth Auto Switch Panel in the 2402 ~ 2480MHz frequency band.

MPE calculation method

Calculation Method of RF Safety Distance:

$$S = \frac{PG}{4\pi r^2}$$

S: power density mW/ cm²;

P: power input to the antenna in mW;

g: numeric gain of antenna;

r: distance to centre of radiation in cm

Unit dbuv/m@3m to mW calculation method

$$E = EIRP - 20\log(d) + 104.8$$

E: is the electric field strength in dBuv/m;

EIRP: is the equivalent isotropically radiated power in dBm;

d: is the specified measurement distance in m

For BLE mode

Field strength = 96.39dBuV/m @3m

$$\text{EIRP} = E + 20\log(d) - 104.8 = 96.39 + 20\log(3) - 104.8 = 1.132 \text{ dBm} = 1.298 \text{ mW}$$

Note1: the antenna gain is 3.19dBi for 2.4GWIFI and 3.53dBi for 5GWIFI;

Note2: Calculated distance is 20cm, which is declared by the manufacture.
