### Talk to fellow spies in secret!


1. Turn on each walkie talkie by pressing and holding POWER button for 2 seconds. The red indicator LED will be turned on. The walkie talkie is now ready to play with!
2. To speak to the other agent, push and hold down the PUSH TO TALK button. Release the button when you are not talking

**Hint:** Press the CALL button to alert the other agent with a "beep".

**Tip:** When finished playing with the SpyX walkie talkies, please press and hold power button for 2 seconds to turn off.



### ATTENTION ADULTS—TO INSTALL AND REPLACE BATTERIES

Each walkie talkie requires three (3) 1.5V AAA (LR03) batteries, not included.

- Use a small phillips head screwdriver to loosen the screw and remove the battery cover (Fig. 2).
- Remove all old batteries.
- Place new batteries in compartments as shown (Fig. 2).
- Replace the battery cover and tighten screw.

### SAFETY INFORMATION

Your wireless hand-held portable transceiver contains a low power transmitter. When the PTT button is pushed (or the VOX mode is enable) it sends out radio frequency (RF) signals. The device is authorized to operate at a duty factor not to exceeds 50%. In August 1996, the Federal Communications Commissions (FCC) adopted RF exposure guidelines with safety levels for hand-held wireless devices.

The device operates on GMRS (General Mobile Radio Service) frequencies, which require an FCC (Federal Communications Commission) license. You must be licensed prior to transmitting on all channels, which comprise of GMRS channels. Serious penalties could result for unlicensed use of GMRS channels, in violation of FCC rules, as stipulated in the Communications Act's Sections 501 and 502 (amended).

You will be issued a call sign by the FCC, which should be used for station identification when operating the radio on GMRS channels. You should also cooperate by engaging in permissible transmissions only, avoiding channel interference with other GMRS users, and being prudent with the length of their transmission time.

### BATTERY SAFETY INFORMATION

#### Important:

To maintain compliance with the FCC's RF exposure guidelines hold the transmitter at least 1 inch (2.5 centimeters) from your face and speak in a normal voice, with the antenna pointed up and away.

Do not use your transceiver with a damaged antenna. Unauthorized antennas, modifications or attachments could damage the transmitter and may violate FCC regulations.

This device is supplied by power source of (3) three 1.5V AAA (LR03) batteries. Please remove the batteries if the device is not used for a long time.


