Do not throw, avoid the damage caused by falling.

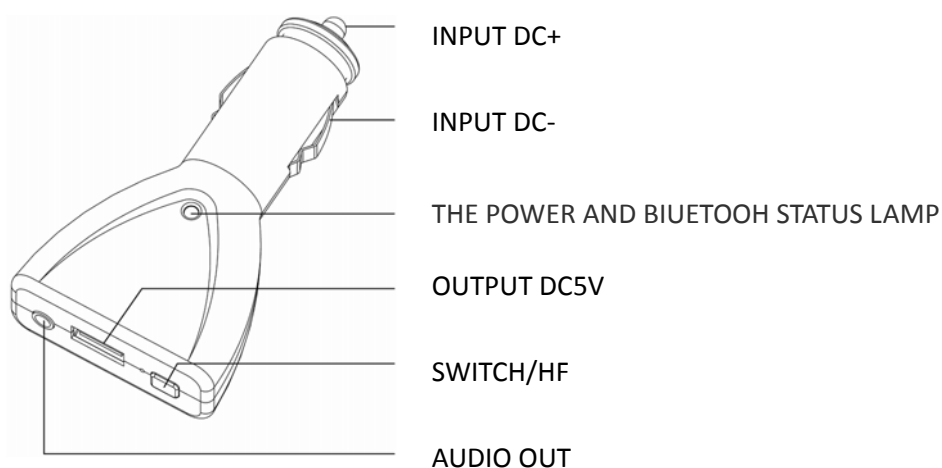
Please do not disassemble by repair and transform the product;

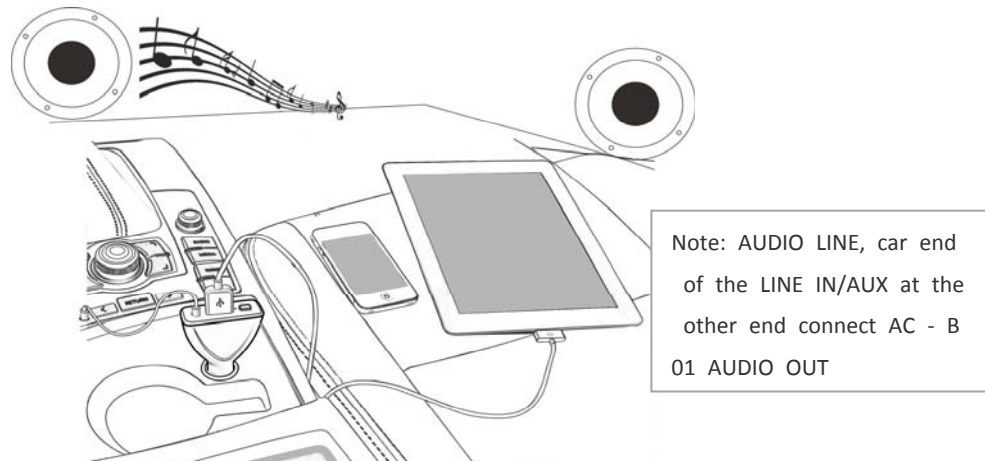

## 7. Functional specifications

On: connect the unit power, or long press "📞" the stereo sends out "beep, beep" of the boot prompt, the bluetooth indicator light flashing at the same time.

On the bluetooth connectivity, power supply, double click on the "📞", the machine enter into the search matching state, the bluetooth indicator light flash, a bluetooth device can search to the machine, click on the match, after the success of the connection, the bluetooth indicator light flash, slow the stereo will send du a hint sound. Within 10 minutes after the power to open the bluetooth speakers find any bluetooth equipment will automatically shut down also can be long press "📞" manual close bluetooth. If the next to connect again need to electrical commissioning or long press "📞" boot, this machine is back to league final equipment function; After successful connection of equipment to open the bluetooth automatically connected or click "📞" connection.

Warm prompt: if the connection fails, please shut down or restart to re-enter the search matches.

After the success of the bluetooth music playback: bluetooth connectivity, equipment can play music directly.

Hands-free calls: bluetooth stereo with mobile phone after the connection is successful, when the caller id, the stereo sends out "beep" prompt tone; According to "📞" answering the phone/long according to reject, can replace mobile phone talking to each other, and then according to the end of "📞" hang up the phone call, also can be long press "📞" to redial the bottom number phone.

Charger: insert the car power electricity long red light, no matter the bluetooth standby or shutdown state can be output 5 v / 2 a charge for other devices
