\*Note: Both for the items requested to be kept in short and long term confidentiality, please take into consideration that Carcomputer B.V. has spent substantial R&D effort in developing this product, which is the first of its kind in the industry. Having the subject information easily available to "competition" would negate the advantage they have achieved by developing this product. Not protecting the details of the design will result in financial hardship. Not keeping confidential the items requested for *short term* confidentiality would pre-inform and pre-alert competition, therewith giving away a critical part of competitive advantage and the element of surprise. Not keeping confidential the items requested for *long term* confidentiality would make competition privy to information they would normally never be able to obtain or only after significant investments time and R&D.

#### **Permanent Confidentiality:**

The applicant requests the exhibits listed above as permanently confidential be permanently withheld from public review due to materials that contain trade secrets and proprietary information not customarily released to the public.

#### **Short-Term Confidentiality:**

The applicant requests the exhibits selected above as short term confidential be withheld from public view for a period of 180 days from the date of the Grant of Equipment Authorization and prior to marketing. This is to avoid premature release of sensitive information prior to marketing or release of the product to the public. Applicant is also aware that they are responsible to notify ACB in the event information regarding the product or the product is made available to the public. ACB will then release the documents listed above for public disclosure pursuant to FCC Public Notice DA 04-1705.
