

# Manual for TrackBlue LLC Tags

Manual for two (2) Asset Tracking Devices, Model Numbers: TB-200 and TB-130. These two devices are Low Energy Bluetooth Devices using digital modulation operating in the 2400 MHz to 2483.5 MHz band and contain a receiver operating in the 902 MHz to 928 MHz Band. Both units are powered by an internal battery.

The product will help end customers optimize data accuracy, and will fit the demands of a broad spectrum of industries and applications. The tags will improve accuracy and increase productivity by enabling end customers to easily track their assets using the TrackBlue TB-200 and TB-130 Tags.

TrackBlue Tags are tracked using the TrackBlue App on the following devices:

iOS: Apple iPad3, iPod (touch), and iPhone (4s & later)

Android: (4.3 & 4.4) Samsung Note3, Motorola Droid

Nexus 7 and windows 7 & 8 via a dongle.

The TB-200 Asset Identification TAG is installation by attaching the tag with double-sided tape to the asset. We suggest All weather tape for items place outdoors and weather-resistant for items to be used indoors and outdoors. For items you wish to leave the tag on, it is suggested that you apply the tags with permanent adhesive on both sides of the double-sided tape. If applicable, you can use the four (4) screw holes provided to screw the item to your asset.

TrackBlue TB-200 allows the tags to be place on your assets without intruding on the external of the container/asset. Down load the TrackBlue App using your devices instructions

Once your asset is attached:
