



## **Inserting the micro SIM card & the microSD card**

Be sure to insert your SIM card and Micro SD card in the correct direction to avoid damage. Please refer to the following instructions.



## **Use the same method to insert SIM**



When installing a Nano SIM card into its tray, make sure that it fits the tray. If it is hard to pull the tray with the SIM card out of its slot, go to the TCL after-sales service sites to get it out. Do not forcefully pull it out.

## Note

Please charge before first use. Normally, the tablet will power on and display the Home Screen when you long press the Power key, but if the tablet is low on power, a battery icon will appear indicating that you should charge the device before use. Only use the charger recommended by TCL Communication Ltd. and its affiliates.



This device cannot be charged using the USB connection on your computer. Please plug in your charger before first use.

## 1.2 Home screen

Your device includes a Home screen with two pages, giving you more space to add your favorite apps, folders, and widgets. To switch between screens, slide your finger left or right on the screen.

### 1.2.1 Lock/Unlock your screen




Once your device is powered on, it shows a locked screen interface, which is set as default.

Press and slide up the lock screen to unlock.

Double touch on a shortcut icon to start the corresponding function.

## 1.2.2 Icons on your screen




Name	Description
Google Search	Touch it to access the Google Search engine.
Voice Actions	Use Voice Actions to watch a video, send email, set alarm, get directions, etc.
All Apps	Touch to show all apps list interface.
Back	Go back to the previous menu or screen.
Home	Return to the home screen.
Recent Apps	Touch to view recent apps.

Touch and drag down the Status bar to open the Quick setting panel or Notification panel. Touch and drag up to close it.

## Notification panel


When there are notifications, touch and drag down the Status bar to open the Notification panel and read the detailed information.



**Note:** After opening the Notification panel, touch  to switch to the Quick settings panel, or drag down the Status bar again to access the Quick settings panel.

## Quick setting panel

You can enable or disable functions or change modes by touching the icons on the Quick setting panel.



**Note:** After opening the Quick settings panel, touch  to enter User screen, which allows you to switch the user mode or add new users.

## 1.3 Apps and widgets

### 1.3.1 Apps

The Applications (apps) list contains all pre-embedded and newly installed apps. To access the apps list, touch the all apps key  on the Home screen.

### 1.3.2 Widgets

By touching and holding an empty area on the Home screen, you can switch to widget interface mode.

### 1.3.3 Get more apps

Touch the Google Play Store icon  to get more apps.

### 1.3.4 Create and manage shortcuts on the desktop

When you long press an icon on the All Apps menu or when in widget interface mode, it will jump to the Home screen automatically and allows you to drag it to your preferred location. Overlapping icons together will build a folder. You can name the folder by touching the **Folder > Unnamed Folder**.

### 1.3.5 Remove an app icon from desktop

Long press the item to be removed to activate Move mode, drag the item up to the top of the  **Remove** icon, and release after the item turns red.

### 1.3.6 Uninstall apps

Press  to enter all Apps. Long press the Apps icon you want to uninstall and drag it over the  icon, which appears at the top-right of the desktop.

## 1.4 Basic operation

### 1.4.1 Power on your device

Long press the **Power** key until the tablet powers on. It will take a few seconds before the screen lights up.

### 1.4.2 Power off your device

- Long press the Power key for about 3 seconds until the options appear, select "Power off" to power off your device.

- Long press the Power key for about 10 seconds to restart your device.

### 1.4.3 Stand-by mode

Press the Power key once to shut down the screen and to enter stand-by mode.

**Note:** When unused, the tablet will enter stand-by mode automatically. Press the **Power** key once to wake it up.

### 1.4.4 Restart

- Long press the **Power** key for about 3 seconds until the options appear, select "Restart" to restart your device.
- If your device is frozen, long press the Power key for about 10 seconds to restart.

### 1.4.5 Connecting to a computer via USB

Connecting your device to a computer via USB allows you to transfer files between your device and computer.

**Note:** Files copied to your tablet are not available until the USB data cable is disconnected from the PC completely. Use a USB 2.0 version or higher to connect the devices.

### 1.4.6 Change your wallpaper

Long press an empty area in the Home screen, then select **WALLPAPERS** to set wallpaper.

Or you can also change your wallpaper from the **Settings** > **Display** > **Wallpaper**, select an image, then touch **Set wallpaper**.

### 1.4.7 Wi-Fi

To turn Wi-Fi on and connect to a wireless network:

- Touch the Wi-Fi icon on the Quick setting bar to turn Wi-Fi on/off.
- Select **Settings**, touch the switch  beside Wi-Fi to turn Wi-Fi on/off.
- Select a Wi-Fi network to connect. If the network you selected is secured, you are required to enter a password or other credentials (you may need to contact the network operator for details). When finished, touch **Connect**.

**Tip:** To extend the battery life, turn Wi-Fi off when you're not using it.

#### 1.4.8 Email

You can also set-up external POP3, IMAP or Exchange email accounts on your device.

To access this function, touch the **Application**  on the Home screen, then select **Email** . An email setup wizard will guide you through the steps to set up an email account.

- Enter the email address of the account, then touch **Next**.
- Select the right account type (POP3, IMAP, or EXCHANGE), and sign in the password to touch **Next** to finish the email setup.

#### To create and send emails

Touch the  icon while on the Inbox screen.

- Enter recipient(s) email address(es) in the **To** field.
- If necessary, touch **+Cc/Bcc** to add a copy or a blind copy of the message.
- Enter the subject and the content of the message.
- Touch  to add an attachment.
- Finally, touch  to send .
- If you do not want to send the email right away, touch  and then select **Save draft** to save a copy.

#### 1.4.9 Surf the Web

Use the Browser application to surf the Web easily and securely. To access this function, touch the Application tab on the Home screen, then touch **Browser** .

#### To go to a Web page

On the Browser screen, touch the URL box at the top, enter the address of the Web page, then touch  to confirm.

#### 1.4.10 Zoom in/out

Draw your fingers apart/together to zoom in/out (Web browser, Gallery etc..).

# 2 Settings

## 2.1 Device

### 2.1.1 Gestures

Your device can be configured in ALARM mode so that turning it over will activate the snooze function, or you can mark a check box to change music tracks when the device is shaken.

### 2.1.2 Display

Touch **Settings > Display**, to view the following:

- **Brightness level** Adjust your screen to a comfortable brightness.
- **Wallpaper** Set your wallpaper.
- **Sleep** Set a time before the Screensaver begins.
- **Daydream** Select an animation effect to display while on standby status.
- **Font size** Select a suitable font size for your tablet.
- **When device is rotated** Touch to set when the device will be rotated.

### 2.1.3 Sound & notification

You can set volumes of system, using the **Volume up/ down** key, or set **Volumes, screen lock sound**, and **Power on/Shut down ringtone** by touching **Settings > Sound**.

### 2.1.4 Apps

Touch **Setting > Apps** to check the App status.

### 2.1.5 Storage & USB

Touch **Settings > Storage & USB** to view the memory usage status.

### 2.1.6 Battery

Touch **Settings > Battery** to check the battery power and its service status.

## 2.2 Personal

### 2.2.1 Location

Touching this allows sites to request access to your location.

- Select **Settings > Location**, touch the switch  at the title bar to enable/disable location services.
- Touch **Mode > Device only** to use GPS to determine your location.

### 2.2.2 Language & input

Touch **Settings > Language & input** to view or set system language and input methods.

### 2.2.3 Backup & reset

You can back up settings and other data associated with one or more of your Google Accounts. If you need to replace or factory reset your device, you can restore your data for any accounts that were previously backed up.

Touch **Settings > Backup & reset**

**Tips:** Please make sure that all of your important data has been backed-up before you run factory data reset, as this function will erase all user installed apps and data; and ensure that the remaining battery charge is more than 50%.

## 2.3 System

### 2.3.1 Date & time

Touch **Settings > Date & time**, to set date, time, and format.

**Note:** When the Automatic option is deactivated, you can manually set the date and time.

### 2.3.2 Regulatory & Safety

Touch to view Regulatory & Safety information, including Product model, Manufacturer name, etc.

### 2.3.3 About tablet

Touch **Settings > About tablet** to check legal information, tablet status, software version, etc.

### 3 Phone call

### 3.1 Placing a call


Touch  on the home screen to access phone call interface.

Touch  to display the keyboard. Enter the desired number from the keyboard directly or select a contact from **Contacts** or Call log by sliding or touching tabs, then touch  to place the call. The number you entered can be saved to **Contacts** by touching **Add to Contact**.



### 3.2 Answering or rejecting a call

When you receive a call, drag the icon  rightward to answer the call, leftward to reject the call, upward to reject the call by sending a preset message.



# **Safety information**

We recommend that you read this chapter carefully before using your device. The manufacturer disclaims any liability for damage, which may result as a consequence of improper use or use contrary to the instructions contained here.

## **• TRAFFIC SAFETY**

Given that studies show that using a device while driving a vehicle constitutes a real risk, even when the hands-free kit is used (car kit, headset...), drivers are requested to refrain from using their device when the vehicle is not parked.

When driving, do not use your device or headphone to listen to music. Using a headphone can be dangerous and forbidden in some areas. ## **FCC RF Exposure Information (SAR):**

This device is designed and manufactured not to exceed the emission limits for exposure to radio frequency (RF) energy set by the Federal Communications Commission of the United States.

During SAR testing, this is set to transmit at its highest certified power level in all tested frequency bands, and placed in positions that simulate RF exposure in usage near the body with the separation of 10 mm. Although the SAR is determined at the highest certified power level, the actual SAR level of the device while operating can be well below the maximum value. This is because the device is designed to operate at multiple power levels so as to use only the power required to reach the network. In general, the closer you are to a wireless base station antenna, the lower the power output.

The exposure standard for wireless devices employs a unit of measurement known as the Specific Absorption Rate, or SAR. The SAR limit set by the FCC is 1.6W/kg.

Tests for SAR are conducted using standard operating positions accepted by the FCC with the device transmitting at its highest certified power level in all tested frequency bands.

SAR compliance for body operation is based on a separation distance of 1.0 cm between the device and the human body. During use, the actual SAR values for this device are usually well below the values stated above. This is because, for purposes of system efficiency and to minimize interference on the network, the operating power of your device is automatically decreased when full power is not needed. The lower the power output of the device, the lower its SAR value.

Body SAR testing has been carried out at a separation distance of 1.0 cm. To meet RF exposure guidelines during body-worn operation, the device should be positioned at least this distance away from the body.

If you are not using an approved accessory ensure that whatever product is used is free of any metal and that it positions the device the indicated distance away from the body.

Organizations such as the World Health Organization and the US Food and Drug Administration have suggested that if people are concerned and want to reduce their exposure they could use a hands-free accessory to keep the wireless device away from the head or body during use, or reduce the amount of time spent on the device

# Troubleshooting

- Use Factory data reset and the upgrade tool to perform tablet formatting or software upgrading. All user tablet data: contacts, photos, and files, downloaded applications will be lost permanently. It is strongly advised to fully back up the tablet data and profile before doing formatting and upgrading.

## **My tablet cannot be switched on or is frozen**

- When the tablet cannot be switched on, charge for at least 20 minutes to ensure the minimum battery power needed, then try to switch on again.
- When the tablet falls into a loop during power on-off animation and the user interface cannot be accessed, press the Power key to Pop up the options, then long press "Power Off" to enter Safe Mode. This eliminates any abnormal OS booting issues caused by 3rd party APKs.

## **My tablet has not responded for several minutes**

- Restart your tablet by long pressing the Power key for about 10 seconds.

## **My tablet turns off by itself**

- Check that your screen is locked when you are not using your tablet, and make sure the Power key is not mis-contacted due to unlocked screen.
- Check the battery charge level.

## **My tablet can't charge properly**

- Make sure that your battery is not completely discharged; if the battery power is empty for a long time, it may take around 20 minutes to display the battery charger indicator on the screen.

- Make sure charging is carried out under normal conditions (0°C to +40°C).
- When abroad, check that the voltage input is compatible.

### **My tablet can't connect to the Internet**

- Check your tablet's Internet connection settings.
- Make sure you are in a place with network coverage.
- Try connecting at a later time or another location.

### **I am unable to use the features described in the manual**

- Check with your operator to make sure that your subscription includes this service.
- Make sure this feature does not require an ALCATEL ONE TOUCH accessory.

### **I am unable to connect my tablet to my computer**

- Check that your USB driver is installed properly.

- Check that your computer meets the requirements for ALCATEL ONE TOUCH Centre Installation.
- Make sure that you're using the right cable from the box.

### **I am unable to download new files**

- Make sure there is sufficient tablet memory for your download.
- Check your subscription status with your operator.

### **The tablet cannot be detected by others via Bluetooth**

- Make sure that Bluetooth is turned on and your tablet is visible to other users.
- Make sure that the two tablets are within Bluetooth's detection range.

### **How to make your battery last longer**

- Make sure you follow the complete charge time (minimum 2.5 hours).

- After a partial charge, the battery level indicator may not be exact. Wait for at least 20 minutes after removing the charger to obtain an exact indication.
- Adjust the brightness of screen as appropriate.
- Extend the email auto-check interval for as long as possible.
- Update news and weather information on manual demand, or increase their auto-check interval.
- Exit background-running applications if they are not being used for a long time.
- Deactivate Bluetooth, Wi-Fi, or GPS when not in use.

**The tablet will become warm following prolonged game playing, internet surfing or running other complex applications.**
