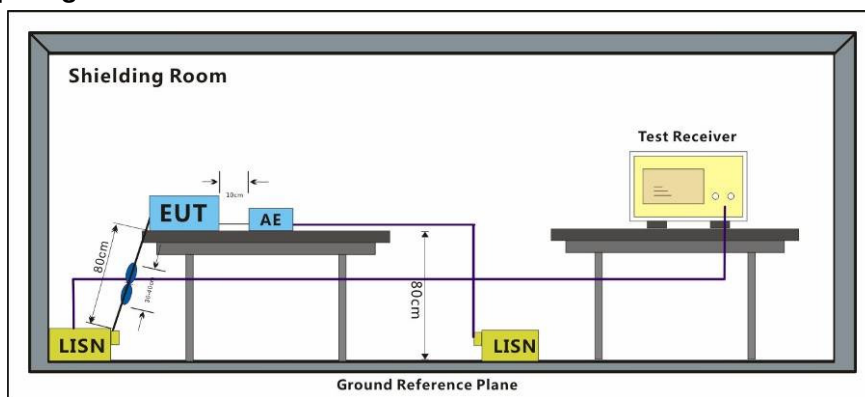

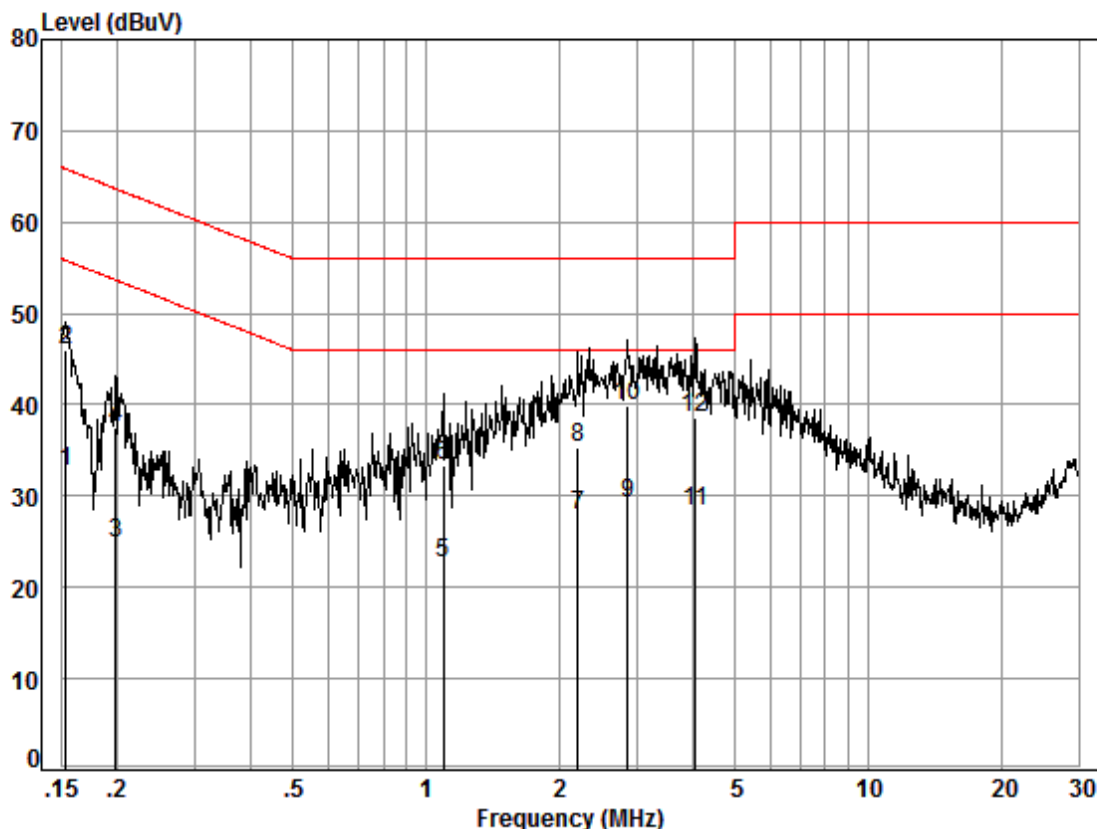
6.1.2 Test Setup Diagram

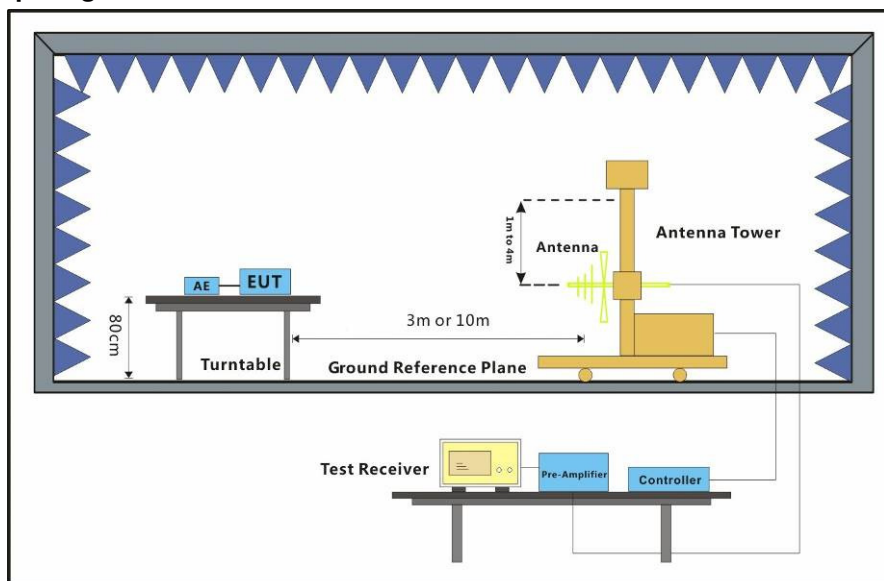
g: WCDMA Band II+BT+earphone+battery+adapter

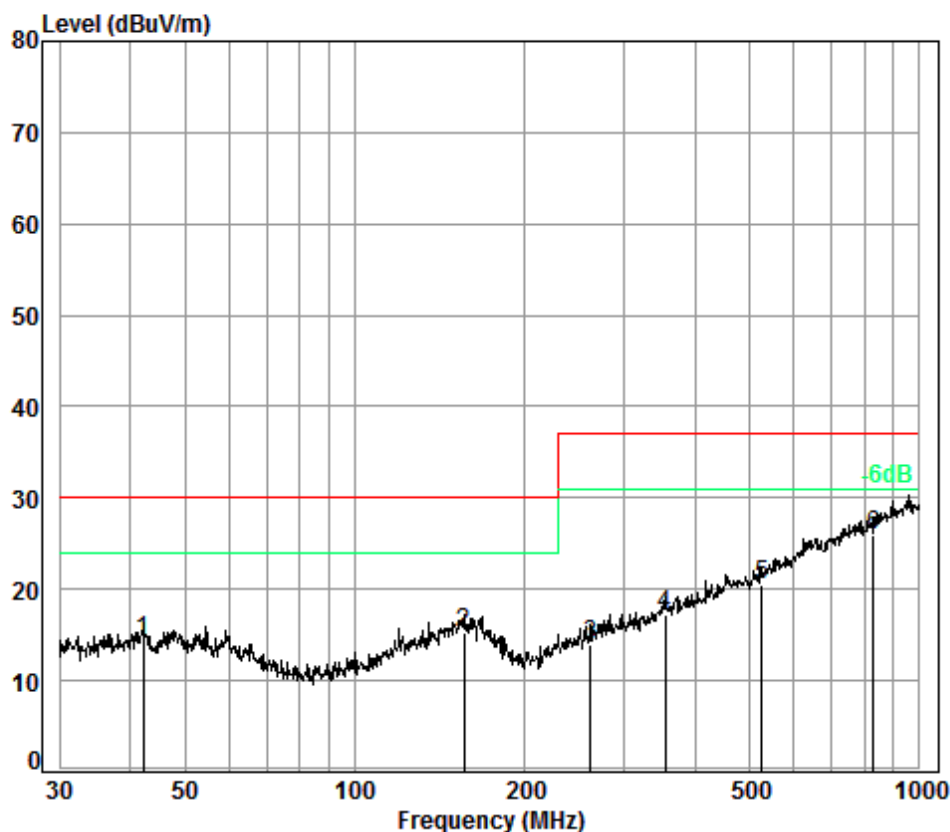
6.2.2 Test Setup Diagram

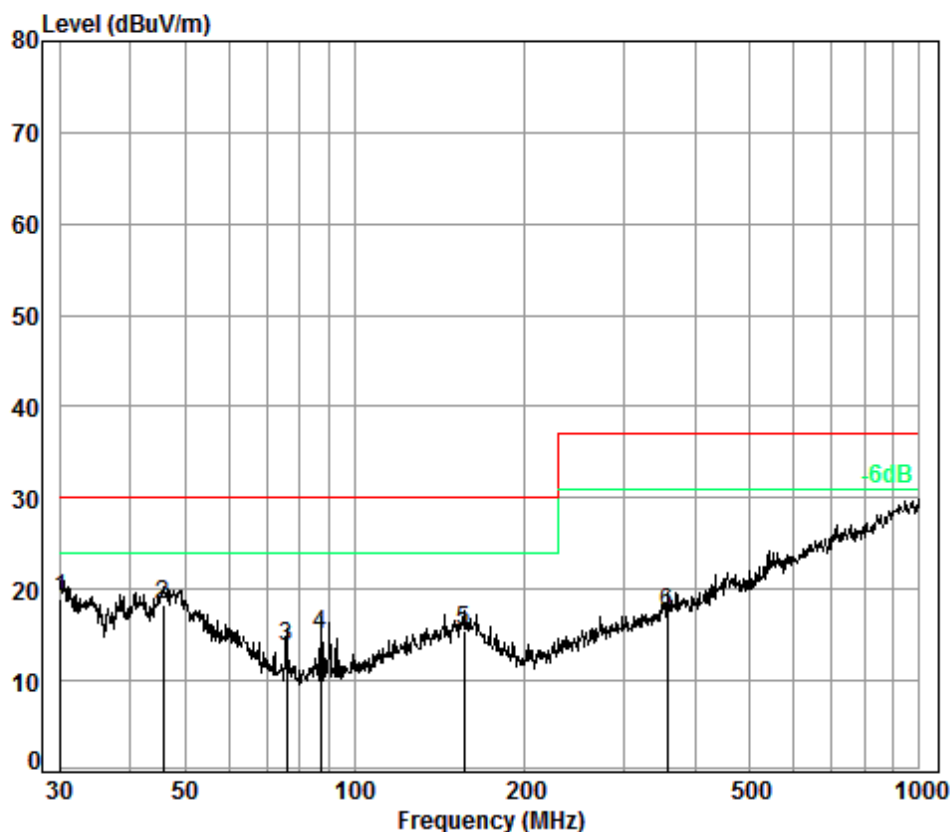

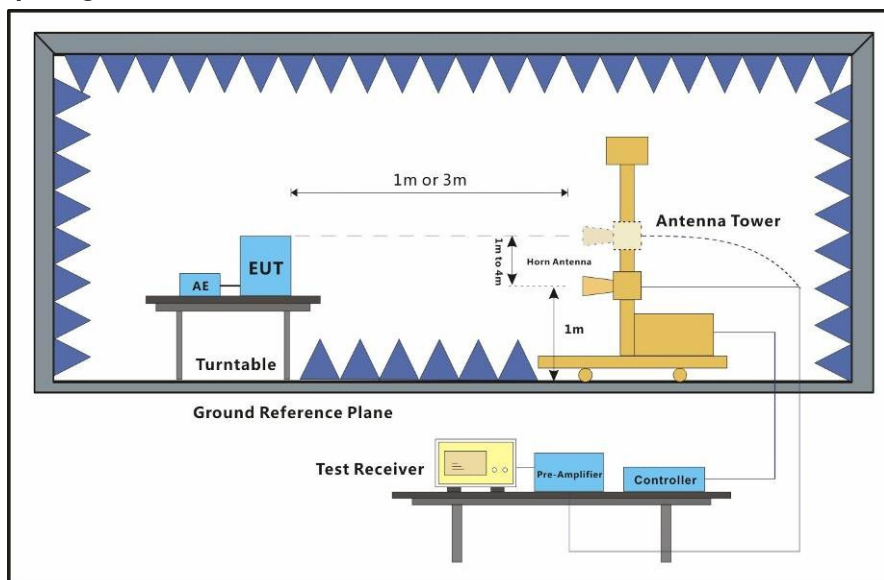

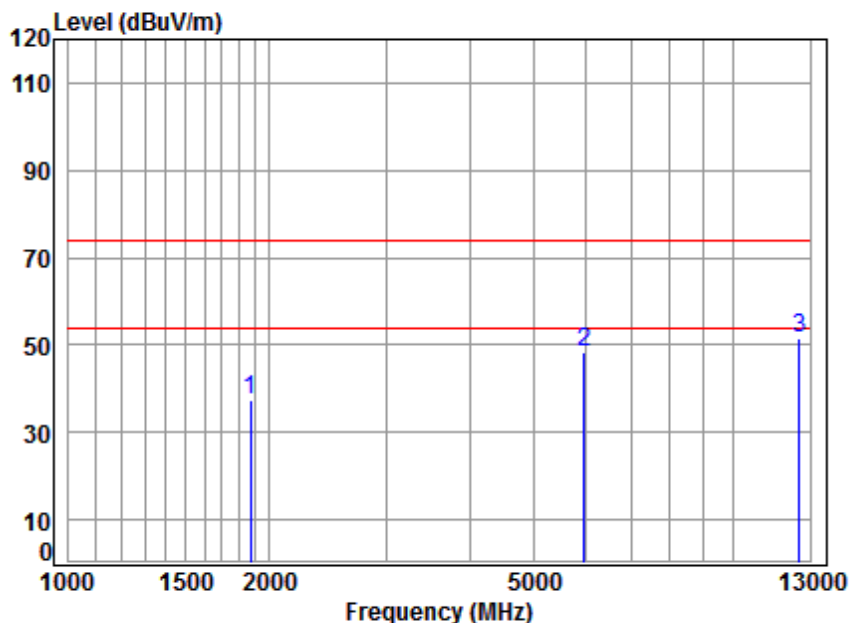
