# Safety and use



Please read this chapter carefully before using your device. The manufacturer disclaims any liability for damage, which may result as a consequence of improper use or use contrary to the instructions contained herein.

- Do not use your device when the vehicle is not safely parked. Using a hand-held device while driving is illegal in many countries.
- Comply with restrictions on use specific to certain places (hospitals, planes, gas stations, schools, etc.).
- Switch the device off before boarding an aircraft.
- Switch the device off when you are in health care facilities, except in designated areas.
- Switch the device off when you are near gas or flammable liquids. Strictly obey all signs and instructions posted in a fuel depot, petrol station, or chemical plant, or in any potentially explosive atmosphere when operate your device.
- Turn off your mobile device or wireless device when in a blasting area or in areas posted with notifications requesting "two-way radios" or "electronic devices" are turned off to avoid interfering with blasting operations.

The manufacturer's recommended operating temperature range is 0°C (32°F) to 40°C (104°F). At over 40°C (104°F) the legibility of the device's display may be impaired, though this is temporary and not serious.

#### **PROTECT YOUR HEARING**

## **Battery:**

In accordance with air regulations, the battery of your product is not fully charged. Please charge it first.

## Radio waves

THIS DEVICE MEETS THE GOVERNMENT'S REQUIREMENTS FOR EXPOSURE TO RADIO WAVES.

The exposure standard for devices employs a unit of measurement known as the Specific Absorption Rate, or SAR. The highest SAR value for this device when tested is 0.94 W/Kg for use at the ear and 0.66 W/Kg for use close to the body.

While there may be differences between the SAR levels of various devices and at various positions, they all meet the government requirement for RF exposure.

For body-worn operation, the device meets FCC RF exposure guidelines provided that it is used with a non-metallic accessory with the handset at least 15 mm from the body. Use of other accessories may not ensure compliance with FCC RF exposure guidelines.
