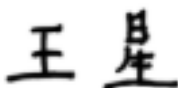

A. 1.1 Measurement Limit

End User Devices may operate only if they can positively receive and decode an authorization signal transmitted by a CBSD, including the frequencies and power limits for their operation.

An End User Device must discontinue operations, change frequencies, or change its operational power level within 10 seconds of receiving instructions from its associated CBSD.

A.1.2 Measurement Method of LTE B48

The EUT was connected via an RF cable to a certified CBSD and spectrum analyzer. End user device additional requirements (CBSD Protocol) are tested per the test procedures listed below.

During testing, the EUT was connected to a certified CBSD (Baicells pBS2120 FCC ID: 2AG32PBS212096) as a companion device to show compliance with Part 96.47.

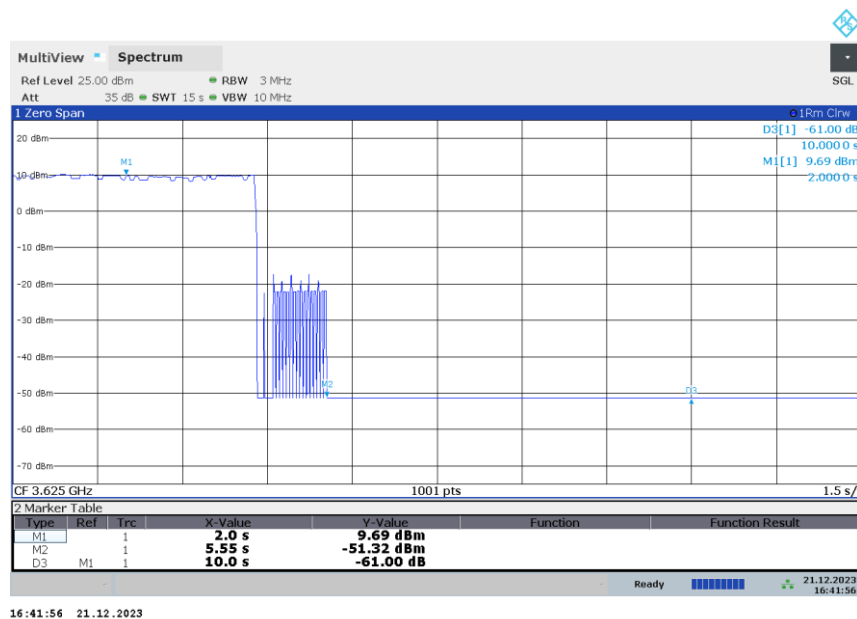
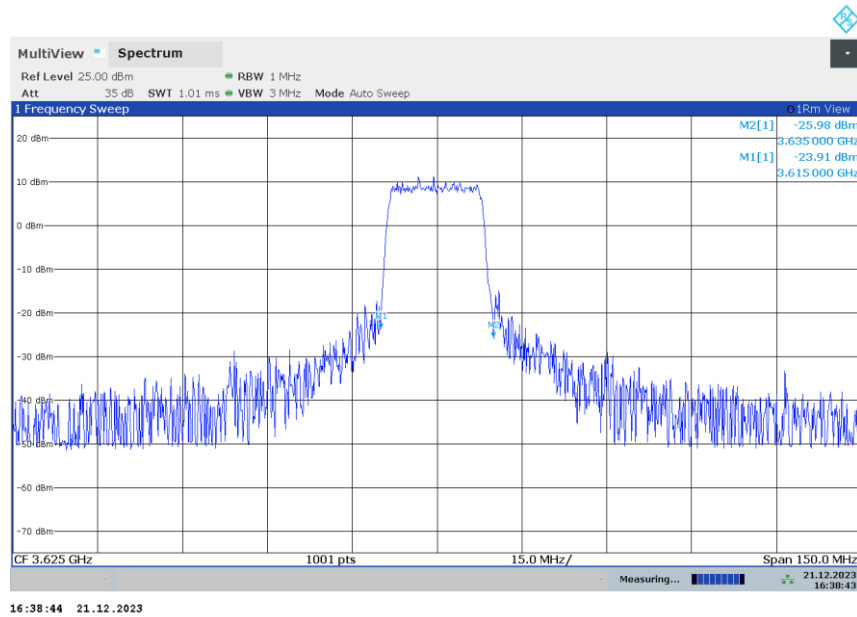
