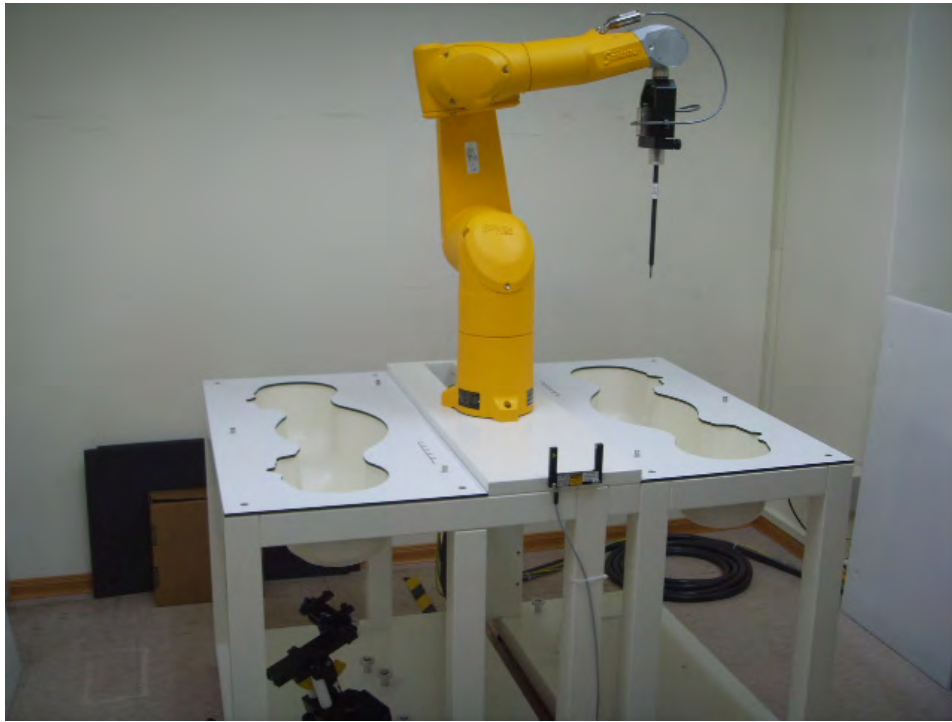


Fig.1 Photograph of the SAR measurement system

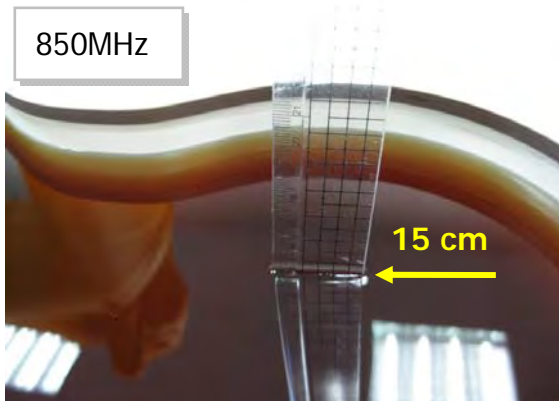

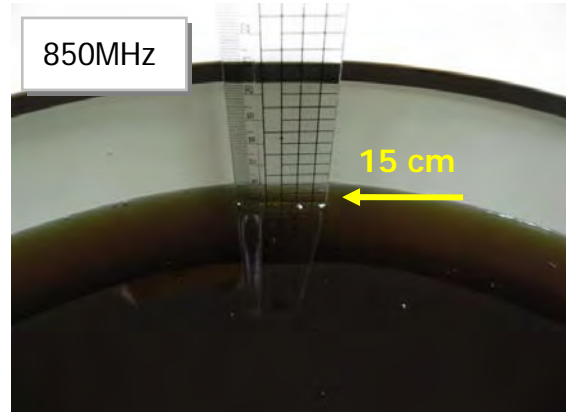

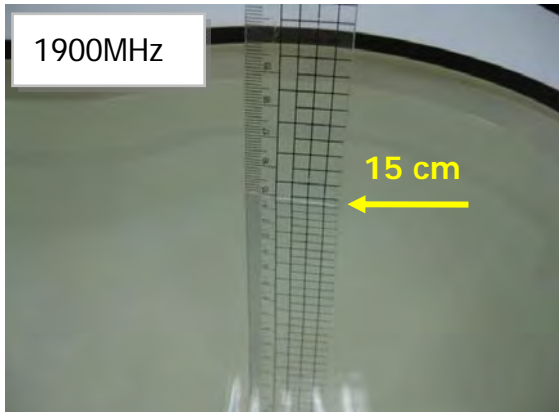

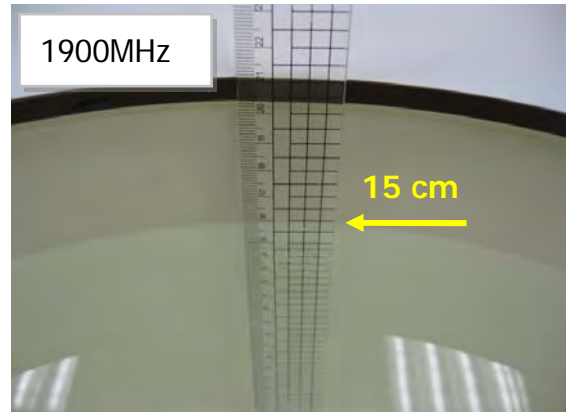

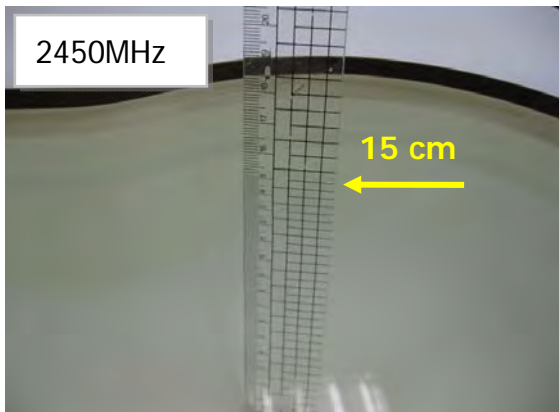

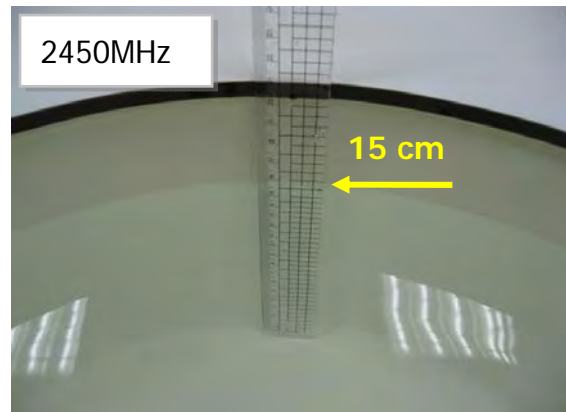

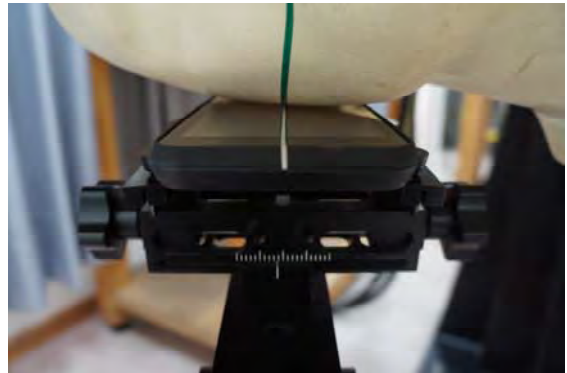
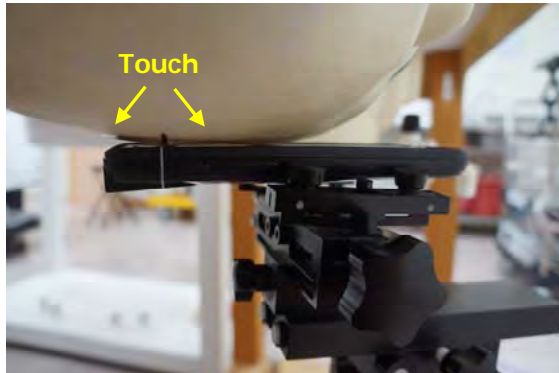


Fig.3 Right Head Section / Cheek-Touch Position

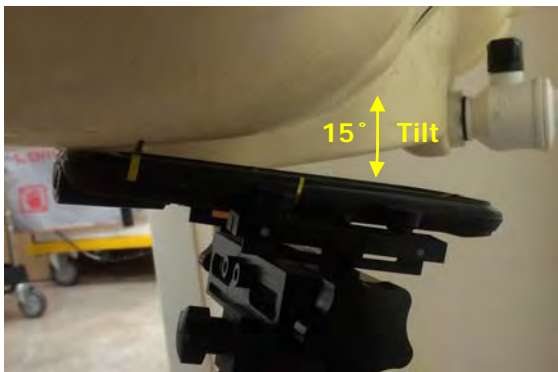


Fig.4 Right Head Section / Ear-Tilt Position(15°)

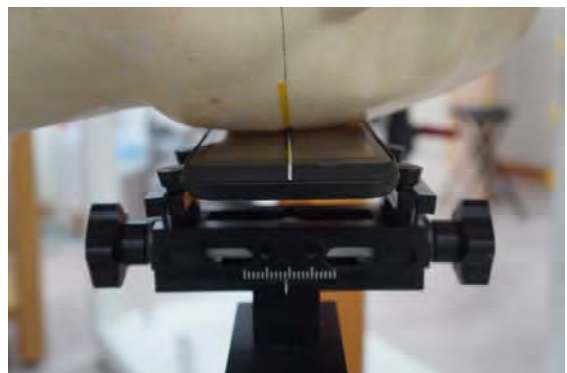
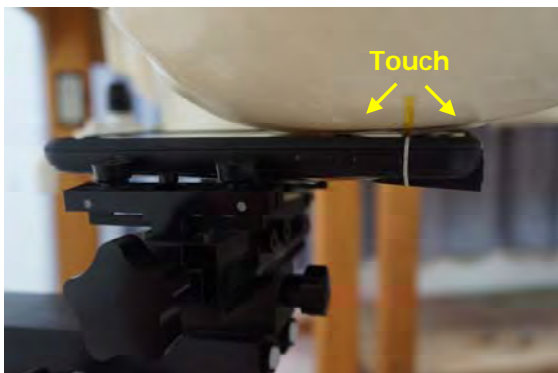


Fig.5 Left Head Section / Cheek-Touch Position

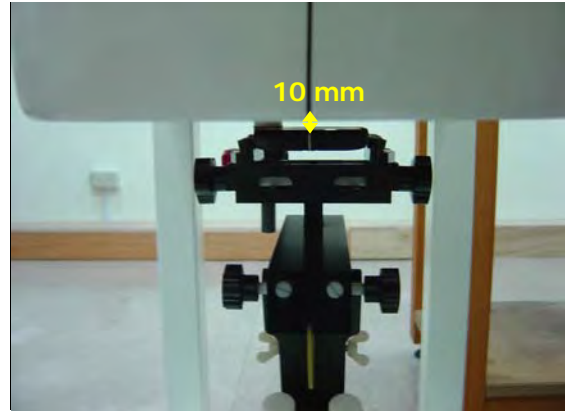


Fig.7 EUT front to flat phantom

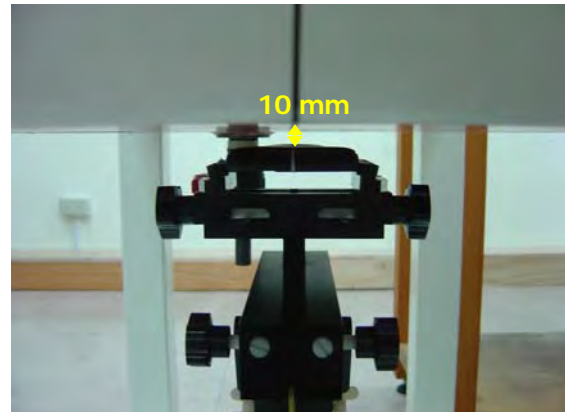


Fig.8 EUT back to flat phantom

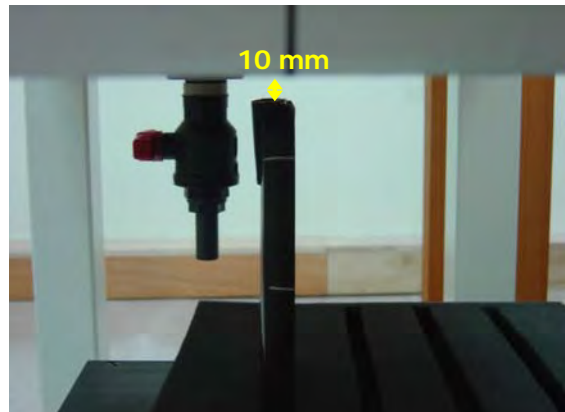


Fig.9 EUT top to flat phantom

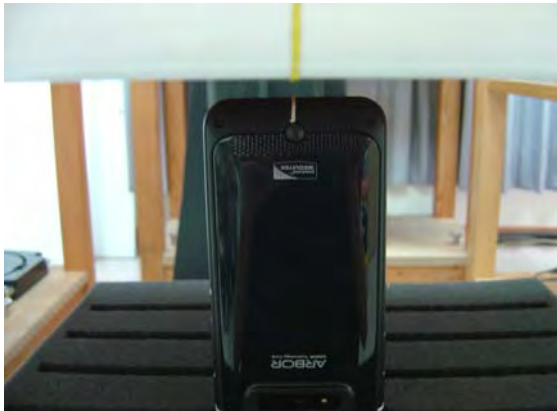


Fig.10 EUT bottom to flat phantom

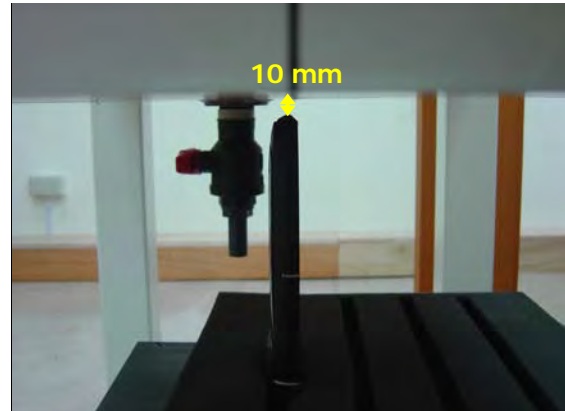


Fig.11 EUT right to flat phantom

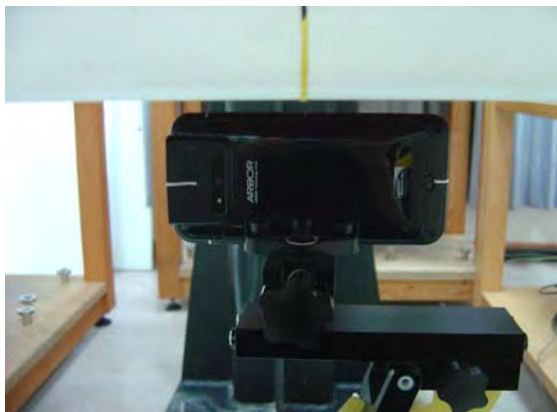
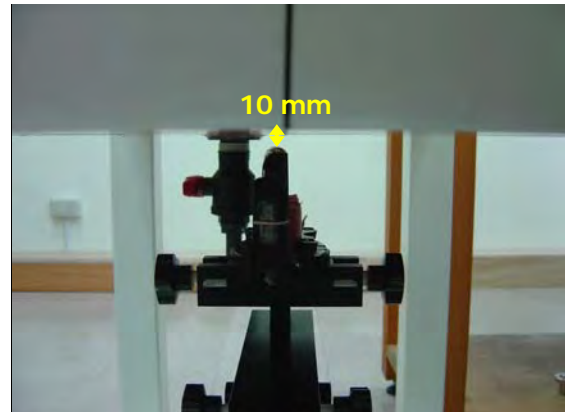
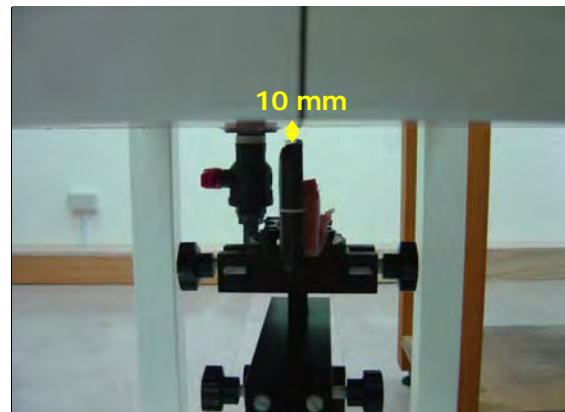


Fig.12 EUT left to flat phantom

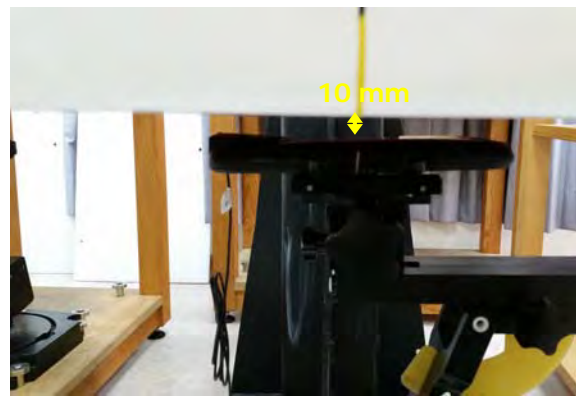


Fig.14 EUT back with headset to flat phantom

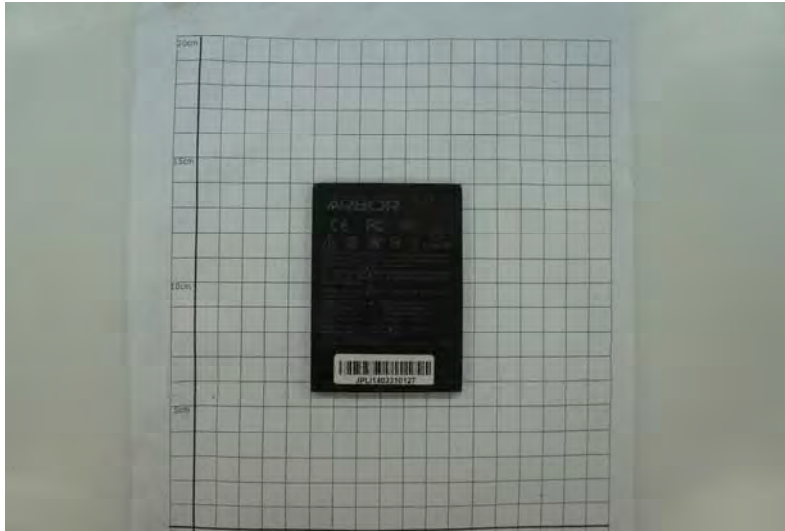


Fig.17 Front view of battery

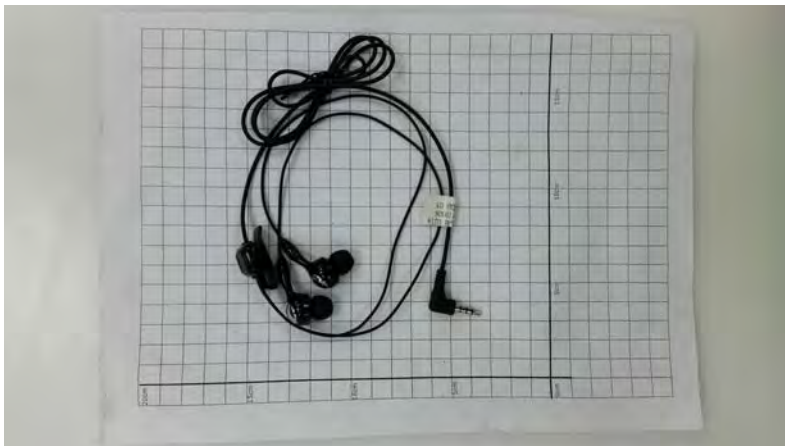


Fig.18 Headset
