8.1 Test Result

The antenna port 1 and antenna port 2 support 2x2 MIMO with identical RF transmission, therefore only antenna port 1 tested and record the data.

Only antenna port 1 was tested.

The operation temperature range is -30 to 50 °C declared by the manufacture.

the nominal supply voltage is 120V.

VL: Lowest voltage is 85% of normal voltage.

VH: Highest voltage is 115% of the nominal supply voltage.

NT: Normal temperature 25°C .

The 20ppm frequency deviation can demonstrate all emission is maintained within the band of operation.
