5.2 MPE Calculation

For FCC:

According to the formula $S = P / 4\pi R^2$, we can calculate S which is MPE.

Note:

- 1) P (mW)
- 2) R = distance to the center of radiation of antenna (in meter) = 20cm
- 3) MPE limit = 1mW/cm²

For 2.4GHz WiFi mode:

The max. antenna gain is: 1.52 dBi
