## 4 Test Standards and Limits

### 4.1 FCC Radiofrequency radiation exposure limits:

According to §1.1310, the limit for general population/uncontrolled exposures

Frequency	Power density(mW/cm <sup>2</sup> )	Averaging time(minutes)
300MHz~1.5GHz	$f/1500$	30
1.5GHz~100GHz	1.0	30

For 2.4G band, the limit is 1.0 mW/cm<sup>2</sup>

### 4.2 IC Radiofrequency radiation exposure limits:

According to RSS-102 section 2.5.2, RF exposure evaluation is required if the separation distance between the user and/or bystander and the device's radiating element is greater than 20 cm, except when the device operates as follows:

below 20 MHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than 1 W (adjusted for tune-up tolerance);

- at or above 20 MHz and below 48 MHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than  $4.49/f^{0.5}$  W (adjusted for tune-up tolerance), where  $f$  is in MHz;
- at or above 48 MHz and below 300 MHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than 0.6 W (adjusted for tune-up tolerance);
- at or above 300 MHz and below 6 GHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than  $1.31 \times 10^{-2} f^{0.6834}$  W (adjusted for tune-up tolerance), where  $f$  is in MHz;
- at or above 6 GHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than 5 W (adjusted for tune-up tolerance).

For 2.4G band, the limit of worse case is 2.68 W

## 5.2 MPE Calculation

For FCC:

According to the formula  $S = P / 4\pi R^2$ , we can calculate S which is MPE.

Note:

- 1) P (mW)
- 2) R = distance to the center of radiation of antenna (in meter) = 20cm
- 3) MPE limit = 1mW/cm<sup>2</sup>

Antenna 1: E.I.R.P. =  $P \times G = 0.04977 \times 1.641 = 0.08W < 2.68W$

Antenna 2: E.I.R.P. =  $P \times G = 0.04295 \times 1.641 = 0.07W < 2.68W$

For 2.4GHz WiFi MIMO mode: E.I.R.P. =  $P \times G = 0.06318 \times 3.281 = 0.21W < 2.68W$

So the device is exclusion from SAR test.
