5.2 MPE Calculation

The Max Conducted Peak Output Power is 15.30dBm (33.88mW);

The best case gain of the antenna is 3.3dBi. 3.3dB logarithmic terms convert to numeric result is nearly 2.14

For FCC:

According to the formula $S = \frac{PG}{4R^2\pi}$, we can calculate S which is MPE.

Note:

1) P (Watts) = Power Input to antenna = $10^{\frac{dBm}{10}} / 1000$

2) G (Antenna gain in numeric) = $10^{(Antenna\ gain\ in\ dBi / 10)}$

3) R = distance to the center of radiation of antenna (in meter) = 20cm

4) MPE limit = 1mW/cm²

For WiFi: $S = \frac{PG}{4R^2\pi} = \frac{33.88 \times 2.14}{4 \times 400 \times 3.14} = 0.014\ mW/cm^2$

So the device is exclusion from SAR test.
