5.2 MPE Calculation

According to the formula $S = PG/4\pi R^2$, we can calculate S which is MPE.

Note:

- 1) P_d = Power density in mW/cm^2
- 2) P_{out} = Output power to antenna in mW
- 3) G = gain of antenna in linear scale
- 4) R = min. separation distance between the antenna and the user.

The max. antenna gain is 2.61 dBi
