The Radio with FCC ID: 2AE6CER9000VHF was designed to operate in the frequency bands 136~174 MHz

To aid equipment authorization in other countries which accept the United States FCC Grant for Certification, Shenzhen Excera Technology Co., Ltd. is requesting that the FCC lists the frequencies 136~174 MHz, under FCC Rule Part 90/80/74/22 on the FCC Grant.

Shenzhen Excera Technology Co., Ltd. Attests that the radio will not be marketed to USA users with the frequency band which is not allowed by the rule part 90/80/74/22.


