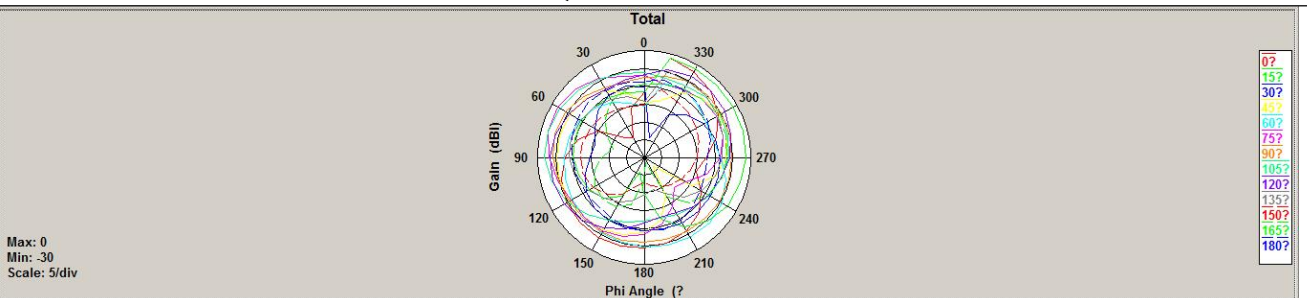

2D POLAR RADIATION PATTERN

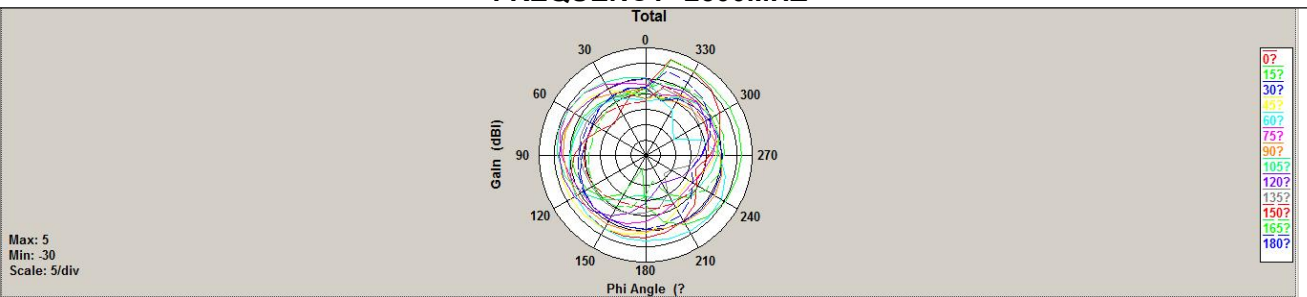

2D POLAR RADIATION PATTERN

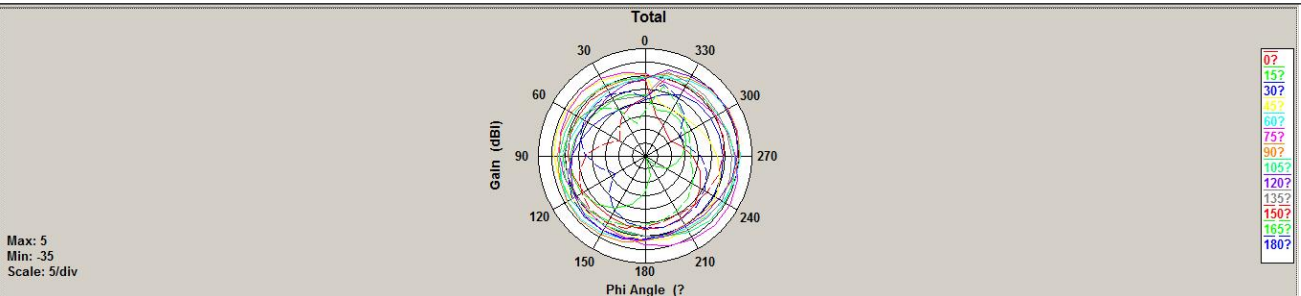

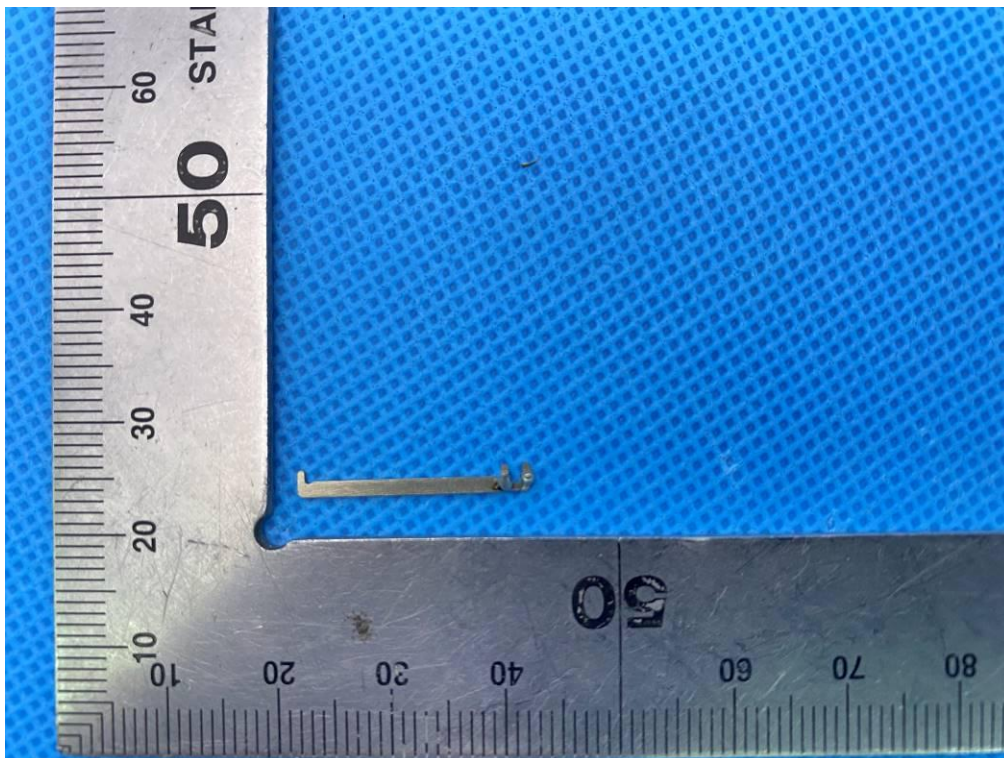

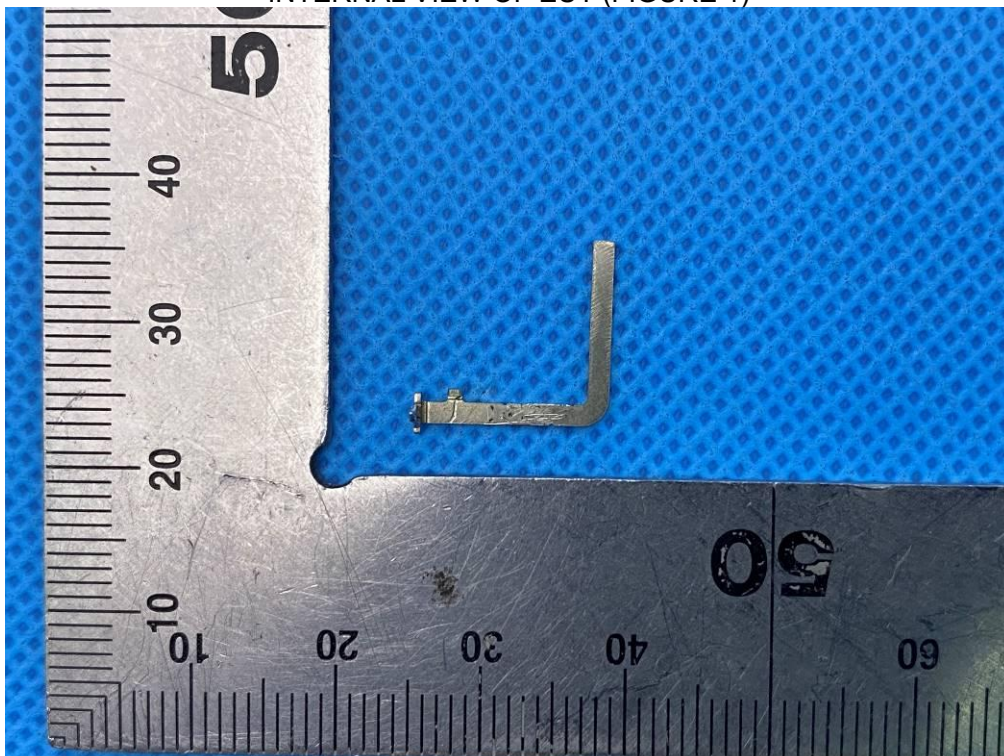
