


MANUAL CONTROL

1. To turn the item ON quickly press on the will flash to indicate the power is on. Push again to change the vibration pattern. There are a total of 8 modes using the manual control.


2. To power OFF your plug press and hold \circ for 2 seconds. LED will turn off to indicate the power is OFF.





REMOTE CONTROL



Flashing light = Charging




Solid light = Fully Charged

· All b-Vibe items include travel lock for safe and convenient travel


For the remote:
