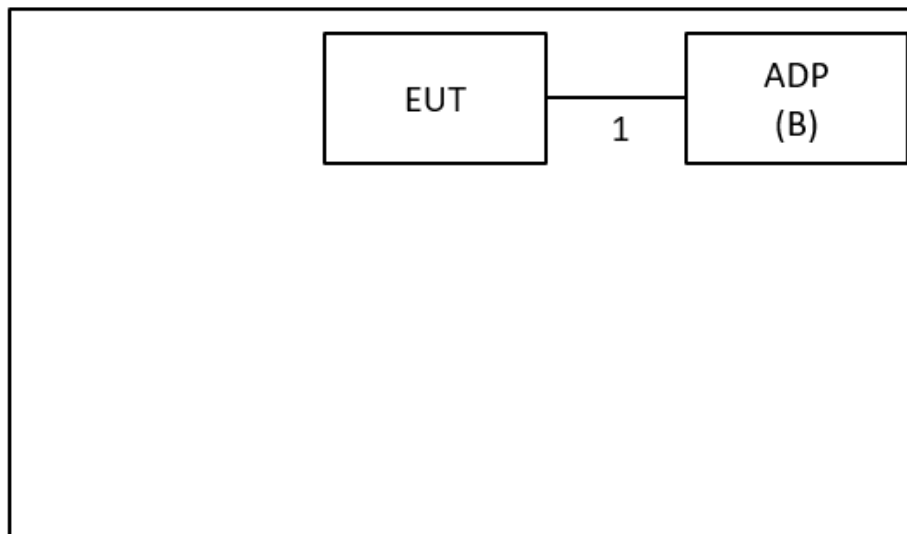

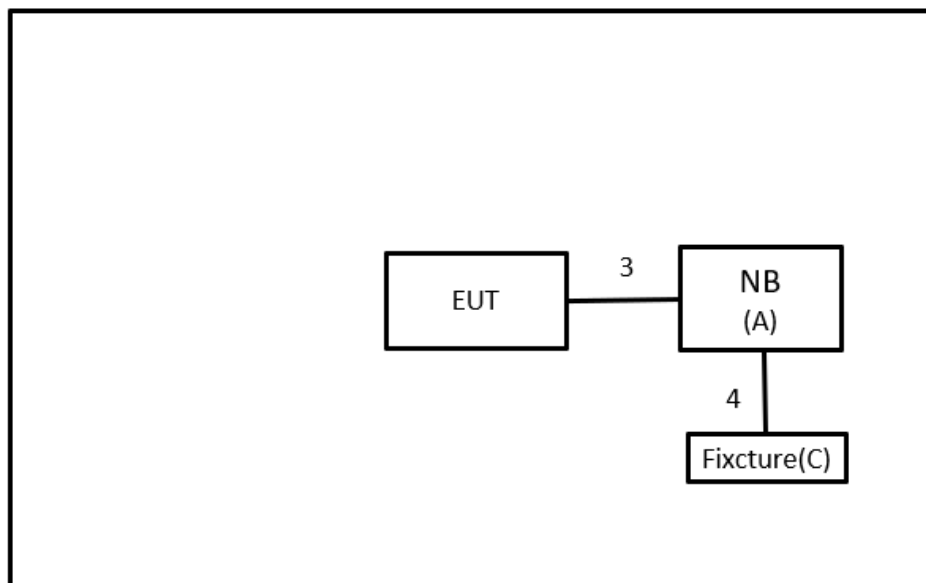

3.2 TEST PROCEDURE

- a. The EUT was placed 0.8 m above the horizontal ground plane with the EUT being connected to the power mains through a line impedance stabilization network (LISN).
 All other support equipment were powered from an additional LISN(s).
 The LISN provides 50 Ohm/50uH of impedance for the measuring instrument.
- b. Interconnecting cables that hang closer than 40 cm to the ground plane shall be folded back and forth in the center forming a bundle to keep the cable above 40 cm.
- c. Excess I/O cables that are not connected to a peripheral shall be bundled in the center.
 The end of the cable will be terminated, using the correct terminating impedance.
 The overall length shall not exceed 1 m.
- d. The LISN is spaced at least 80 cm from the nearest part of the EUT chassis.

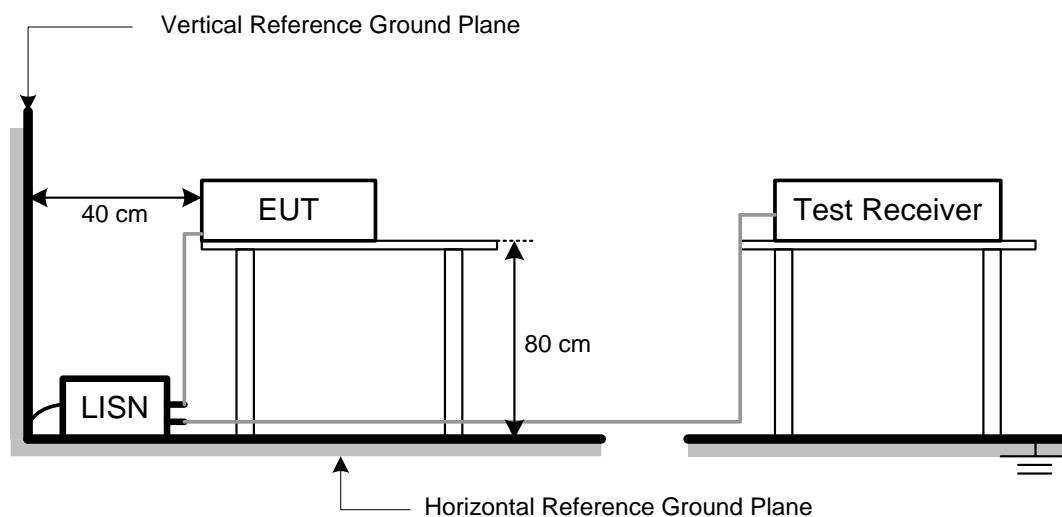

4.1 LIMIT

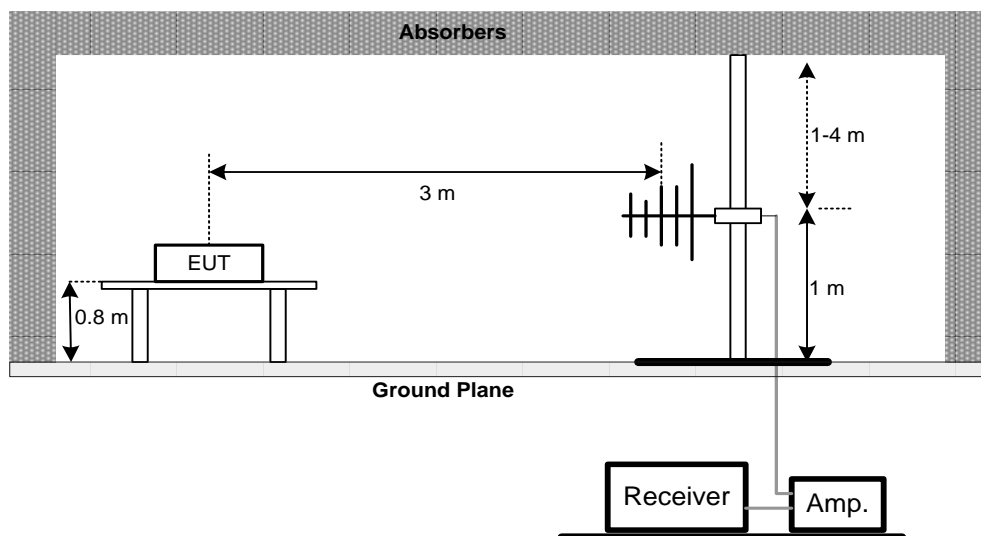

4.2 TEST PROCEDURES

1. Substitution method is used for E.I.R.P measurement. In the semi-anechoic chamber, EUT placed on the 0.8m height of Turn Table, rotated the table around 360 degrees to search the maximum radiation power and receiver antenna shall be rotated vertical and horizontal polarization and moved height from 1m to 4m to find the maximum polar radiated power. The "Read Value" is the spectrum reading the maximum power value.
2. The substitution horn antenna is substituted for EUT at the same position and signals generator export the CW signal to the substitution antenna via a TX cable. Rotated the Turn Table and moved receiving antenna to find the maximum radiation power. Adjust output power level of S.G to get a Value of spectrum reading equal to "Read Value " of step a. Record the power level of S.G
3. EIRP = Output power level of S.G – TX cable loss + Antenna gain of substitution horn.
4. E.R.P power can be calculated form E.I.R.P power by subtracting the gain of dipole, E.R.P power = E.I.R.P power - 2.15dBi.
5. The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 1MHz/3MHz.

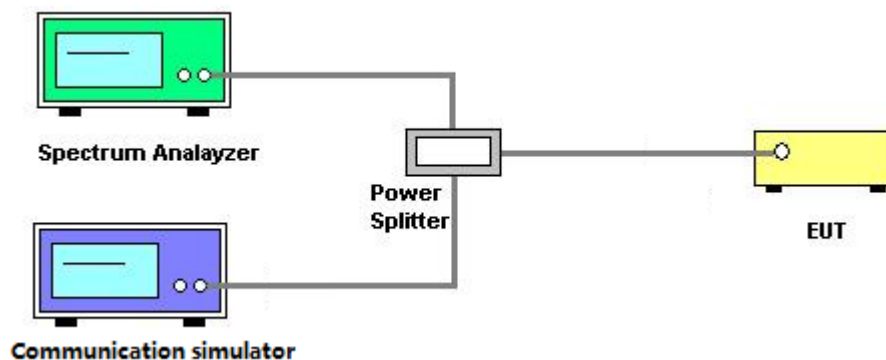
5. OCCUPIED BANDWIDTH MEASUREMENT

5.1 TEST PROCEDURES

The testing follows FCC KDB 971168 v03r01 Section 4.

1. The EUT makes a call to the communication simulator. All measurements were done at low, middle and high operational frequency range. The communication simulator station system controlled a EUT to export maximum output power under transmission mode and specific channel frequency. Use OBW measurement function of Spectrum analyzer to measure 99 % occupied bandwidth and 26dB bandwidth.
2. The EUT was connected to spectrum analyzer and system simulator via a power divider.
3. $RBW = (1\% \sim 5\%) * EBW$
 $VBW \geq 3 * RBW$
4. Set spectrum analyzer with Peak detector.

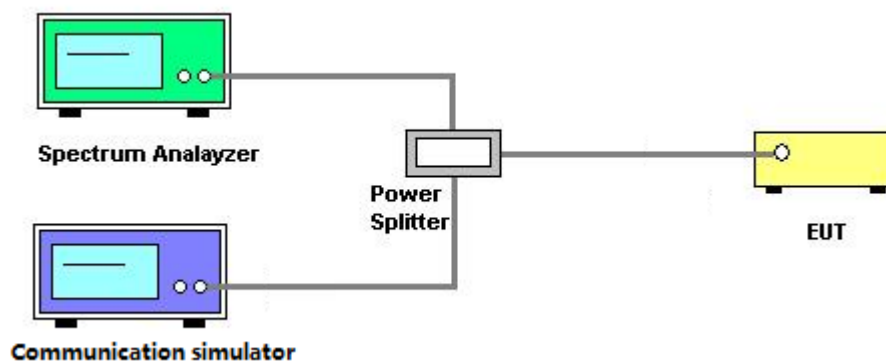
The power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitting power (P) by a factor of at least $43 + 10 \log(P)$ dB. The emission limit equal to -13dBm.

6.2 TEST PROCEDURES

The testing follows FCC KDB 971168 v03r01 Section 6.

1. The EUT was connected to spectrum analyzer and system simulator via a power divider.
2. The band edges of low and high channels for the highest RF powers were measured. Set RBW $\geq 1\%$ EBW in the 1MHz band immediately outside and adjacent to the band edge.
3. Set spectrum analyzer with Peak detector.
4. The RF fundamental frequency should be excluded against the limit line in the operating frequency band.

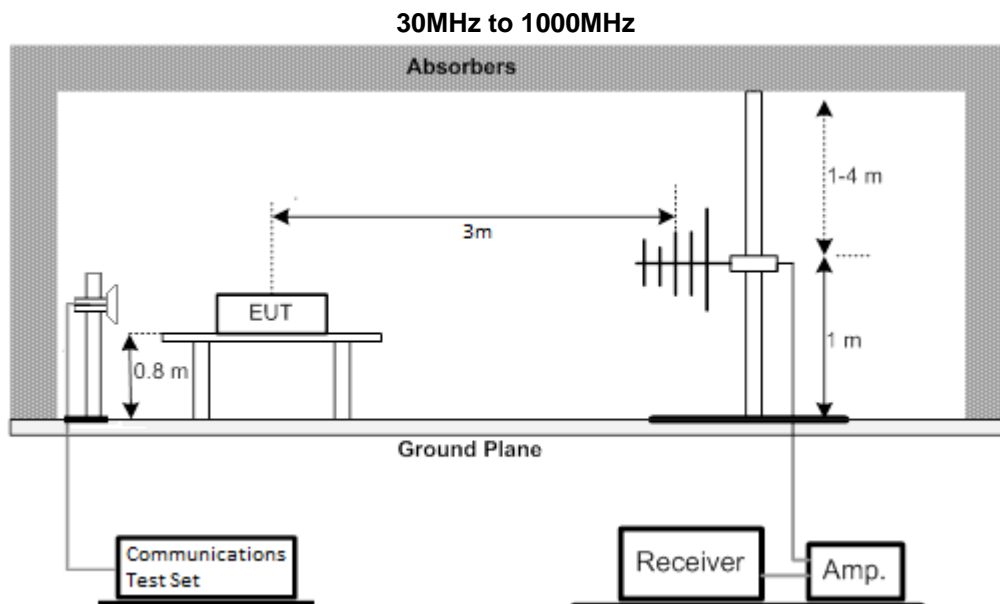

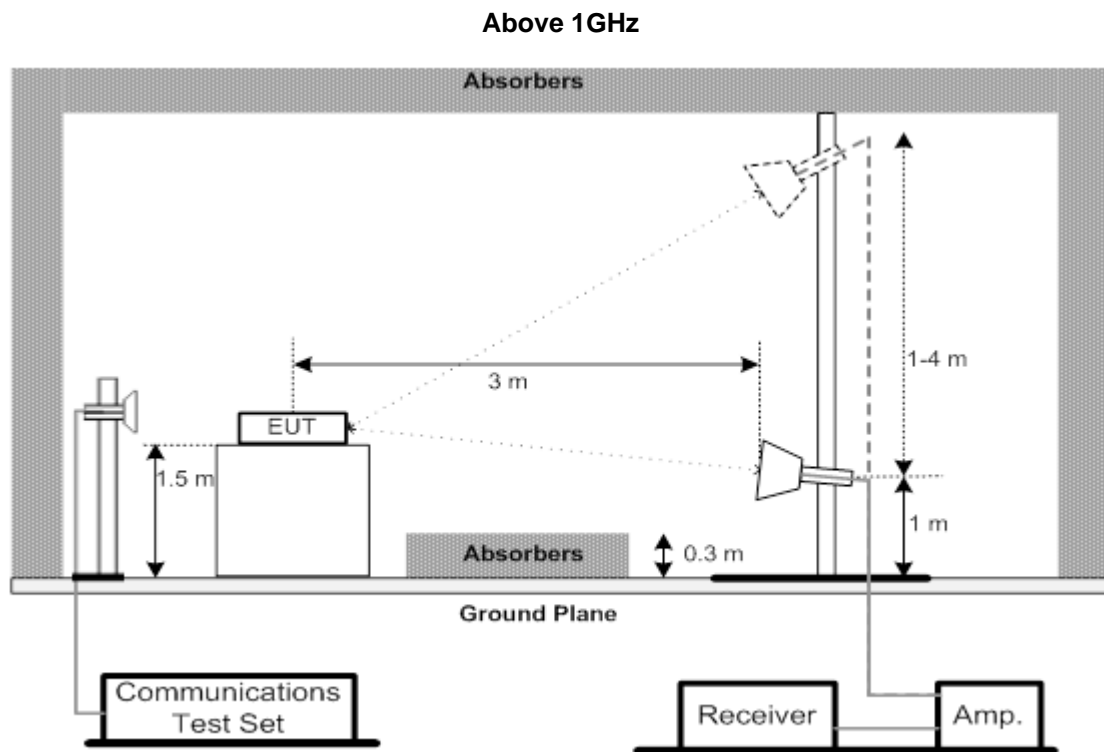
7.2 TEST PROCEDURES

The testing follows FCC KDB 971168 v03r01 Section 6.2.

1. In the semi-anechoic chamber, EUT placed on the 0.8m height of Turn Table, rotated the table around 360 degrees to search the maximum radiation power and receiver antenna shall be rotated vertical and horizontal polarization and moved height from 1m to 4m to find the maximum polar radiated power. The "Read Value" is the spectrum reading the maximum power value.
2. The substitution horn antenna is substituted for EUT at the same position and signals generator export the CW signal to the substitution antenna via a TX cable. Rotated the Turn Table and moved receiving antenna to find the maximum radiation power. Adjust output power level of S.G to get a Value of spectrum reading equal to "Read Value " of step a. Record the power level of S.G
3. $EIRP = \text{Output power level of S.G} - \text{TX cable loss} + \text{Antenna gain of substitution horn}.$
4. ERP can be calculated form EIRP by subtracting the gain of dipole, $ERP = EIPR - 2.15\text{dBi}.$
5. The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 1MHz/3MHz.

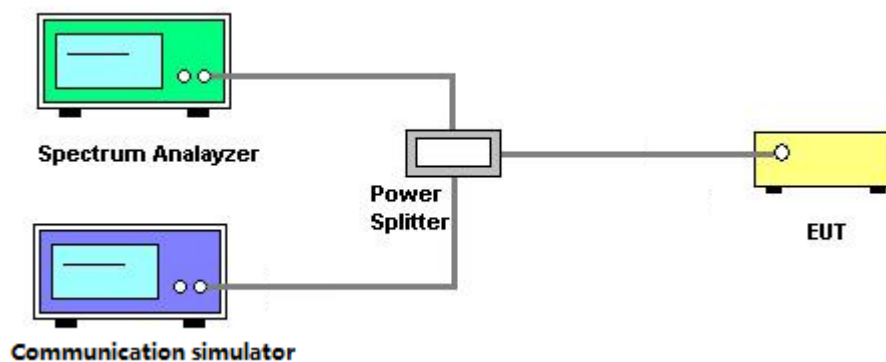

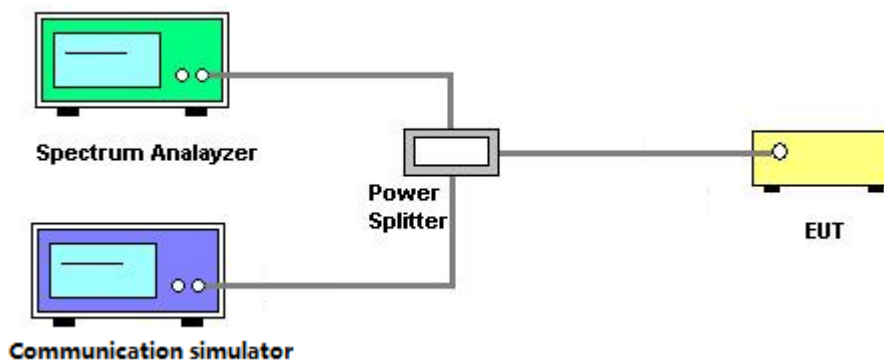

2. Set the number of counts to a value that stabilizes the measured CCDF curve;
3. Record the maximum PAPR level associated with a probability of 0.1%.

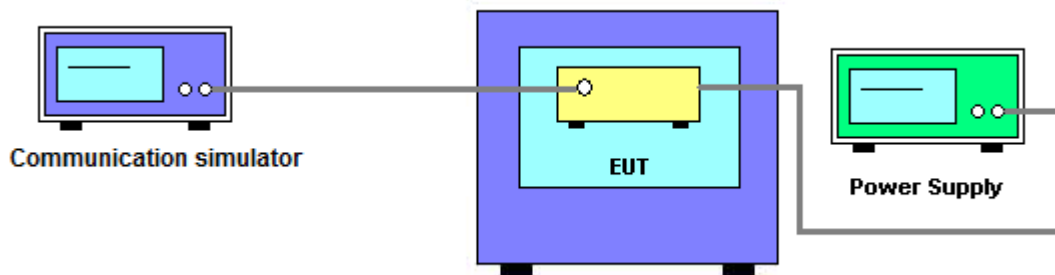

10.2 TEST PROCEDURES

The testing follows FCC KDB 971168 v03r01 Section 9.

1. Device is placed at the oven room. The oven room could control the temperatures and humidity. Power warm up is at least 15 min and power applied should perform before recording frequency error.
2. EUT is connected the external power supply to control the DC input power. The test voltage range is from minimum to maximum working voltage. Each step shall be record the frequency error rate.
3. The temperature range step is 10 degrees in this test items. All temperature levels shall be hold the $\pm 0.5^{\circ}\text{C}$ during the measurement testing. The each temperature step shall be at least 0.5 hours, consider the EUT could be test under the stability condition.
4. The frequency error was recorded frequency error from the communication simulator.
