





Fig.3 Configuration 1: remove the watchband and make the watch's back touch against the flat phantom






Fig.4 Configuration 2: remove the watchband and make the watch's back touch against the neck phantom area






Fig.5 Configuration 3: remove the one side's watchband and make the watch's back touch against the neck phantom area






Fig.6 EUT




Fig.7 Antenna location
