2. Connect the charger to a USB power source. The red indicator light will display during charging. If charging does not start, disconnect the charger plug it in again, and retry. Charging the battery fully may take hours.
3. When the battery is fully charged, the red indicator light

will turn off. Disconnect the charger from the USB power source and the Speaker. The fully charged battery has power for hours of music time.


