
- The Saygus VSquared

- Stereo Earbuds


If one or more of the items in this list is missing from the box when you first open it, please contact the shop where you bought your phone











Phone Services Activation

Access the SIM card slots by removing the back cover.

To open the back cover pull it from the bottom first.

There are two micro SIM card slots, so you may insert one or two SIM cards.

Reboot the VSquared to initialize the newly inserted SIM card(s)

For phone service that does not use a SIM card, your service provider will require the IMEI code from this VSquared device.

Power On the Phone

To start the VSquared press and hold down the power button for 1 second. The Saygus logo will appear while the phone is starting up.

To shut down or restart the VSquared, press and hold the power button for 1 second. The available options will appear on screen for your selection? to cancel, tap the screen anywhere else away from the options

Fingerprint Unlock

The Saygus VSquared provides an easy, secure, and quick way to unlock your device via fingerprint identification.

- Enable screen lock from Settings -> Security -> Screen lock, or go to Settings -> Fingerprint
- 2. Choose/Create a screen lock as required.
- 3. Enroll a fingerprint according to the onscreen guide.
- 4. Enable "Fingerprint to unlock".

Universal Remote

For convenience, you can use the infrared learning function to control most of your audio and video equipment.

- From the Home screen or the All Apps menu, touch the "Remote" app icon.
- Create a new remote and open the edit mode. (The green circles indicate remote buttons that have not been assigned any commands yet)
- 3. Select a button and an onscreen guide will guide you through the recording process.

Additional Information

The highest SAR value for this (SG02) mobile phone when tested at the ear is 0.52 W/kg, when properly worn on the body is 1.45 W/kg. SAR is measured aganist head and with the device at a separation of 10mm to the body, while transmitting at the highest certified output power level in all frequency bands of the mobile device.
