





Cover Off - Top View (charging base)


Mainboard – Rear View(charging base)


Conducted Emissions Test Setup – Front View(With Direct Charging Mode)








Radiated Emissions Test Setup Below 1GHz(With Direct Charging Mode)






Block Configuration Diagram for Conducted Emissions (With Direct Charging Mode)




Block Configuration Diagram for Conducted Emissions (With Charging base Mode)
