To turn the lamp on:

- 1. Connect the power adapter in the rear of the lamp. This power unit is intended to be correctly orientated in a vertical or floor mount position.
- 2. Touch On/Off to turn on the lamp.



- 3. Touch or slide finger up and down on control panel to adjust brightness.
- 4. Tap "M" to switch between 3 modes: Warm, Bright, Natural light.
- 5. Tap On/Off to turn off.

USB Port Specifications:

The USB Ports are capable of charging most phones, iPads and small tablets. Requires USB cable to charge (not included).

Bluetooth function:



1. Long press the key to enable the power of Bluetooth function. The phone who has connected before will be connected automatically.

2. Long press the key to clock the power of Bluetooth function.



- 1. Long press: last song
- 2. Short press: lower the voice



1. Long press: next song

2. Short press: higher the voice



1. Long press: Disconnect the Bluetooth.

2. Short press: Pause
