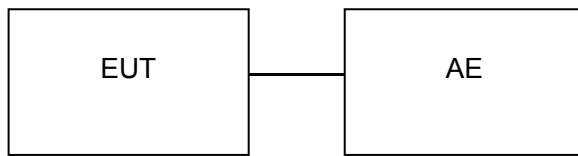

Test_Graph_LE1M_ANT1_2402_1Mbps_Peak Power

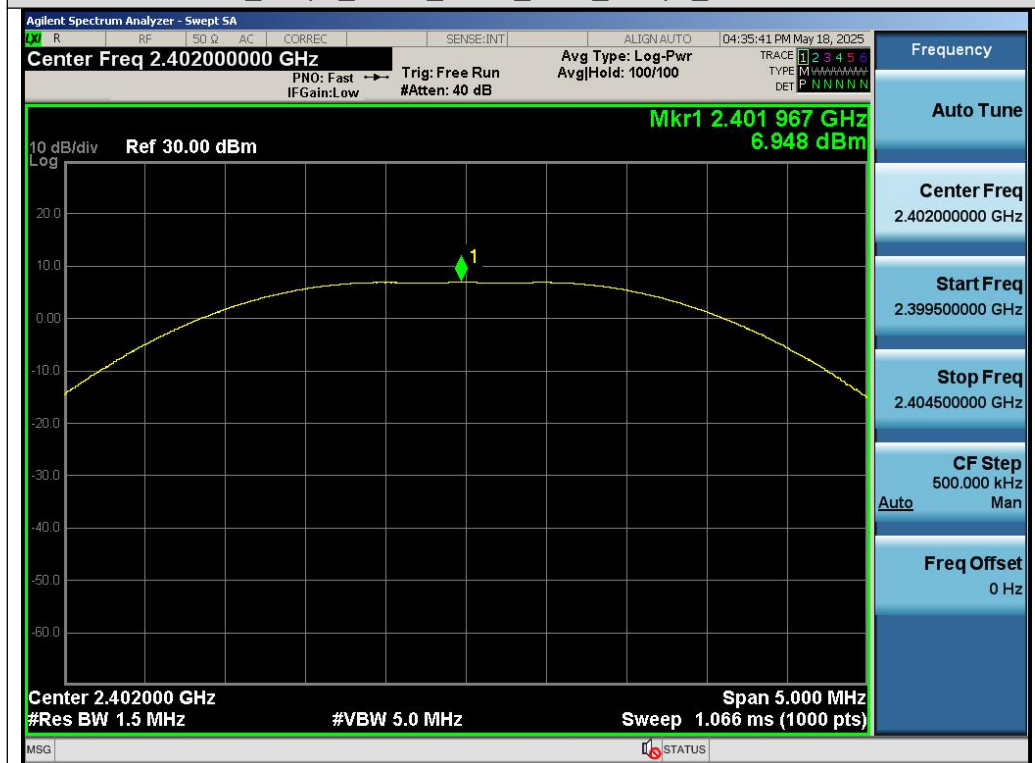

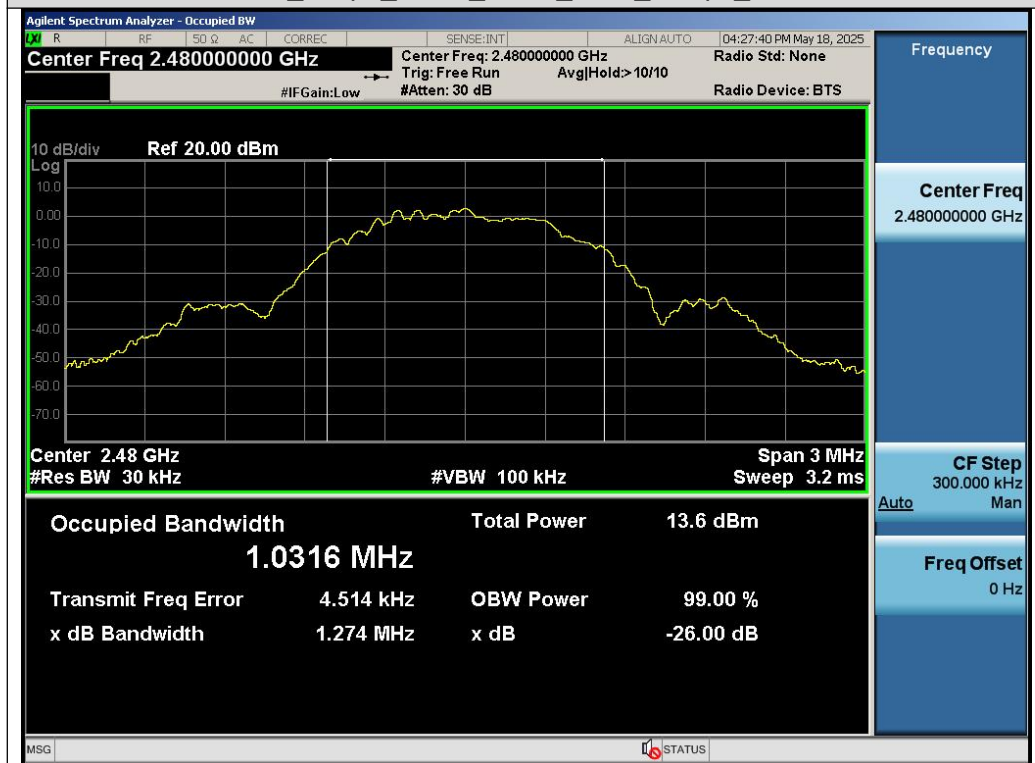
Test Graphs of Occupied Bandwidth

Test_Graph_LE1M_ANT1_2440_1Mbps_OBW

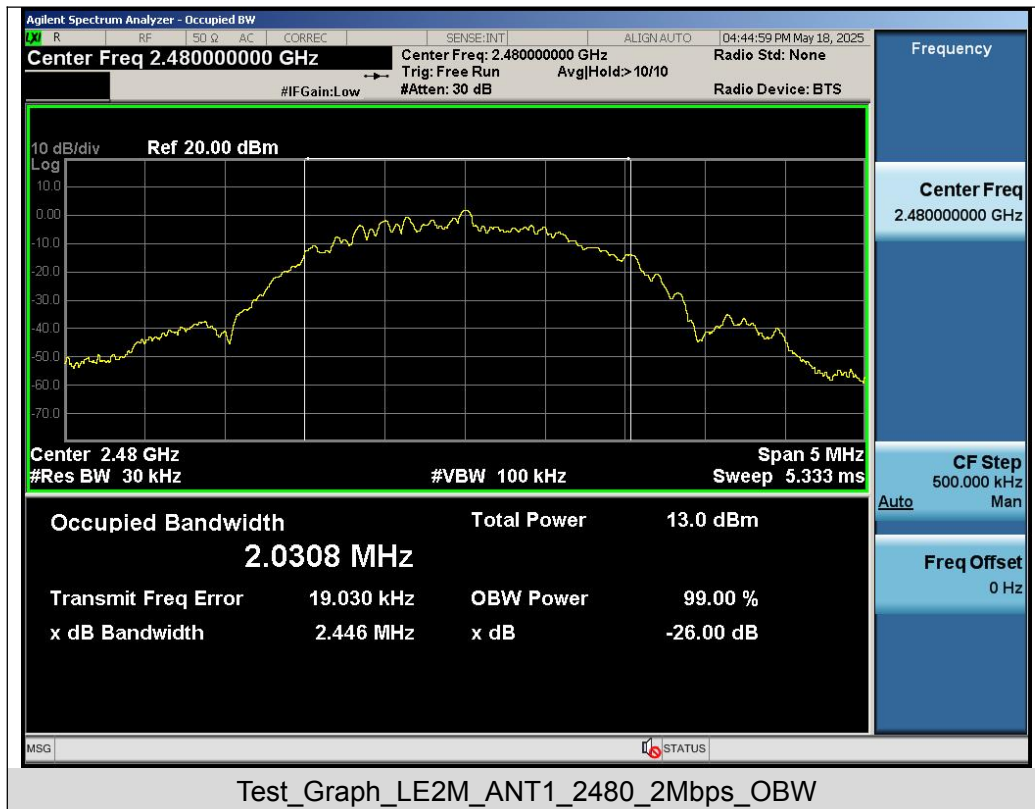

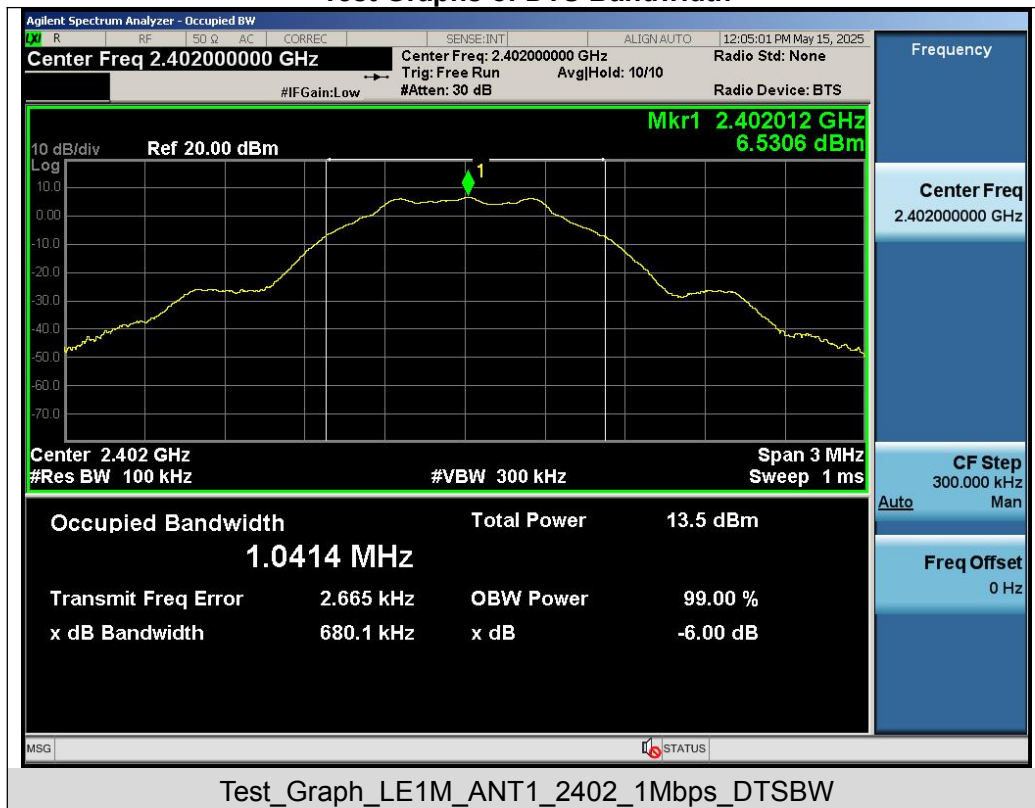

Test Graphs of DTS Bandwidth

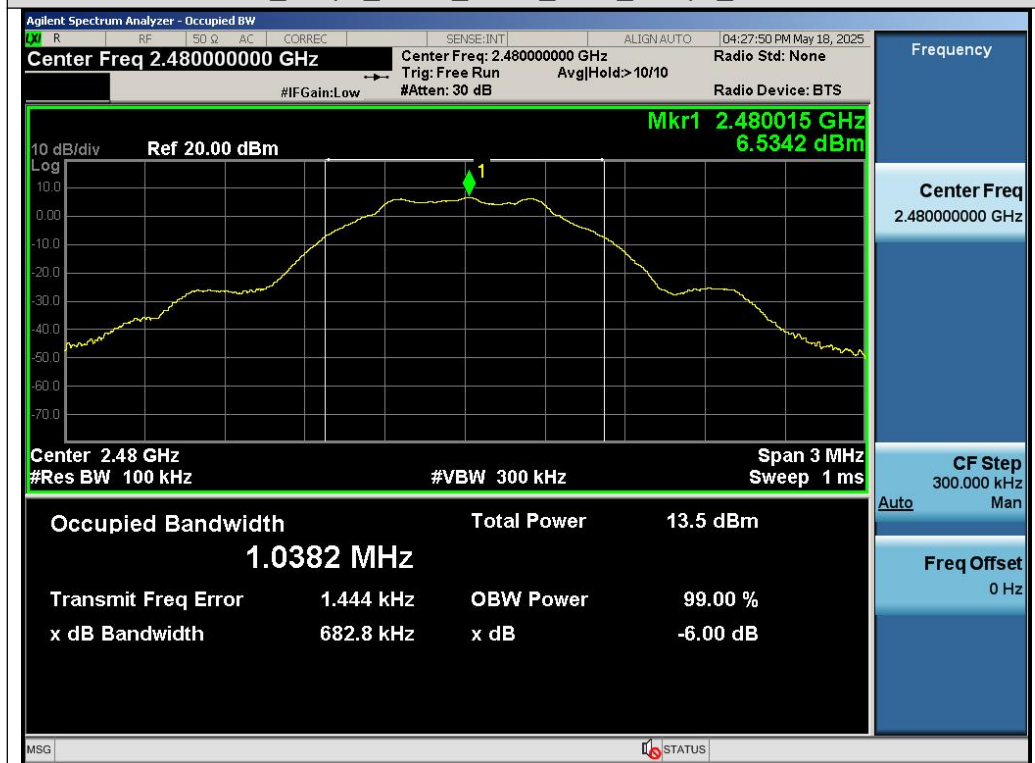

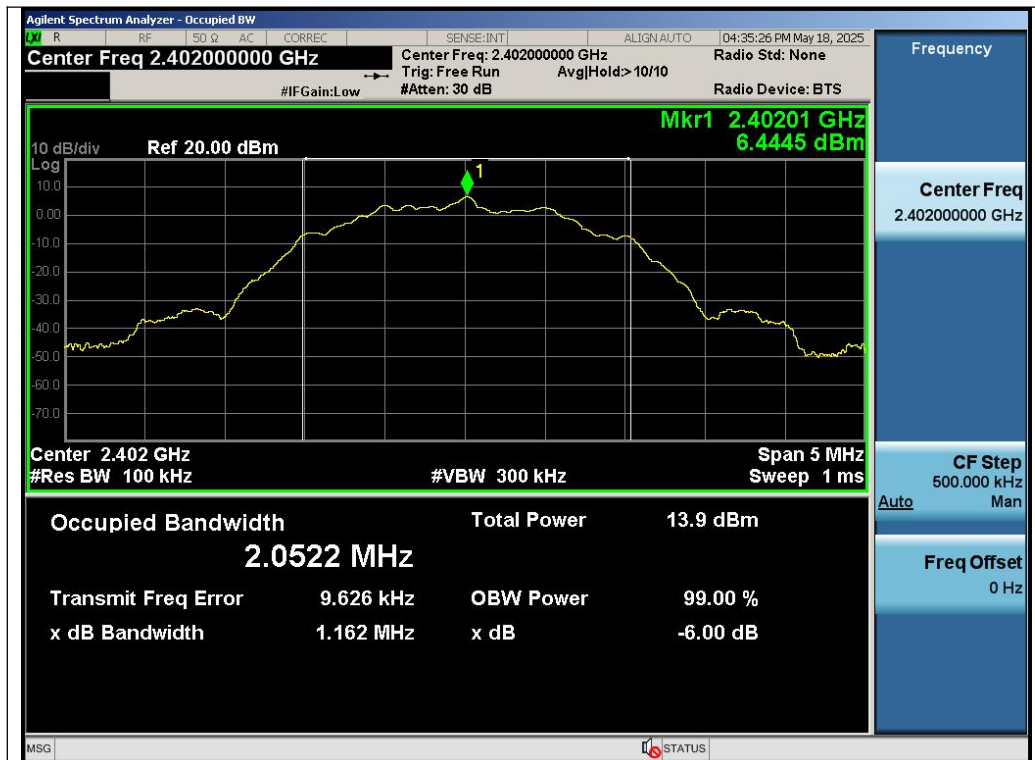


Test_Graph_LE1M_ANT1_2440_1Mbps_DTSBW

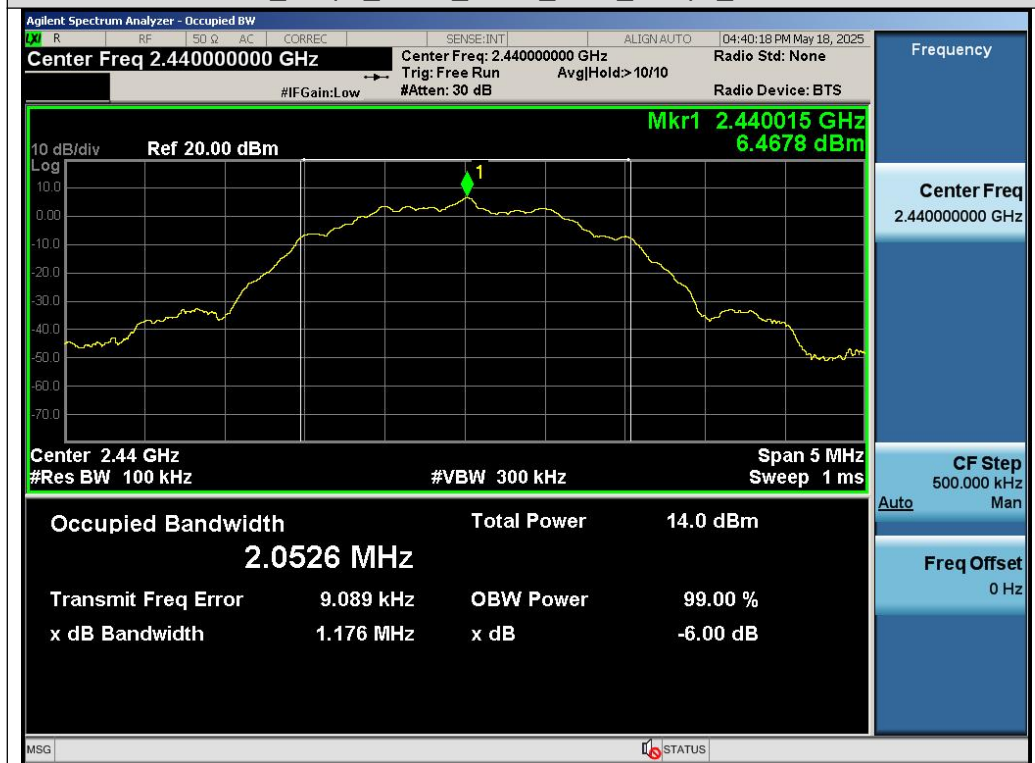

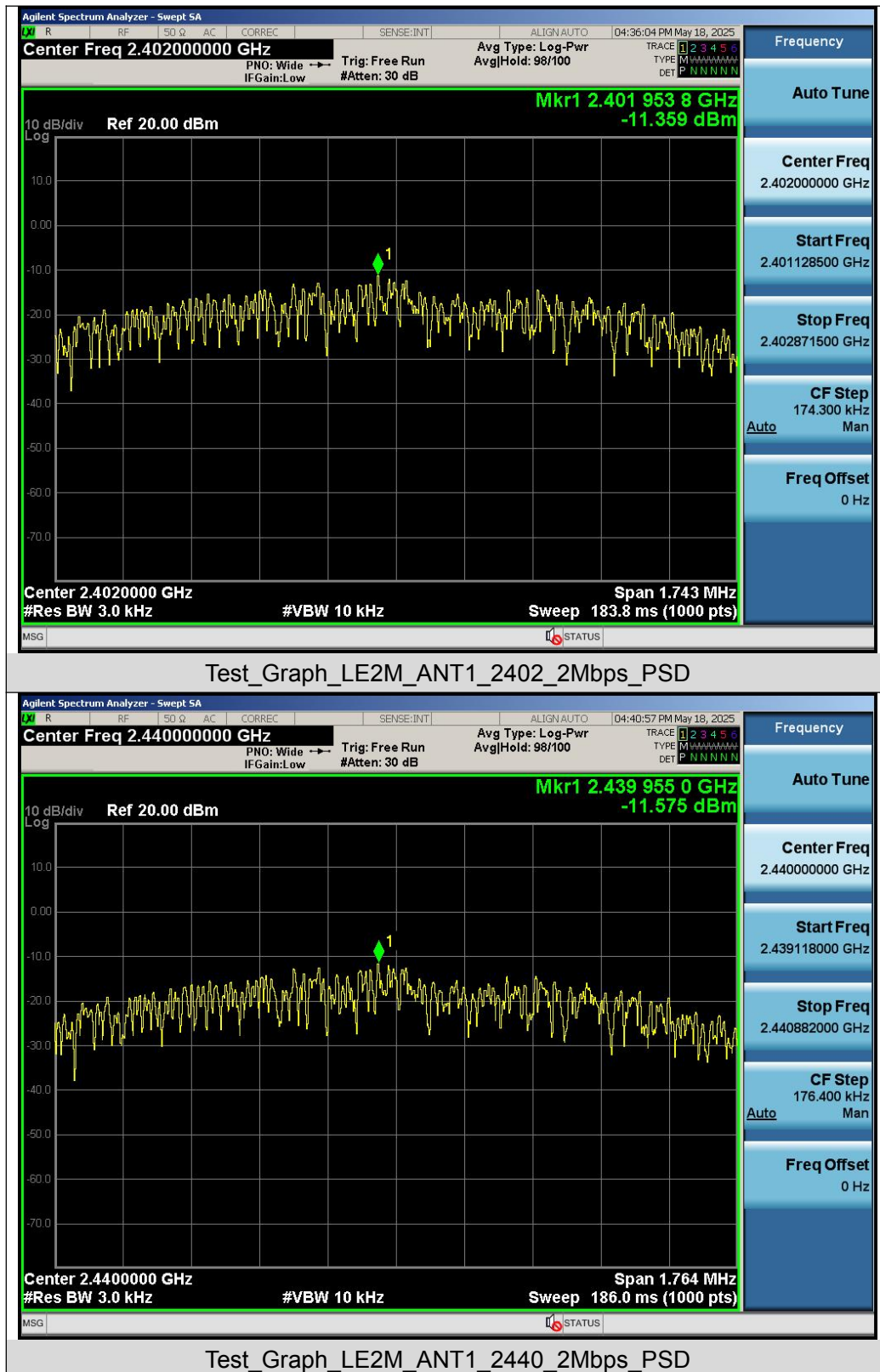
Test Graphs of Conducted Output Power Spectral Density



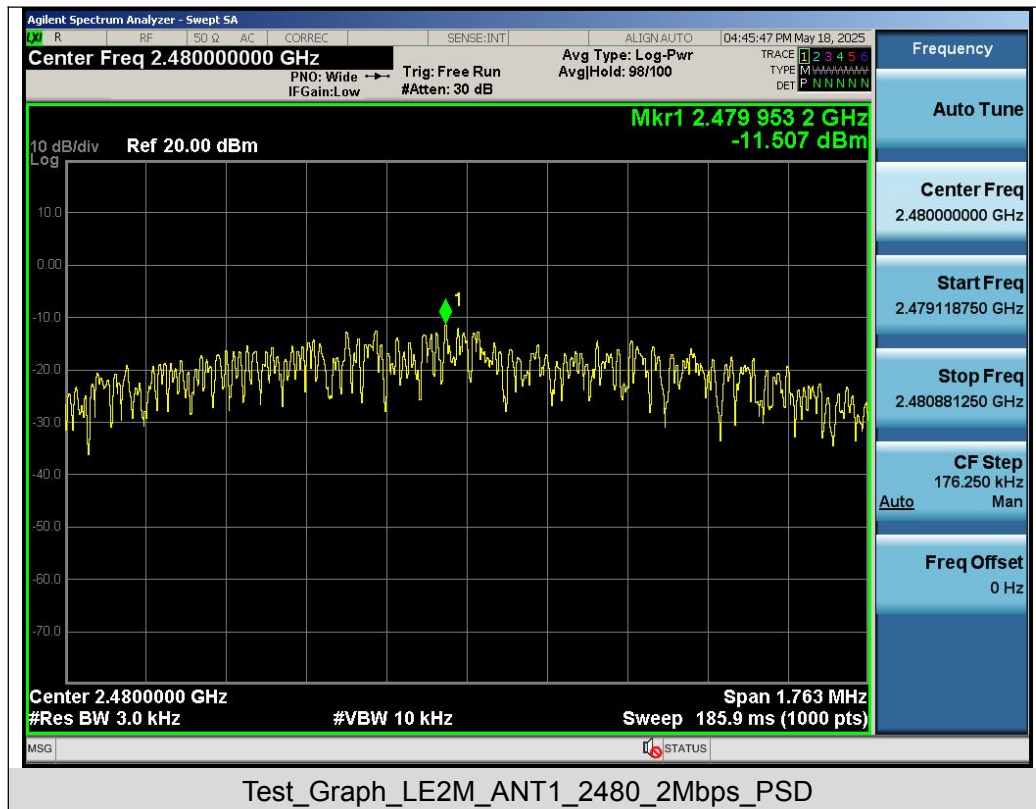

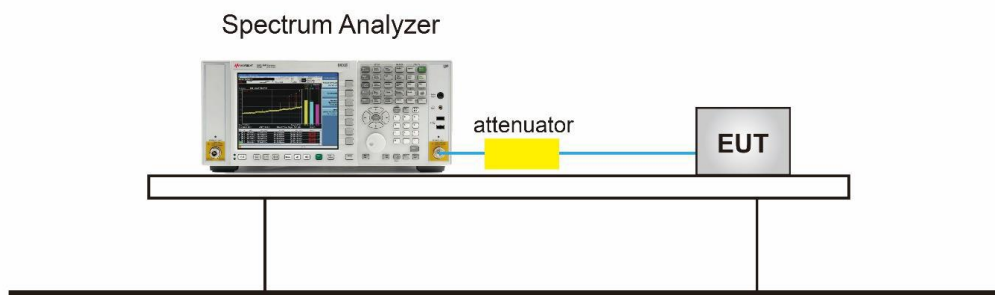

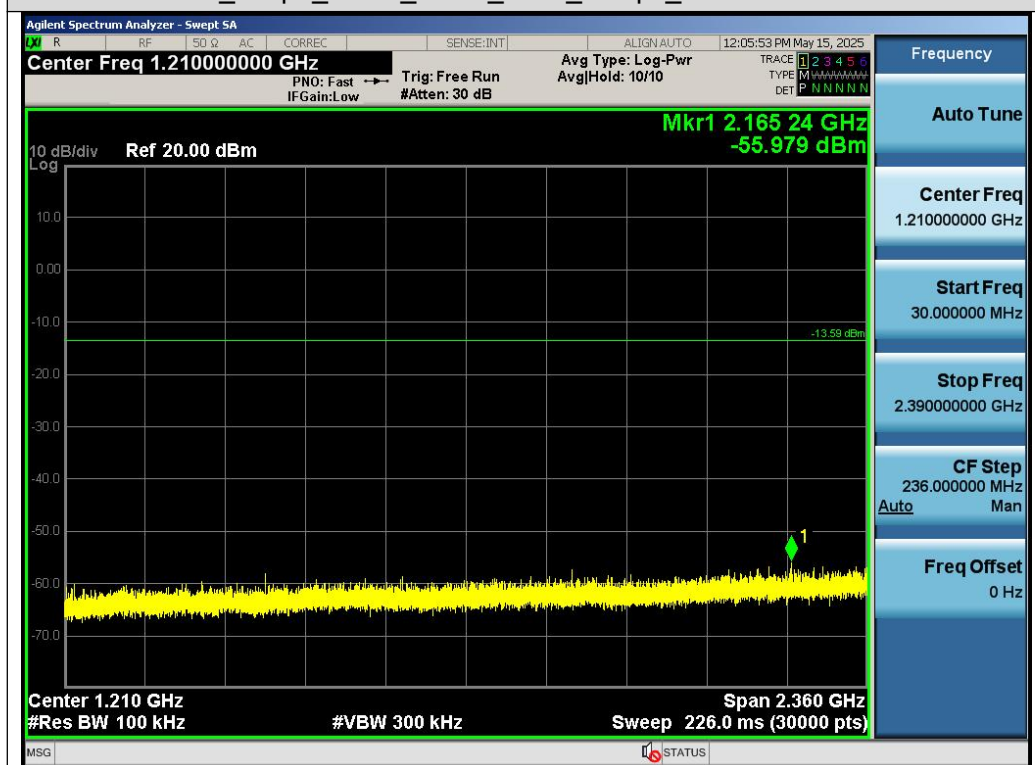

Test Graphs of Spurious Emissions in Non-Restricted Frequency Bands

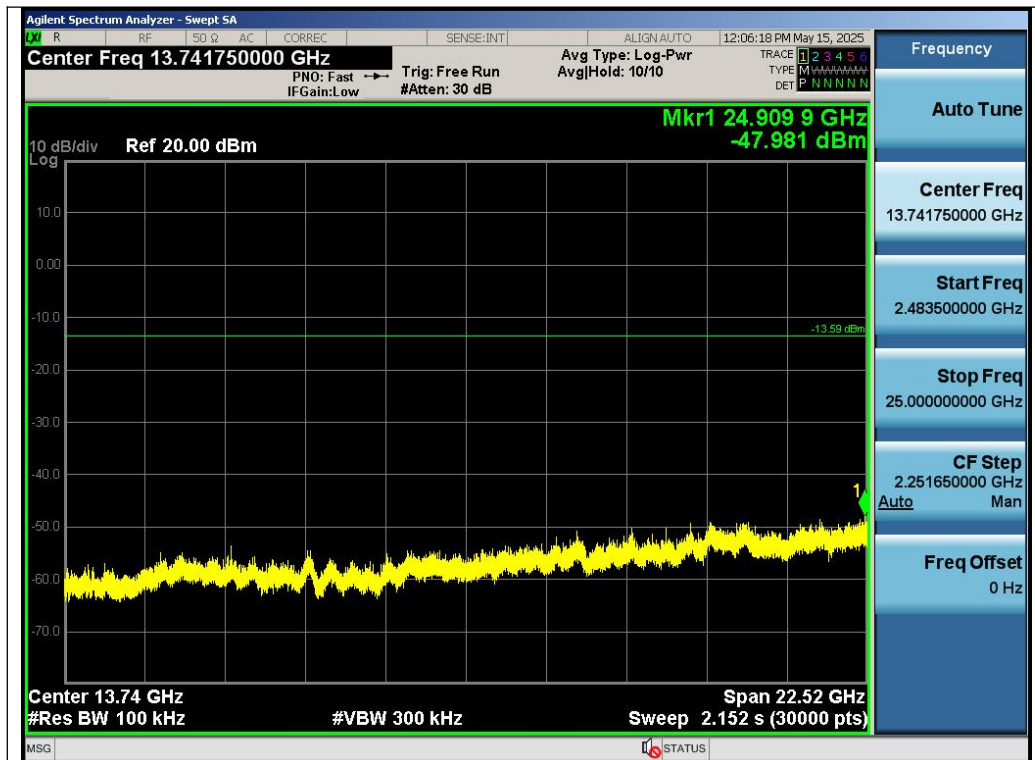

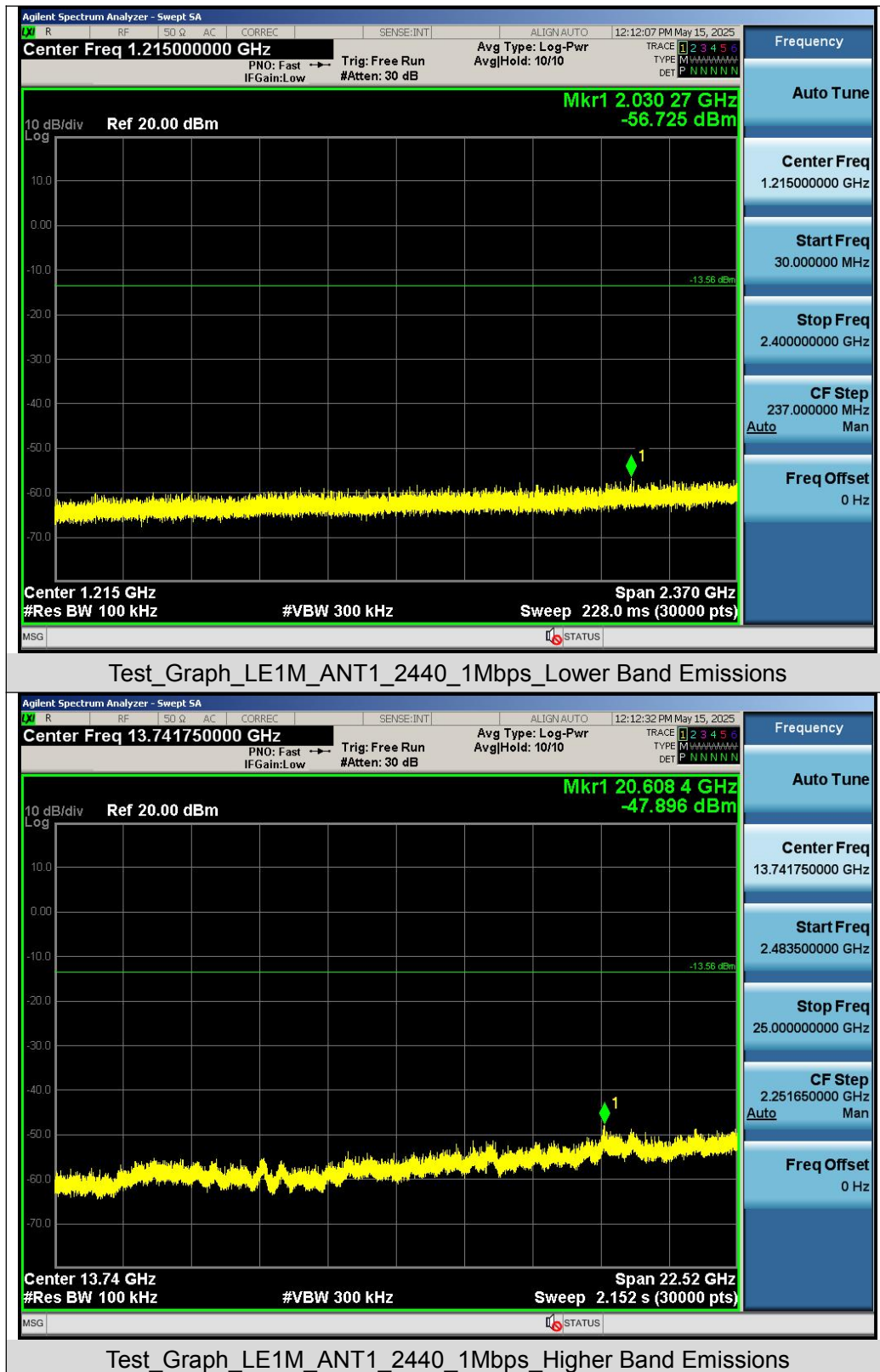


Test_Graph_LE1M_ANT1_2402_1Mbps_Higher Band Emissions

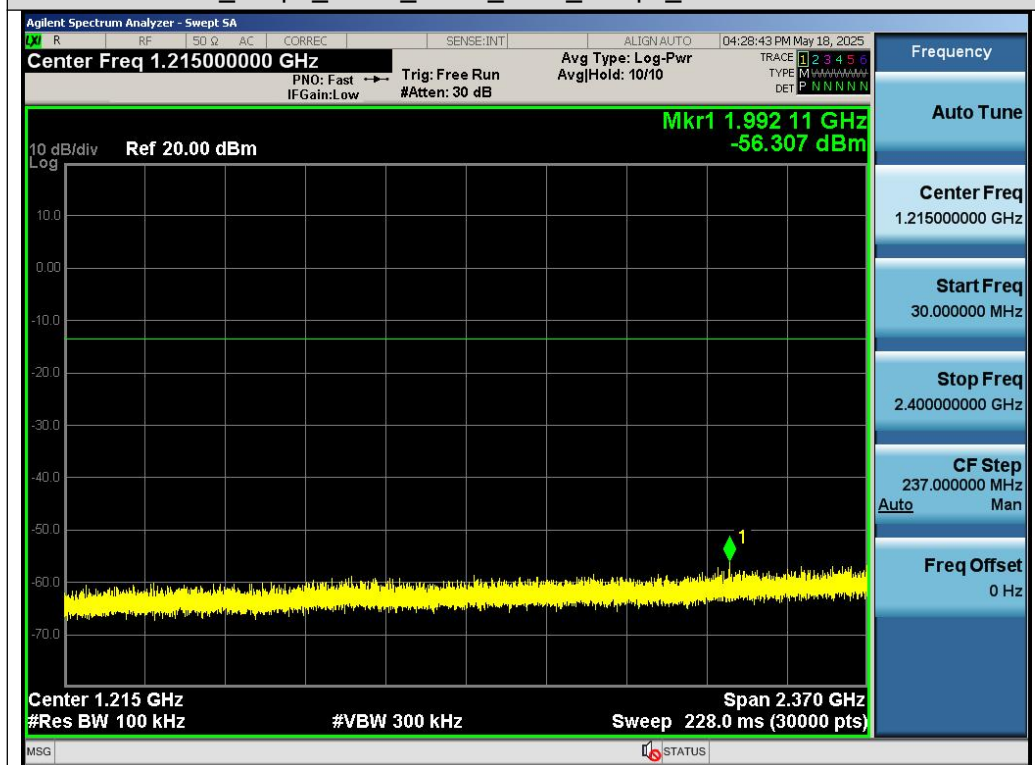

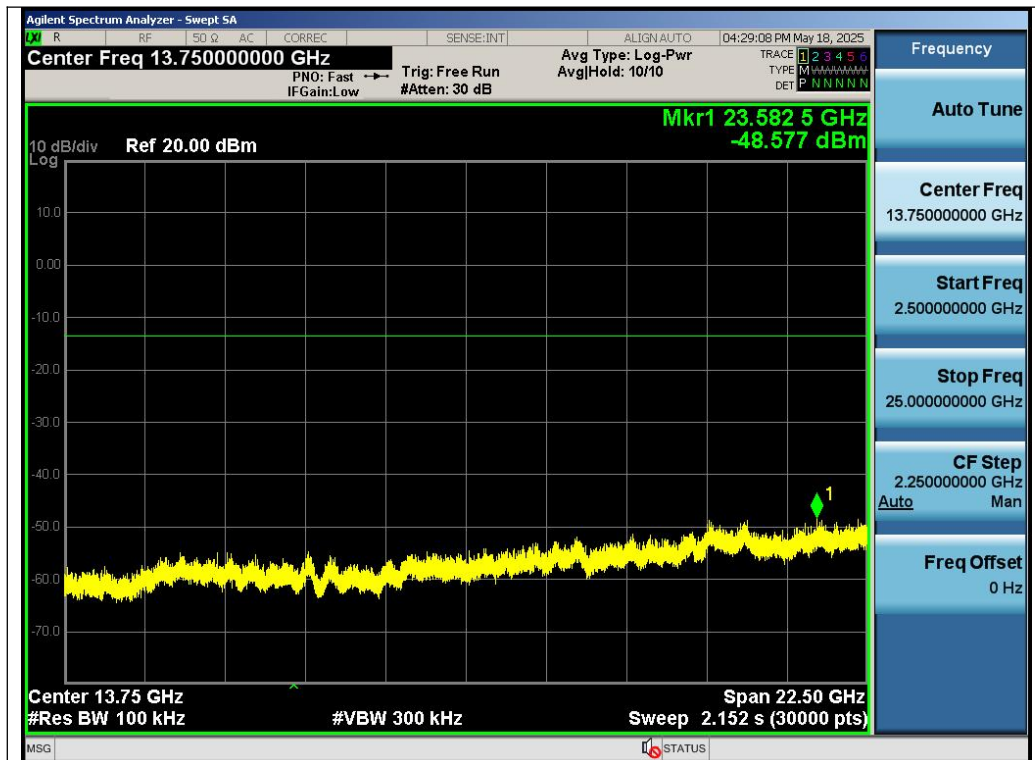


Test_Graph_LE1M_ANT1_2480_1Mbps_Reference Level

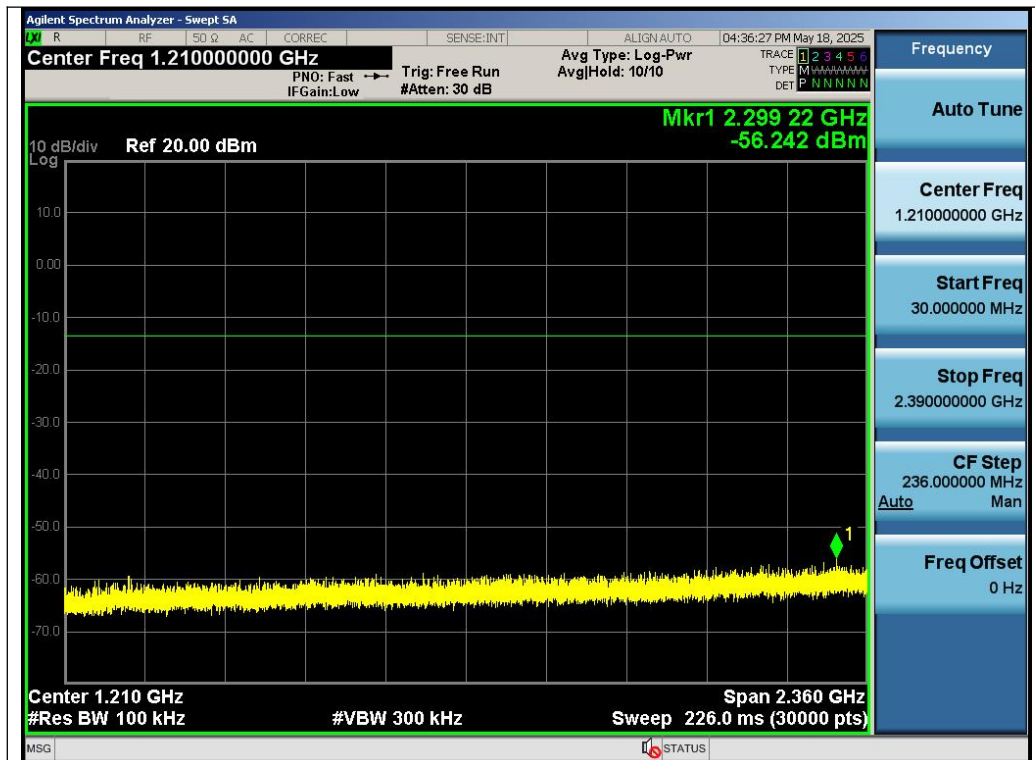


Test_Graph_LE1M_ANT1_2480_1Mbps_Higher Band Emissions

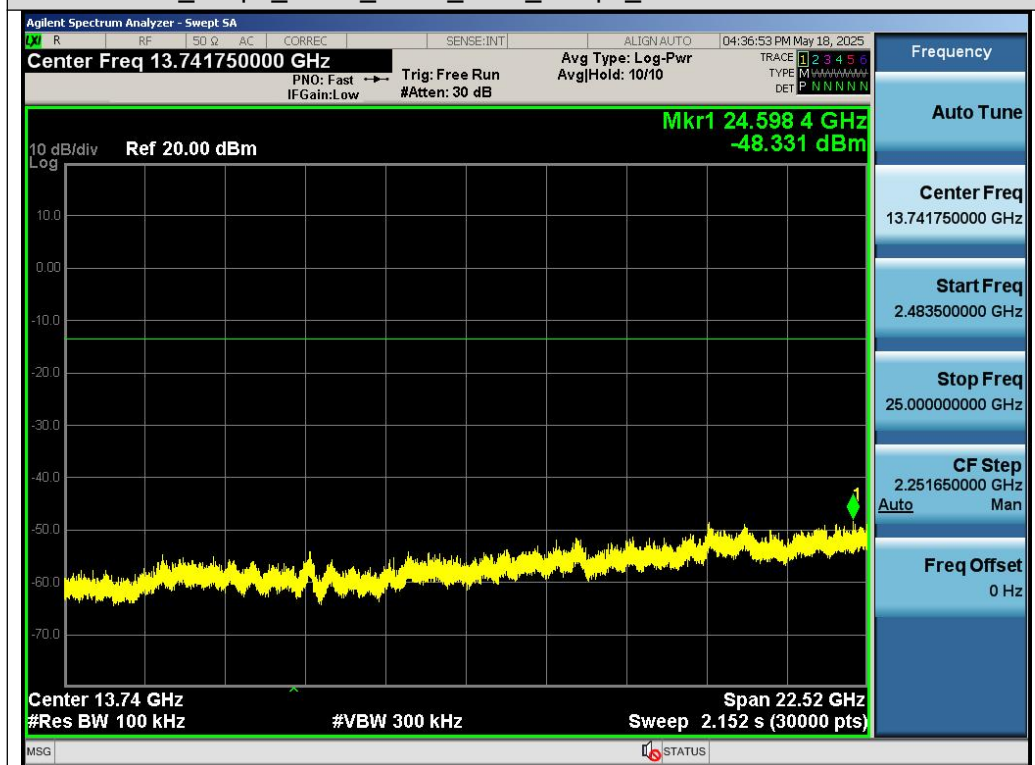
