VentGuard™ Breathers

Check-valves on the bottom of the unit isolate the system until equipment needs to breathe. As air is drawn into equipment through the breather, the layered filter elements remove particulate while the desiccant beads strip harmful moisture. While in service or during shutdown, the desiccant beads attract moisture from inside the equipment reservoir, actively drying the equipment.



Product Installation

Module Installation:

- Install batteries in module by removing screws, inserting three AAA batteries and reinstalling the screws.
- 2. Push button on front of module to ensure indicator lights illuminate. If battery indicator light illuminates, the module is properly assembled. If lights do not illuminate, remove cover to check if batteries are installed in the correct direction and/or the module cover is installed in the correct position.
- 3. Align module with clips on side of breather
- 4. Pull down on module until secure



Replacement Breather Cartridges

Order replacement breather cartridges through your Des-Case sales representative. Replacements are sold in cases of six.

DO NOT DISCARD THE MODULE.

The module remains with the asset and does not need replaced each time a new breather cartridge is installed.

Change Asset Name

Change the name of your asset in the Des-Case App.

Remove Assets from List

On the Asset page in the Des-Case Web Portal, select "Remove" near the asset to delete. Consider downloading the asset data CVS file prior to removing the asset from your account.

To remove from mobile devices, swipe left (delete).

If an asset is unintentionally removed, it can be restored by synchronizing the module using the Des-Case App.

Multiple Users

Multiple email addresses can access data from the same breathers/modules if both accounts sync their devices with the module.

TROUBLESHOOTING AND FAQ (cont.)

Disposal

Never dispose of breather or module in fire. Dispose of breather cartridge, module and batteries in accordance with local regulations.

Updating the App

Updates are available in iOS and Android app stores.

LED Indicator Lights

- Flashing Lights (Remaining battery life has reached 10-0%; Remaining breather life has reached 0%)
- Lights are Not Illuminating (Batteries are fully drained)

App is Not Connecting to Module

Possible causes include:

- Out of range (100 feet)
- Bluetooth connection is disabled
- Batteries are fully drained

Data is Not Syncing

Possible causes include:

- Loss of internet connection
- Firewall or other security issue

Why Isn't the Breather Blue?

We have eliminated the opportunity for subjectivity be removing the color indicator. With the internal sensors, users now have a digital reading of the breather's remaining life.

Breather Life

The replacement cartridge life differs depending on the asset, application and size of the breather. Our experts will work with users to select the appropriate size breather just as we currently do. Today, we expect most breathers to perform for at least 9-12 months.

Battery Life

In normal operating conditions, the expected battery life for the three AAA batteries in the module is two years.

Do I Need Wireless Internet?

Wireless internet is not required to download data with the app. Internet is required to upload data to the website.

Bluetooth Range

The range for best use of the product is 100 feet.

Humidity and High Temperature Environments

Battery life could be shortened in high or low temperature environments.
