① Connect the power adapter to socket.

Connect adapter to the USB 2.0 interface, the other Micro USB to charging stand.

② Connect the USB 2.0 interface into laptop USB port, the other Micro USB to charging stand.

After power on, both blue and green indicator light on after 5s at the same time and then enter into standby mode.

③ Connect the USB 2.0 interface into desktop motherboard USB port, the other Micro USB to charging stand.
