Disclosure of this confidential information would provide valuable insight into the technical design and engineering know-how of CellGain Wireless, LLC., placing the company at a significant competitive disadvantage.

This confidential information constitutes trade secrets that give CellGain Wireless, LLC. a competitive edge in the marketplace and will only be shared with regulatory authorities or partners under strict confidentiality agreements when necessary.
