






- 1. Echelon® Reflect Fitness Mirror 2. Wood screw (2)

- 4. M8 washer (4)

- 4. Toggle bolt anchor (4) 5. Washer (6)

## **INSTALLING THE MOUNT**

The Echelon® Reflect is required to be mounted directly to a wall stud or suitable floor stand.


NOTE: Standard installation height is 69" to the top of the wall mount.



1. Locate stud within the wall you intend to hang your Reflect on and mark with a pencil. Level and tape up the wall mount




2. Mark all six holes. Using a 1/8" drill bit, drill the two pilot holes for the wood screws. Using a 5/8" drill bit, drill the holes for the toggle bolts.




template with the middle two

holes centered over stud.


3. Place the bolts with washer through the wall mount and attach the toggles to bolt as shown above.




4. Push all toggle bolts into drywall and tighten down. Make sure the two center drill holes are visible and the bracket is level.



5. Drive in the wood screws with washers into predrilled holes.



6. Place the Reflect onto the wall mount as shown above.



7. Using a Philips screwdriver, drive in the screw located above bracket to secure.


The Reflect may also be attached to a 200 x 200mm VESA mount stand.



## **TURNING ON THE REFLECT**

TO TURN ON THE REFLECT, FLIP THE SWITCH ON THE BACK OF THE REFLECT TO THE RIGHT THEN TOUCH THE ECHELON® LOGO ON THE FRONT. THE LOGO WILL TURN BLUE WHEN PRESSED. (SHOWN BELOW)





## **TURNING OFF THE REFLECT**

TO TURN OFF THE REFLECT, PRESS AND HOLD THE ECHELON® LOGO FOR SIX SECONDS. (SHOWN BELOW)



## **ACCOUNT SETUP**

Go to **member.echelonfit.com** and follow the onscreen instructions to choose a plan and setup your account. This info will be needed to login to your account after connecting to your Reflect to WiFi. If you purchased Reflect on our website, you will receive an email with a link to activate your account.

All account info and plans are managed at member. echelonfit.com and use the same login. After creating your account login on member.echelonfit.com, write down your login info. This will be the same login for the Reflect.

## **CONNECTING YOUR REFLECT TO WIFI**

- 1. On initial startup, the Reflect will bring up the WiFi menu.
- 2. Once connected, you will see your network name on the screen and you will then need to type in your network password.
  - 2b. If the Reflect doesn't connect after 20 seconds, the connection attempt will time out. Repeat Step 2.
- 3. If the connection is successful, the Reflect will show the login screen.

## **CONNECTING YOUR HEART RATE MONITOR**

- 1. If using the chest strap heart rate monitor, the Reflect will automatically sync to it when you press the heart monitor icon underneath the "Start Workout" button or when you join a class. Please follow the instructions for proper use of the chest strap heart rate monitor.
- 2. If using the armband heart rate monitor, press the Bluetooth connection button on your heart rate monitor. Press the heart monitor icon underneath the "Start Workout" button or after joining a class and it will automatically sync to Reflect.

## CONNECTING BLUETOOTH HEADPHONES

- 1. Make sure your headphones are in pairing mode.
- 2. Press the headphones icon underneath the "Start Workout" button or while in the class to pair.


