2.2 Test Mode

a. The EUT has been associated with peripherals and configuration operated in a manner tended to maximize its emission characteristics in a typical application. Frequency range investigated: conduction emission (150 kHz to 30 MHz), radiation emission (9 kHz to the 10th harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower). For radiated measurement, pre-scanned in three orthogonal panels, X, Y, Z. The worst cases (X plane) were recorded in this report, and the worst mode of radiated spurious emissions is Bluetooth 1Mbps mode, and recorded in this report.





2.5 EUT Operation Test Setup

The RF test items, utility "CMD" was installed in Notebook which was programmed in order to make the EUT get into the engineering modes to provide channel selection, power level, data rate and the application type and for continuous transmitting signals.

2.6 Measurement Results Explanation Example

For all conducted test items:

The offset level is set in the spectrum analyzer to compensate the RF cable loss and attenuator factor between EUT conducted output port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly the EUT RF output level.

Example:

The spectrum analyzer offset is derived from RF cable loss and attenuator factor.

Offset = RF cable loss + attenuator factor.

Following shows an offset computation example with cable loss 4.2 dB and 10dB attenuator.

Offset(dB) = RF cable loss(dB) + attenuator factor(dB). = 4.2 + 10 = 14.2 (dB)







Channel Separation Plot on Channel 00 - 01








Channel Separation Plot on Channel 00 - 01


Channel Separation Plot on Channel 39 - 40




Channel Separation Plot on Channel 00 - 01


Channel Separation Plot on Channel 00 - 01


Channel Separation Plot on Channel 39 - 40




Channel Separation Plot on Channel 00 - 01


Channel Separation Plot on Channel 39 - 40






Package Transfer Time Plot


Hopping Mode Low Band Edge Plot
