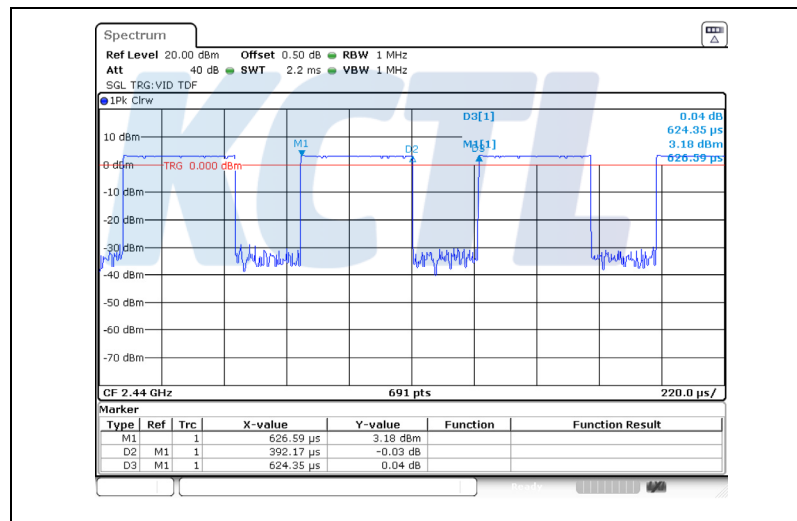

3. Antenna requirement

Requirement of FCC part section 15.203:

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section.

- The transmitter has permanently attached Pattern Antenna (internal antenna) on board.

Requirement of RSS-Gen Section 6.8:

The applicant for equipment certification shall provide a list of all antenna types that may be used with the transmitter, where applicable (i.e. for transmitters with detachable antenna), indicating the maximum permissible antenna gain (in dBi) and the required impedance for each antenna. The test report shall demonstrate the compliance of the transmitter with the limit for maximum equivalent isotropically radiated power (e.i.r.p.) specified in the applicable RSS, when the transmitter is equipped with any antenna type, selected from this list.

For expediting the testing, measurements may be performed using only the antenna with highest gain of each combination of transmitter and antenna type, with the transmitter output power set at the maximum level. However, the transmitter shall comply with the applicable requirements under all operational conditions and when in combination with any type of antenna from the list provided in the test report (and in the notice to be included in the user manual, provided below).

When measurements at the antenna port are used to determine the RF output power, the effective gain of the device's antenna shall be stated, based on a measurement or on data from the antenna's manufacturer.

The test report shall state the RF power, output power setting and spurious emission measurements with each antenna type that is used with the transmitter being tested.

Immediately following the above notice, the manufacturer shall provide a list of all antenna types which can be used with the transmitter, indicating the maximum permissible antenna gain (in dBi) and the required impedance for each antenna type.

- All modes of operation and data rates were investigated. The test results shown in the following sections represent the worst case emissions.
- This test is not applicable because the EUT falls into the automotive device and it's not to be connected to the public utility(AC) power line.
- According to exploratory test no any obvious emission were detected from 9 kHz to 30 MHz. Although these tests were performed other than open field site, adequate comparison measurements were confirmed against 30 m open field site. Therefore sufficient tests were made to demonstrate that the alternative site produces results that correlate with the ones of tests made in an open field based on KDB 414788.
- The fundamental of the EUT was investigated in three orthogonal orientations X, Y and Z. It was determined that X orientation was worst-case orientation. Therefore, all final radiated testing was performed with the EUT in X orientation
- The test procedure(s) in this report were performed in accordance as following.
 - ANSI C63.10-2013
 - KDB 558074 D01 v05r02

5. Measurement uncertainty

The measurement uncertainties shown below were calculated in accordance with the requirements of ANSI C63.10-2013.

All measurement uncertainty values are shown with a coverage factor of $k=2$ to indicated a 95 % level of confidence. The measurement data shown herein meets or exceeds the U_{CISPR} measurement uncertainty values specified in CISPR 16-4-2 and thus, can be compared directly to specified limits to determine compliance.

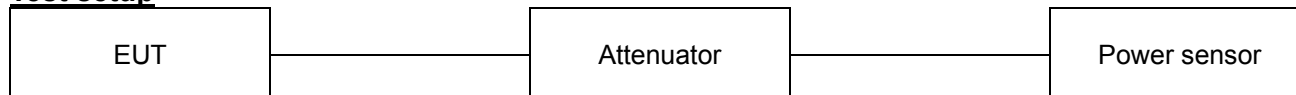

7. Test results

7.1. Maximum peak output power

Test setup



Limit

According to §15.247(b)(3), For systems using digital modulation in the 902-928 MHz, 2 400-2 483.5 MHz, and 5 725-5 850 MHz bands: 1 Watt. As an alternative to a peak power measurement, compliance with the one Watt limit can be based on a measurement of the maximum conducted output power. Maximum Conducted Output Power is defined as the total transmit power delivered to all antennas and antenna elements averaged across all symbols in the signaling alphabet when the transmitter is operating at its maximum power control level. Power must be summed across all antennas and antenna elements. The average must not include any time intervals during which the transmitter is off or is transmitting at a reduced power level. If multiple modes of operation are possible (e.g., alternative modulation methods), the maximum conducted output power is the highest total transmit power occurring in any mode.

According to §15.247(b)(4) The conducted output power limit specified in paragraph (b) of this section is based on the use of antennas with directional gains that do not exceed 6 dBi. Except as shown in paragraph (c) of this section, if transmitting antennas of directional gain greater than 6 dBi are used, the conducted output power from the intentional radiator shall be reduced below the stated values in paragraphs (b)(1), (b)(2), and (b)(3) of this section, as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

According to RSS-247(5.4), For systems using digital modulation in the 902-928 MHz, 2 400-2 483.5 MHz, and 5 725-5 850 MHz bands: 1 Watt. As an alternative to a peak power measurement, compliance with the one Watt limit can be based on a measurement of the maximum conducted output power. Maximum Conducted Output Power is defined as the total transmit power delivered to all antennas and antenna elements averaged across all symbols in the signaling alphabet when the transmitter is operating at its maximum power control level. Power must be summed across all antennas and antenna elements. The average must not include any time intervals during which the transmitter is off or is transmitting at a reduced power level. If multiple modes of operation are possible (e.g., alternative modulation methods), the maximum conducted output power is the highest total transmit power occurring in any mode.

According to RSS-247 5.4(d), For DTSSs employing digital modulation techniques operating in the bands 902-928 MHz and 2400-2483.5 MHz, the maximum peak conducted output power shall not exceed 1 W. The e.i.r.p. shall not exceed 4 W, except as provided in section 5.4(e).

Test procedure

ANSI C63.10 - Section 11.9

Used test method is section 11.9.1.3 and 11.9.2.3.1

Test settings

General

Section 15.247 permits the maximum conducted (average) output power to be measured as an alternative to the maximum peak conducted output power for demonstrating compliance to the limit. When this option is exercised, the measured power is to be referenced to the OBW rather than the DTS bandwidth (see ANSI C63.10 for measurement guidance).

When using a spectrum analyzer or EMI receiver to perform these measurements, it shall be capable of utilizing a number of measurement points in each sweep that is greater than or equal to twice the span/RBW to set a bin-to-bin spacing of $\leq \text{RBW}/2$ so that narrowband signals are not lost between frequency bins.

If possible, configure or modify the operation of the EUT so that it transmits continuously at its maximum power control level. The intent is to test at 100 % duty cycle; however a small reduction in duty cycle (to no lower than 98 %) is permitted, if required by the EUT for amplitude control purposes. Manufacturers are expected to provide software to the test lab to permit such continuous operation.

If continuous transmission (or at least 98 % duty cycle) cannot be achieved due to hardware limitations (e.g., overheating), the EUT shall be operated at its maximum power control level, with the transmit duration as long as possible, and the duty cycle as high as possible during which sweep triggering/signal gating techniques may be used to perform the measurement over the transmission duration.

11.9.1. Maximum peak conducted output power

One of the following procedures may be used to determine the maximum peak conducted output power of a DTS EUT.

11.9.1.1. RBW $\geq$ DTS bandwidth

The following procedure shall be used when an instrument with a resolution bandwidth that is greater than the DTS bandwidth is available to perform the measurement:

- a) Set the RBW $\geq$ DTS bandwidth.
- b) Set VBW $\geq [3 \times \text{RBW}]$.
- c) Set span $\geq [3 \times \text{RBW}]$.
- d) Sweep time = auto couple.
- e) Detector = peak.
- f) Trace mode = max hold.
- g) Allow trace to fully stabilize.
- h) Use peak marker function to determine the peak amplitude level.

11.9.1.3. PKPM1 Peak power meter method

The maximum peak conducted output power may be measured using a broadband peak RF power meter. The power meter shall have a video bandwidth that is greater than or equal to the DTS bandwidth and shall use a fast-responding diode detector.

11.9.2.3.1. Measurement using a power meter (PM)

Method AVGPM is a measurement using an RF average power meter, as follows:

- a) As an alternative to spectrum analyzer or EMI receiver measurements, measurements may be performed using a wideband RF power meter with a thermocouple detector or equivalent if all of the conditions listed below are satisfied:
 - 1) The EUT is configured to transmit continuously, or to transmit with a constant duty cycle.
 - 2) At all times when the EUT is transmitting, it shall be transmitting at its maximum power control level.
 - 3) The integration period of the power meter exceeds the repetition period of the transmitted signal by at least a factor of five.
- b) If the transmitter does not transmit continuously, measure the duty cycle, D, of the transmitter output signal as described in 11.6.
- c) Measure the average power of the transmitter. This measurement is an average over both the ON and OFF periods of the transmitter.
- d) Adjust the measurement in dBm by adding $[10 \log(1/D)]$, where D is the duty cycle

Notes:

1. A peak responding power sensor is used, where the power sensor system video bandwidth is greater than the occupied bandwidth of the EUT.

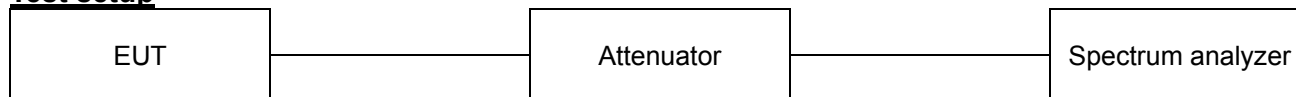

7.2. Peak Power Spectral Density

Test setup



Limit

According to §15.247(e), for digitally modulated systems, the power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission. This power spectral density shall be determined in accordance with the provisions of paragraph (b) of this section. The same method of determining the conducted output power shall be used to determine the power spectral density.

According to RSS-247(5.2), For digitally modulated systems, the power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission. This power spectral density shall be determined in accordance with the provisions of paragraph (b) of this section. The same method of determining the conducted output power shall be used to determine the power spectral density.

Test procedure

ANSI C63.10 - Section 11.10

Test settings

Method PKPSD (peak PSD)

The following procedure shall be used if maximum peak conducted output power was used to determine compliance, and it is optional if the maximum conducted (average) output power was used to determine compliance:

- 1) Set analyzer center frequency to DTS channel center frequency.
- 2) Set the span to 1.5 times the DTS bandwidth.
- 3) Set the RBW to: $3 \text{ kHz} \leq \text{RBW} \leq 100 \text{ kHz}$.
- 4) Set the VBW $\geq 3 \times \text{RBW}$.
- 5) Detector = peak.
- 6) Sweep time = auto couple.
- 7) Trace mode = max hold.
- 8) Allow trace to fully stabilize.
- 9) Use the peak marker function to determine the maximum amplitude level within the RBW.
- 10) If measured value exceeds limit, reduce RBW (no less than 3 kHz) and repeat.

DTS bandwidth

One of the following procedures may be used to determine the modulated DTS bandwidth.

Option 1

- 1) Set RBW = 100 kHz.
- 2) Set the video bandwidth (VBW) $\geq 3 \times$ RBW.
- 3) Detector = Peak.
- 4) Trace mode = max hold.
- 5) Sweep = auto couple.
- 6) Allow the trace to stabilize.
- 7) Measure the maximum width of the emission that is constrained by the frequencies associated with the two outermost amplitude points (upper and lower frequencies) that are attenuated by 6 dB relative to the maximum level measured in the fundamental emission.

Option 2

The automatic bandwidth measurement capability of an instrument may be employed using the X dB bandwidth mode with X set to 6 dB, if the functionality described in 11.8.1 (i.e., RBW = 100 kHz, VBW $\geq 3 \times$ RBW, and peak detector with maximum hold) is implemented by the instrumentation function. When using this capability, care shall be taken so that the bandwidth measurement is not influenced by any intermediate power nulls in the fundamental emission that might be ≥ 6 dB.

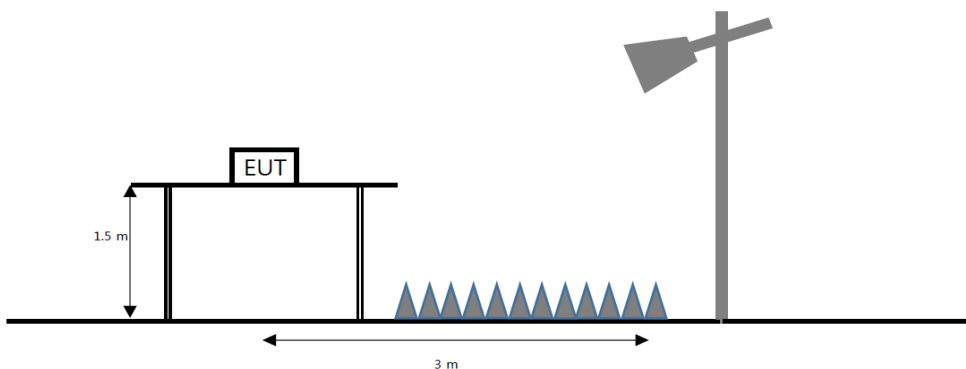
The diagram below shows the test setup that is utilized to make the measurements for emission from 9 kHz to 30 MHz Emissions

The field strength of emissions appearing within these frequency bands shall not exceed the limits shown in section 15.209. At frequencies equal to or less than 1 000 MHz, compliance with the limits in section 15.209 shall be demonstrated using measurement instrumentation employing a CISPR quasi-peak detector. Above 1 000 MHz, compliance with the emission limits in section 15.209 shall be demonstrated based on the average value of the measured emissions. The provisions in section 15.35 apply to these measurements.

According to RSS-247(5.5), In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated device is operating, the RF power that is produced shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided that the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of root-mean-square averaging over a time interval, as permitted under section 5.4(d), the attenuation required shall be 30 dB instead of 20 dB. According to RSS-Gen(8.10), Restricted frequency bands, identified in table 7, are designated primarily for safety-of-life services (distress calling and certain aeronautical activities), certain satellite downlinks, radio astronomy and some government uses. Except where otherwise indicated, the following conditions related to the restricted frequency bands apply:

- The transmit frequency, including fundamental components of modulation, of licence-exempt radio apparatus shall not fall within the restricted frequency bands listed in table 7 except for apparatus compliant with RSS-287, Emergency Position Indicating Radio Beacons (EPIRB), Emergency Locator Transmitters (ELT), Personal Locator Beacons (PLB), and Maritime Survivor Locator Devices (MSLD).
- Unwanted emissions that fall into restricted frequency bands listed in table 7 shall comply with the limits specified in table 5 and table 6.
- Unwanted emissions that do not fall within the restricted frequency bands listed in table 7 shall comply either with the limits specified in the applicable RSS or with those specified in table 5 and table 6.

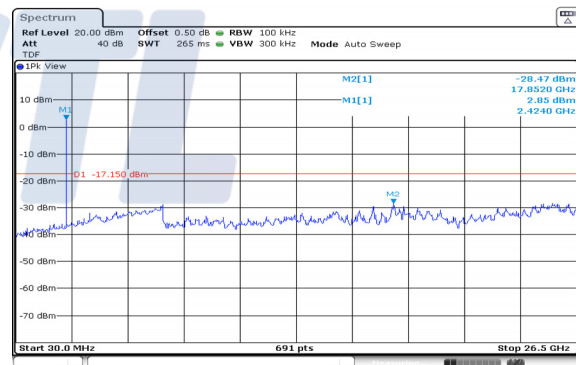
Conducted band-edge / Low ch.

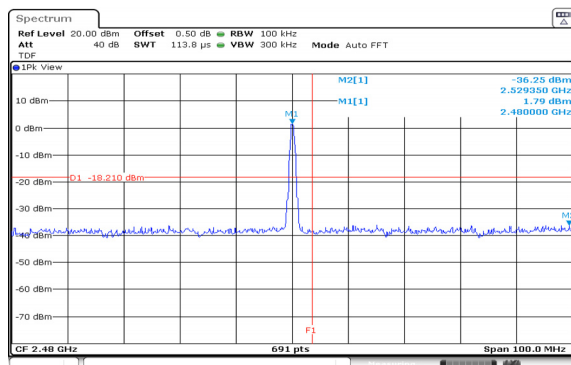

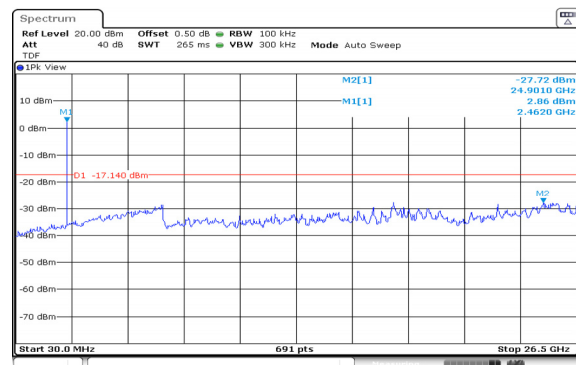
