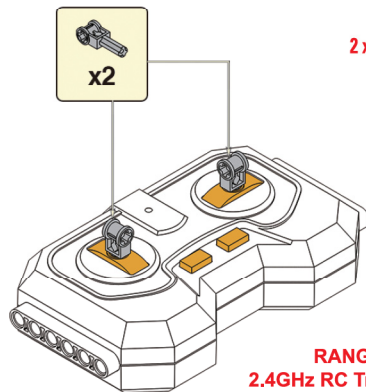
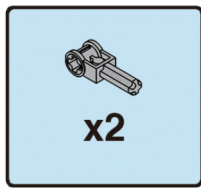
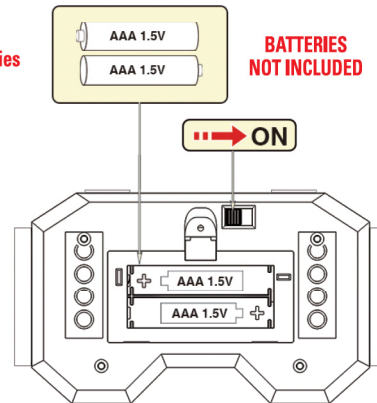


# REMOTE CONTROL RACE CAR INSTRUCTIONS

## Battery Installation



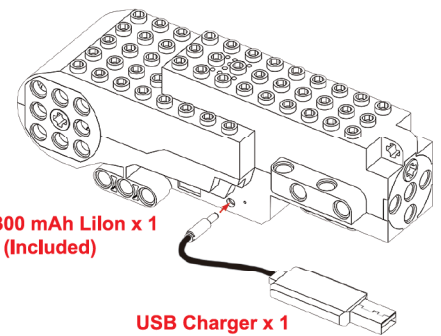
2 x 1.5 V Micro AAA batteries



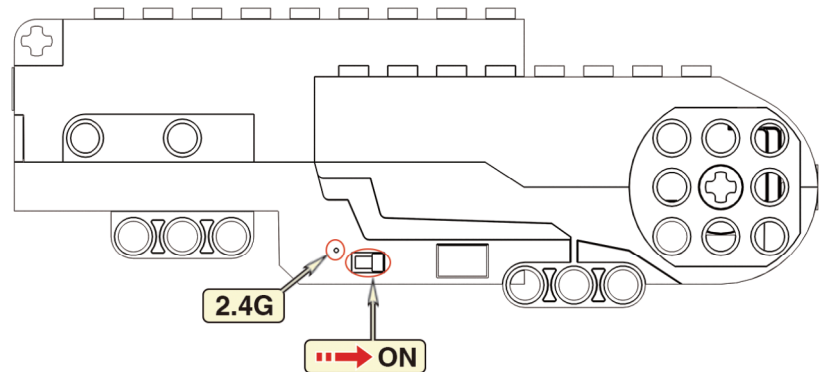

1. Unscrew and open the controller battery cover, install 2 AAA batteries and please pay attention to the correct polarity direction, then screw the battery cover.
2. Please charge the car Li-po battery before using, connect the car battery with mobile phone charger or power bank by USB cable (Charging equipment above 2A is not recommended). The USB red light will be on when charging and be off after full charged. The charging time is about 3 hours.
3. This toy (vehicle) contains batteries that are non-replaceable. Take care only to charge the LiPo battery supplied with the LiPo charging unit (USB-C charger cable) also supplied. if you attempt to recharge the battery with any other LiPo battery charger or any other type of charger, this may result in serious damage. You can recharge the rechargeable battery with the respective USB-C charger cable from a computer USB port (USB 3.0) or a USB power supply unit with at least 1 A output voltage.



4. 2.4G frequency connection: Turn on the power switch on the controller and the car, the indication light will be flickering, and when the indication light is off the frequency connection is successful.
5. Functions: forward, backward, turn left, turn right, Remote control distance: <30 meters
6. The car will enter sleep mode if no operation after 2 minutes, restart needs to press any direction key. Please turn off the controller and car power if it's not played for a long time.



## Battery Precaution

1. The 3.7V rechargeable battery pack must be charged before use by utilizing the battery charger which included.
2. Do not overcharge the battery pack. Do not charge for more than 6 hours.
3. Do not charge the battery pack if it shows leakage, corrosion, or has loose or exposed wires or other damage.
4. Do not cover the battery pack with any sort of materials while charging.
5. Do not touch the battery pack when it is hot.
6. Do not dispose of the battery in fire.
7. Do not dismantle the battery or charger, and do not cut the battery or charger cables.
8. The battery pack will be warm after charging, and hot after use in a vehicle.
9. The supply terminals are not to be short-circuited.
10. Rechargeable batteries for adult charging only.
11. Battery replacement must be only made by adults.
13. The transformer (charger) is not a toy.
14. Charge only type (300mAh Max.) rechargeable battery packs. Other types of batteries may burst causing injury to persons and damage. This power unit is intended to be correctly orientated in a vertical or floor mount position. This charger is intended to be used for charging 3.7V rechargeable battery pack with capacity 300mAh Max. It cannot be used for charging non-rechargeable batteries. Regular examination of battery charger for any damage to their cord, plug, enclosure and other parts, and that, in the event of such damage, it must not be used with the charger or battery pack charge until such damage has been repaired. Note that the AAA batteries is non-rechargeable and is not to be recharged. Only batteries of the same or equivalent type as recommended are to be used. It will need replacement when transmission is poor.
15. Exhausted batteries are to be removed from the product.

## Charging the Rechargeable Battery Pack for the Vehicle:

1. Connect the 3.7V rechargeable battery pack to the battery charger.
2. Plug the USB charger into the USB port.
3. The charging time for a full charge is about 3 hours.
4. When charging is completed, unplug the USB charger from the USB port.
5. Disconnect the rechargeable battery pack from the battery charger.
6. The battery charger used with the electric toy shall be regularly examined for damage to the supply cord, plug, enclosure or other parts, and in the event of damage, it shall not be used until the damage has been repaired.

## Start To Play

### To Match the signal of the Vehicle and Transmitter

1. Make sure the Vehicle and Transmitter are installed with batteries.
2. Switch ON the Vehicle.
3. Switch ON the Transmitter.
4. The indication light will be flickering, and when the indication light is off the frequency connection is successful.
5. To avoid interference to the signal matching process, please make sure there is no other 2.4GHz device operating in the same area during the process.
6. If the Vehicle is matched with more than one Transmitter, or more than one Vehicles are matched with one Transmitter. Just repeat the matching procedures and make sure only one Vehicle and one Transmitter is switched ON in the signal matching process.

### How to Play

1. Switch ON the Vehicle.
2. Use the Forward / Backward joystick to drive the Vehicle forward and backward.
3. Use the Left / Right joystick to control the Vehicle turning left or right.
4. If the vehicle does not run in straight line, adjust the Direction Adjustment on the vehicle chassis.
5. Play on smooth surface to have the optimum performance.
6. Remember to switch OFF the power of the Vehicle and Transmitter after playing.
7. The optimum control range is up to 25m outdoor.

### Performance Tips

1. Do not drive on dirt, sand, dusts or go through water
2. Do not drive in windy or rainy weather
3. Avoid direct impact the Vehicle with obstacles
4. Switch OFF the power when not in use to prevent damage of Vehicle and Transmitter due to leakage of electrolyte from batteries
5. Remove all batteries from the Vehicle and Transmitter when not in use for long period
6. Keep fingers, hair and loose clothing away from wheels, belt, skis
7. The operating range can be affected by a variety of factors
  - a) Low Voltage of batteries in Transmitter or Vehicle
  - b) Interference from other items that emit radio frequency signals
8. Outdoor usage is recommended in order to get optimum control range
9. Recommend to play the vehicle on a clean and smooth surface
10. Clean the battery compartment to make sure it is free from dust to prevent poor contact of batteries

### Cautions

1. Do not attempt to disassemble the Vehicle or Transmitter
2. Make sure the batteries are installed with correct polarities (+/-) as shown inside the battery compartment
3. Remove the package and take out all accessories before giving the Vehicle and Transmitter to child to play
