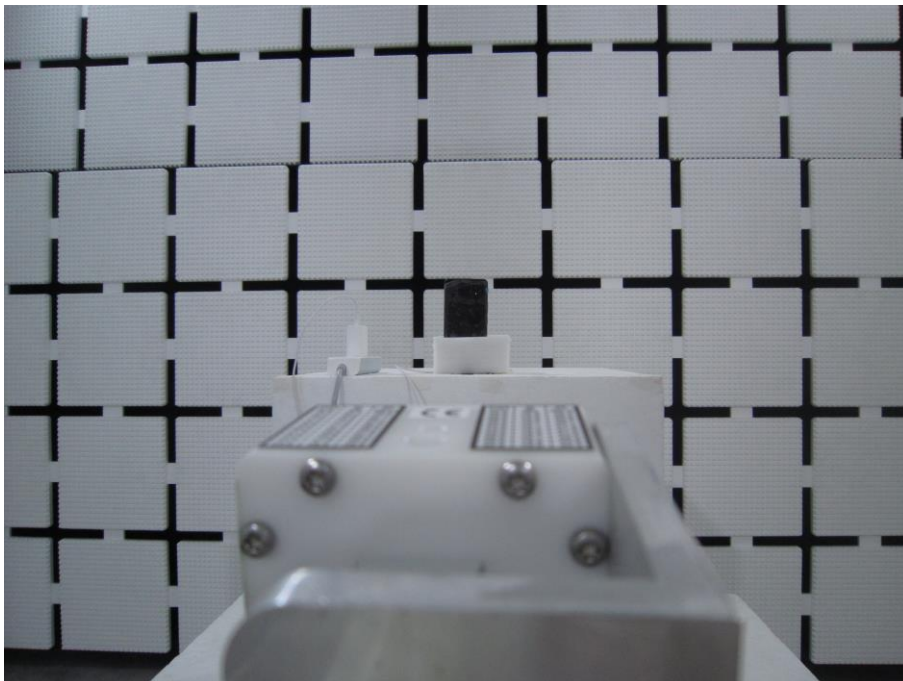

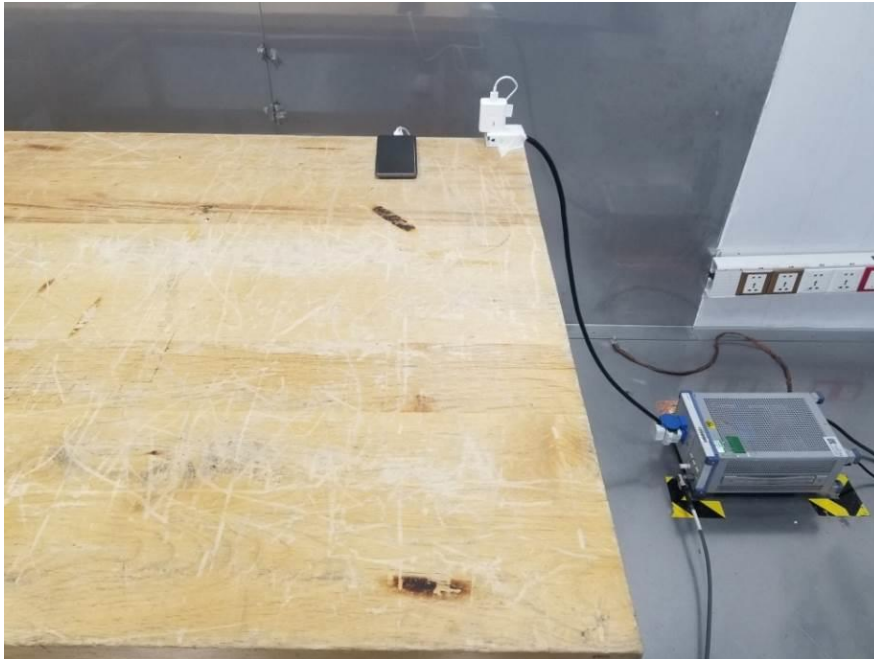

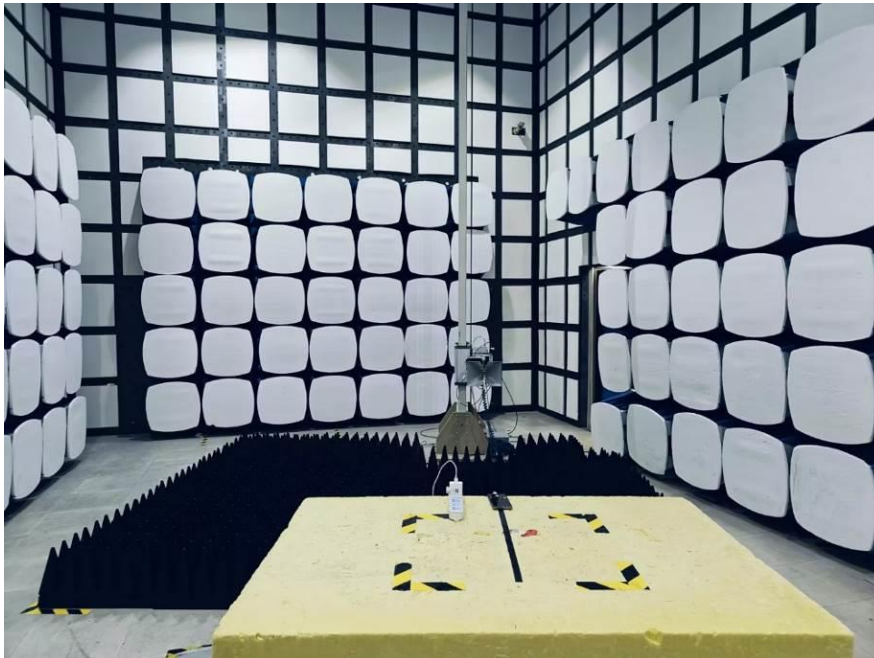

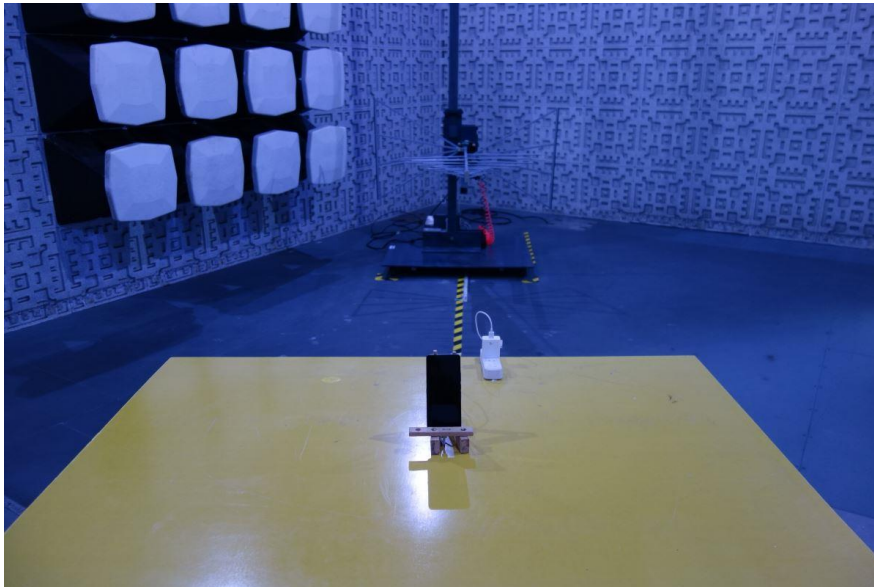

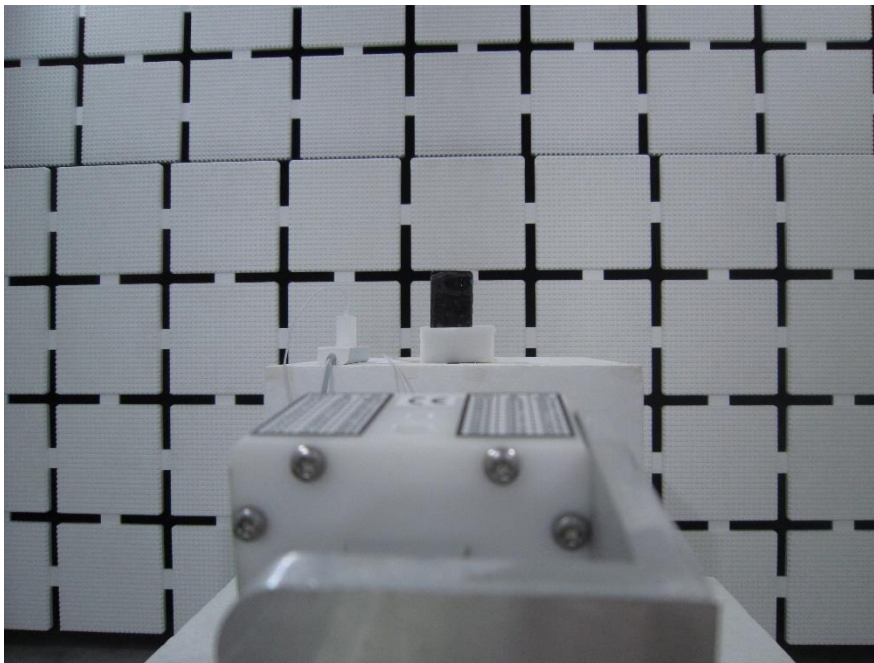
Conducted Emissions at AC Power Line (150kHz-30MHz)



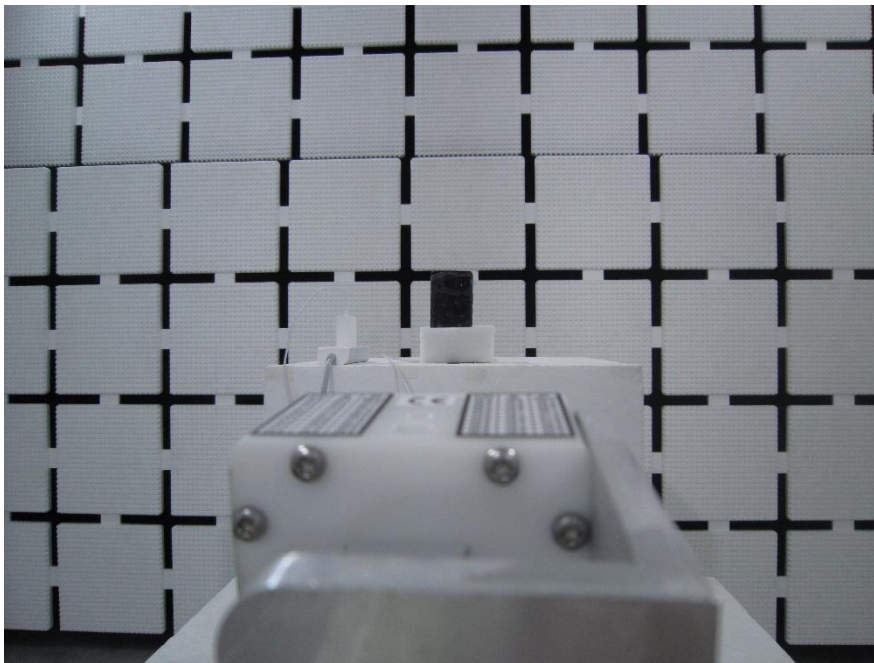
Radiated Emissions (Below 1GHz)

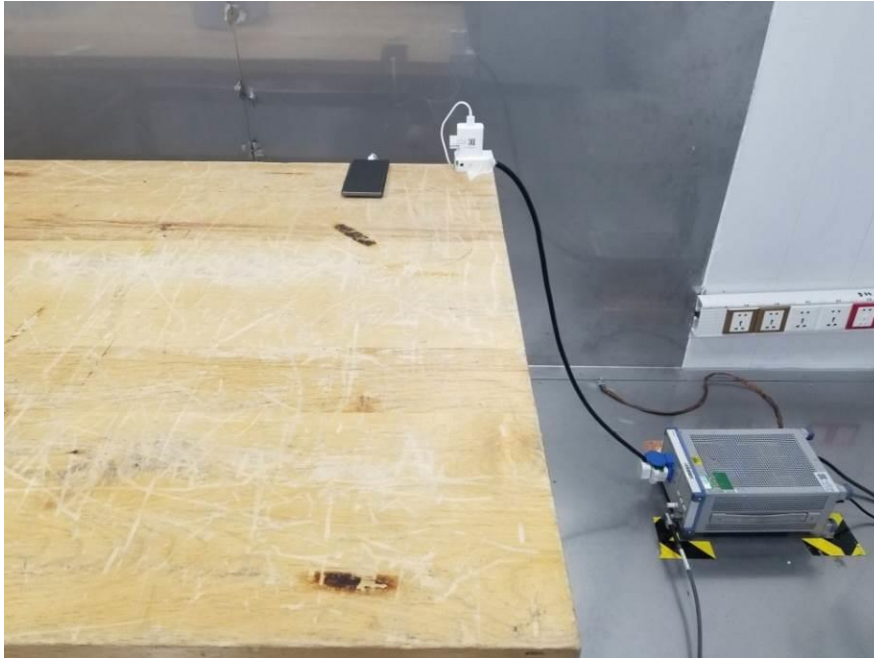

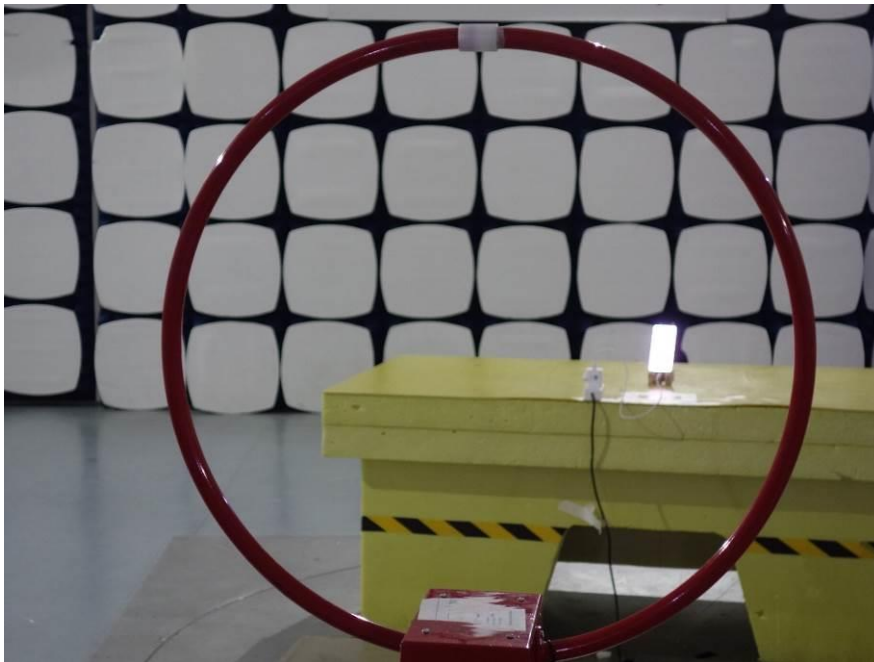

Conducted Emissions at Mains Terminals (150kHz-30MHz)



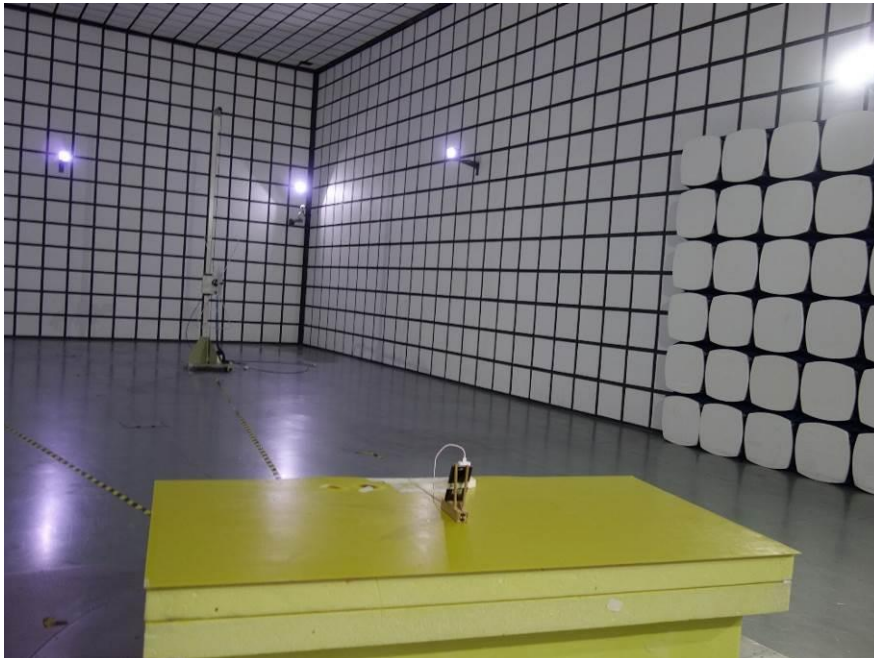
Emission Mask
