9 Technical Requirement

9.1 Conducted Emission

Test Method

1. The EUT was placed 0.4 meter from the conducting wall of the shielding room was kept at least 80 centimeters from any other grounded conducting surface.
2. Connect EUT to the power mains through a line impedance stabilization network (LISN).
3. All the support units are connecting to the other LISN.
4. The LISN provides 50 ohm coupling impedance for the measuring instrument.
5. Both sides of AC line were checked for maximum conducted interference.
6. The frequency range from 150 kHz to 30 MHz was searched.
7. Set the test-receiver system to Peak Detect Function and specified bandwidth (IF Bandwidth = 9kHz) with Maximum Hold Mode. Then measurement is also conducted by Average Detector and Quasi-Peak Detector Function respectively.

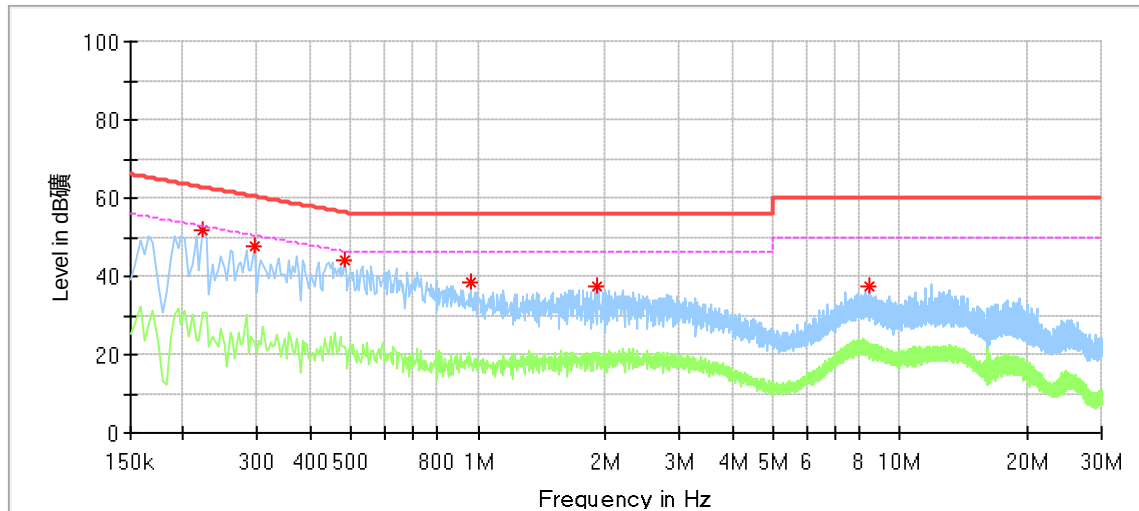

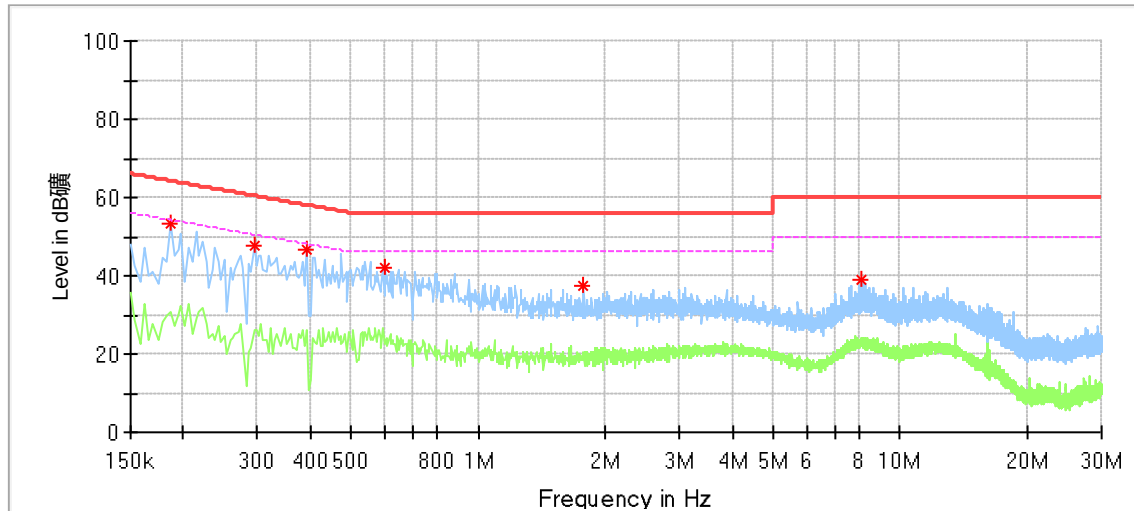

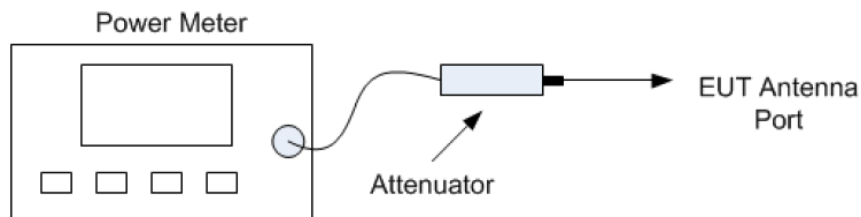

9.2 Conducted output power

Test Method

- 1) The EUT is configured to transmit continuously, or to transmit with a constant duty cycle.
- 2) At all times when the EUT is transmitting, it shall be transmitting at its maximum power control level.
- 3) The integration period of the power meter exceeds the repetition period of the transmitted signal by at least a factor of five.
- 4) Measure the peak power of the transmitter. This measurement is a peak over both the ON and OFF periods of the transmitter.

9.3 6dB bandwidth

Test Method

1. The RF output of EUT was connected to the spectrum analyzer. The path loss was compensated to the results for each measurement.
2. Set to the maximum power setting, the instrument center frequency is set to the nominal EUT channel center frequency enable the EUT transmit continuously.
3. Use the following spectrum analyzer settings:
RBW= RBW=1% to 5% of EBW, or a minimum of 1 MHz if this is not possible due to a large EBW, unless otherwise specified by the applicable rule, VBW $\geq$ 3RBW, Sweep = auto, Detector function = peak, Trace = max hold
4. Use the automatic bandwidth measurement capability of an instrument, use the X dB bandwidth mode with X set to 6 dB.
5. Allow the trace to stabilize, record the 6 dB Bandwidth value.

9.4 Power spectral density

Test Method

This procedure shall be used if maximum peak conducted output power was used to demonstrate compliance:

1. The RF output of EUT was connected to the spectrum analyzer. The path loss was compensated to the results for each measurement.
2. Set to the maximum power setting, the instrument center frequency is set to the nominal EUT channel center frequency enable the EUT transmit continuously.
3. Use the following spectrum analyzer settings:
4. Set analyzer center frequency to DTS channel center frequency. RBW=3kHz, VBW≥3RBW, Span=1.5 times DTS bandwidth, Detector=Peak, Sweep=auto, Trace= max hold.
5. Allow trace to fully stabilize, use the peak marker function to determine the maximum amplitude level within the RBW.
6. Repeat above procedures until other frequencies measured were completed.

9.5 Spurious RF conducted emissions

Test Method

1. The RF output of EUT was connected to the spectrum analyzer by RF cable. The path loss was compensated to the results for each measurement.
2. Set to the maximum power setting, the instrument center frequency is set to the nominal EUT channel center frequency enable the EUT transmit continuously.
3. Use the following spectrum analyzer settings:
Span = wide enough to capture the peak level of the in-band emission and all spurious emissions (e.g., harmonics) from the lowest frequency generated in the EUT up through the 10th harmonic. Typically, several plots are required to cover this entire span.
RBW = 100 kHz, VBW $\geq$ 3RBW, Sweep = auto, Detector function = peak, Trace = max hold
4. Allow the trace to stabilize. Set the marker on the peak of any spurious emission recorded.
5. The level displayed must comply with the limit specified in this Section. Submit these plots.
6. Repeat above procedures until all frequencies measured were complete.
