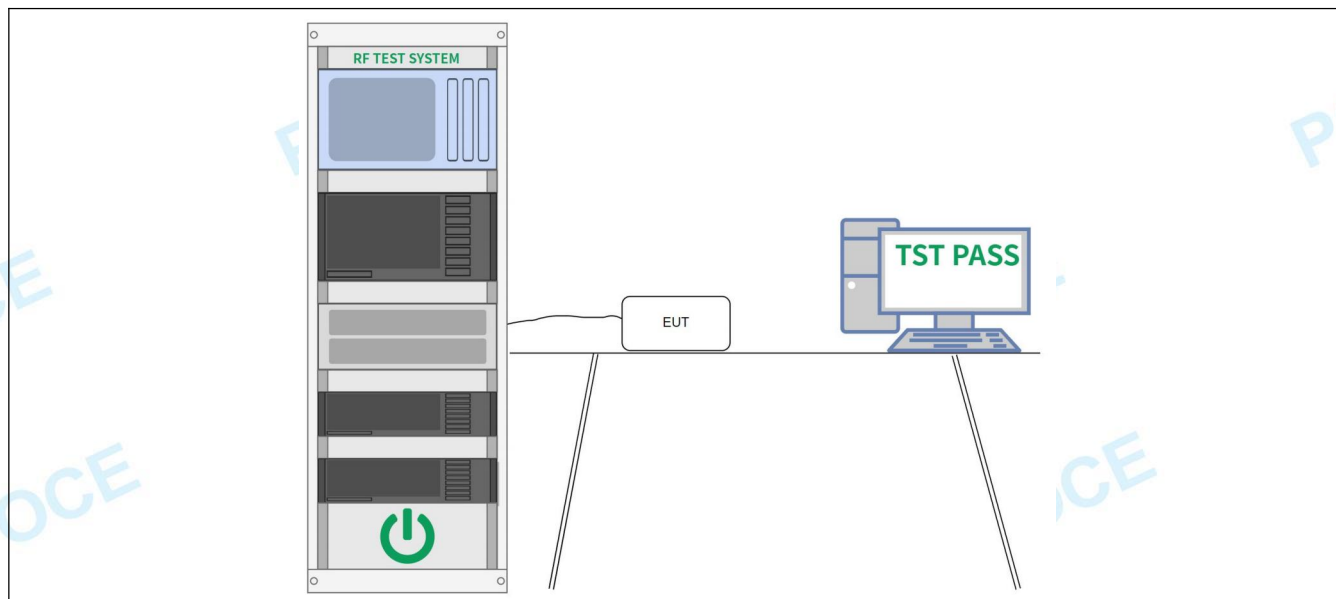

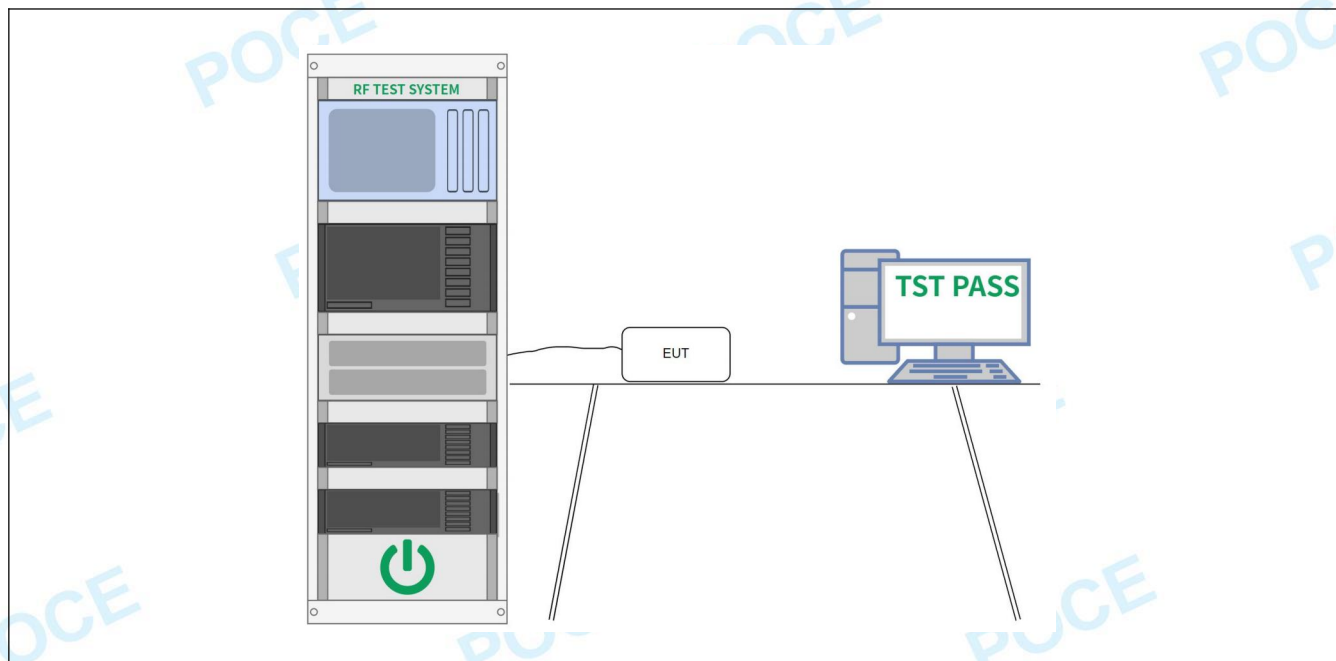

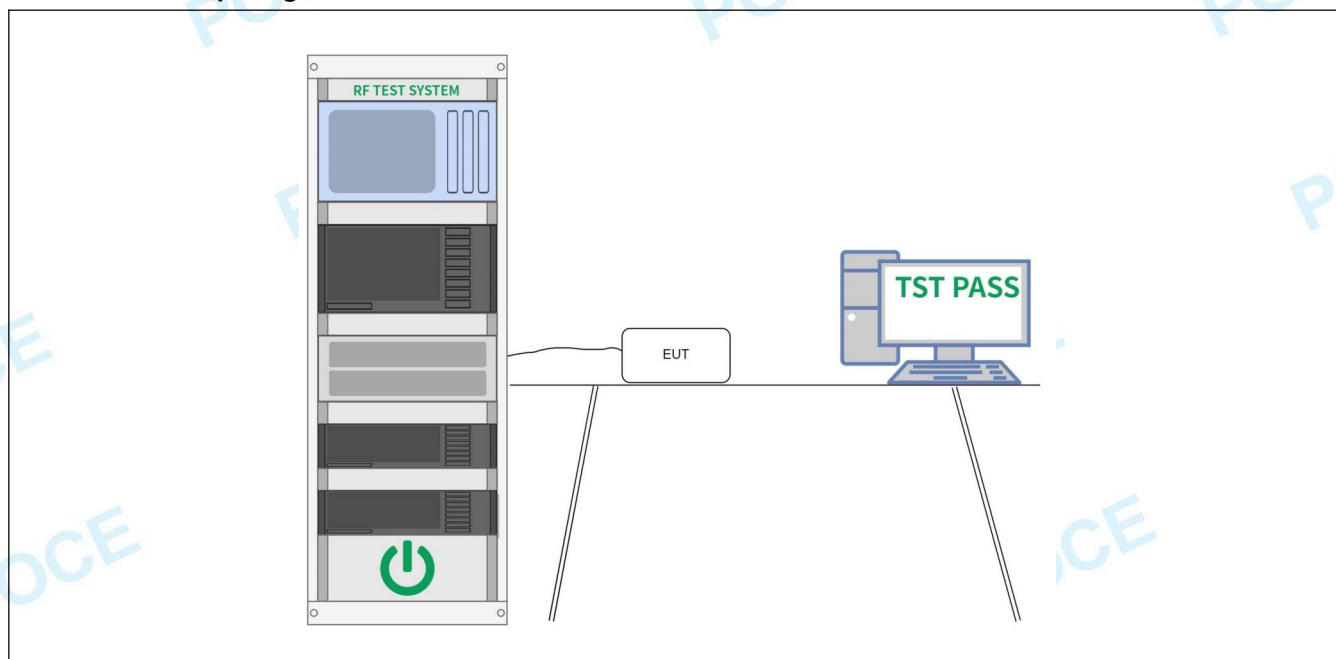

Emissions in frequency bands (below 1GHz)

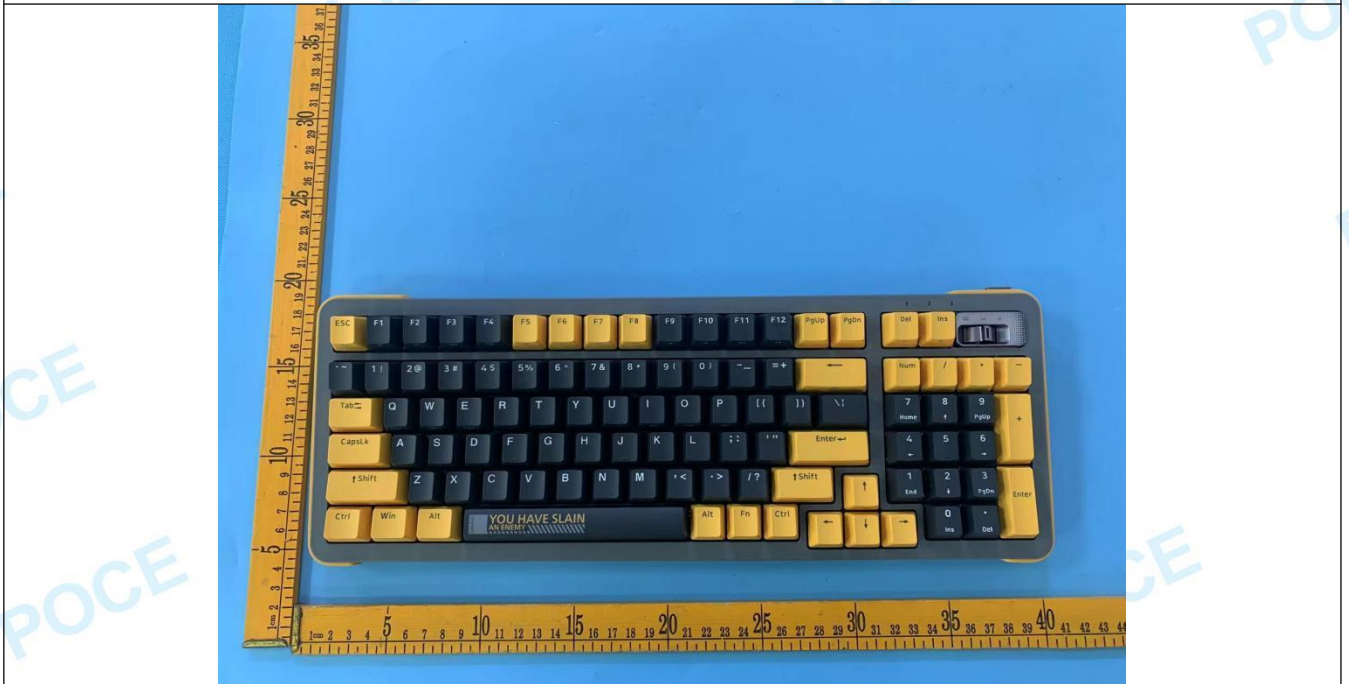


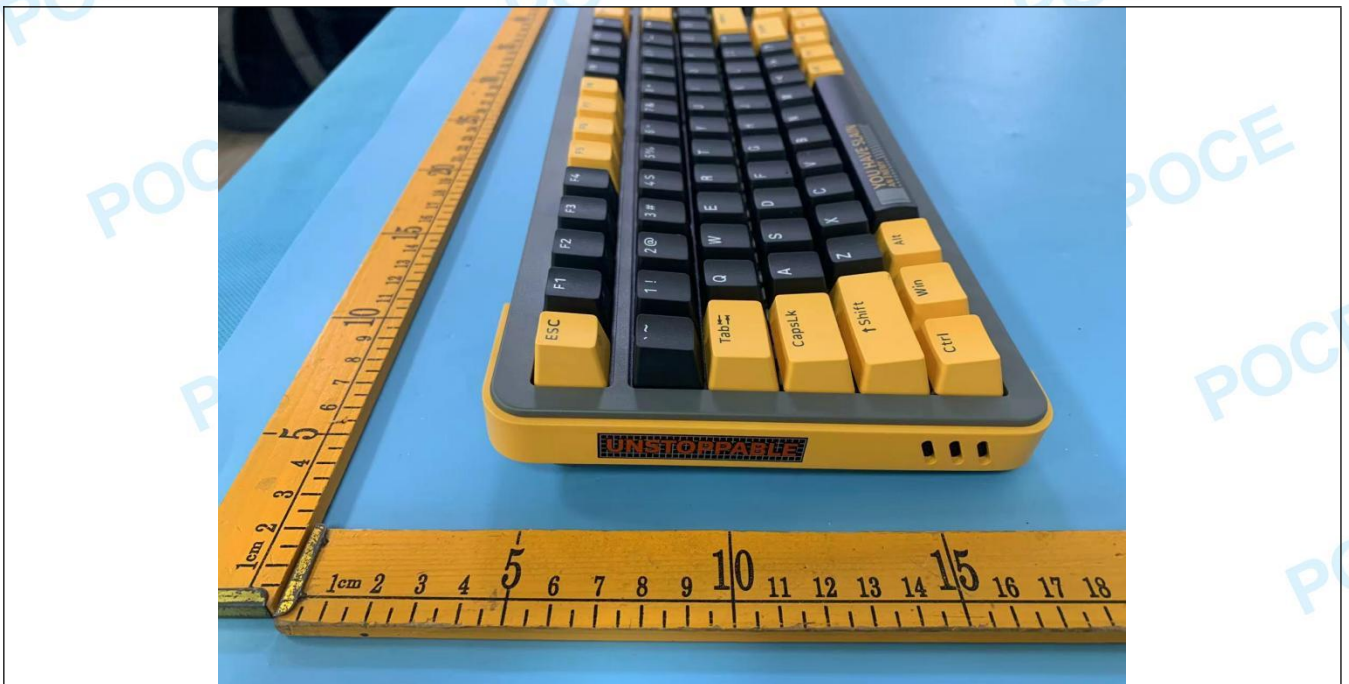
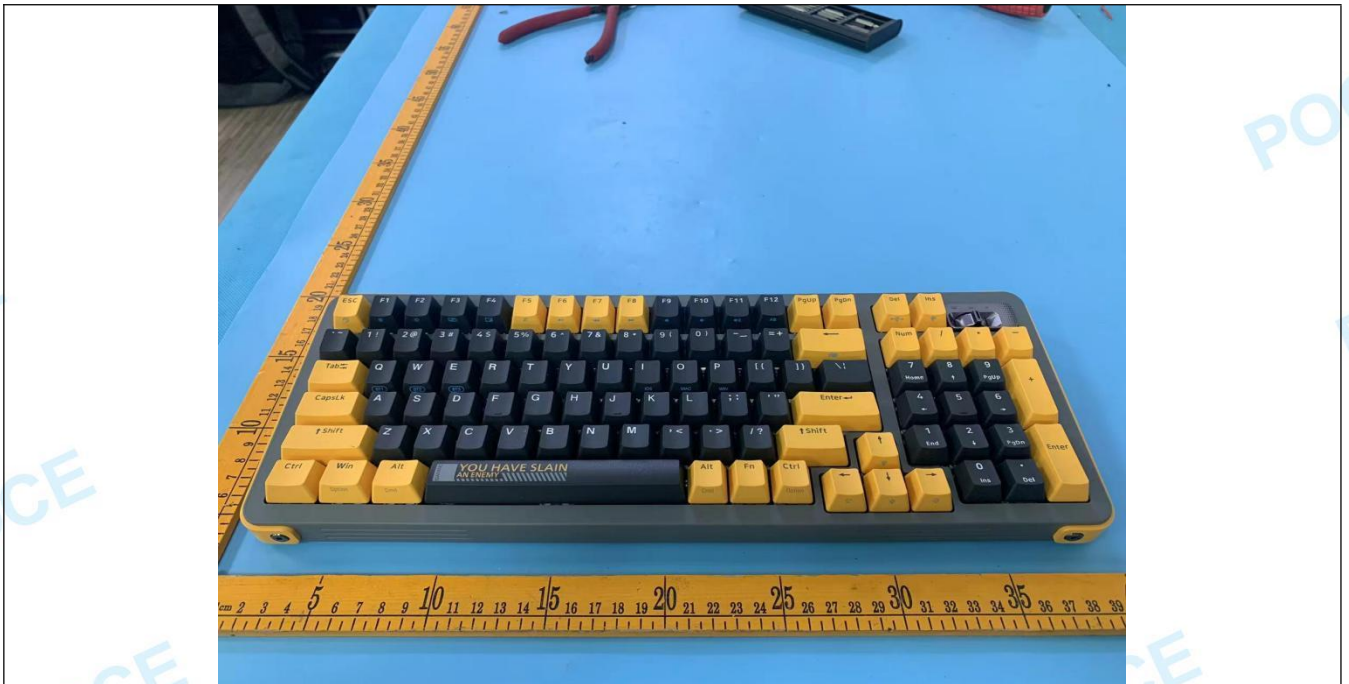

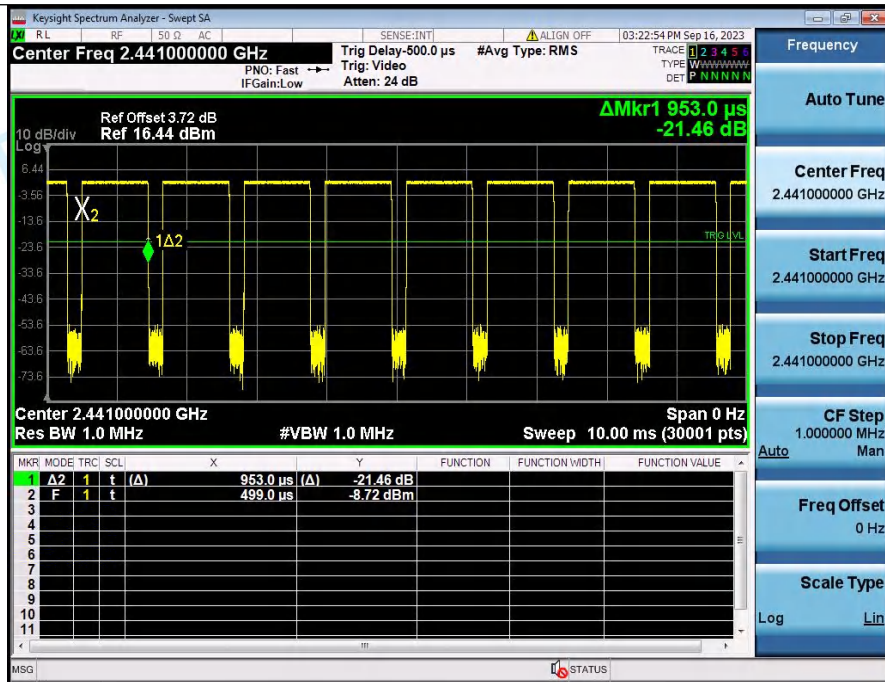
Dwell Time (Hopping) NVNT ANT1 1-DH1 2441 One Burst Time



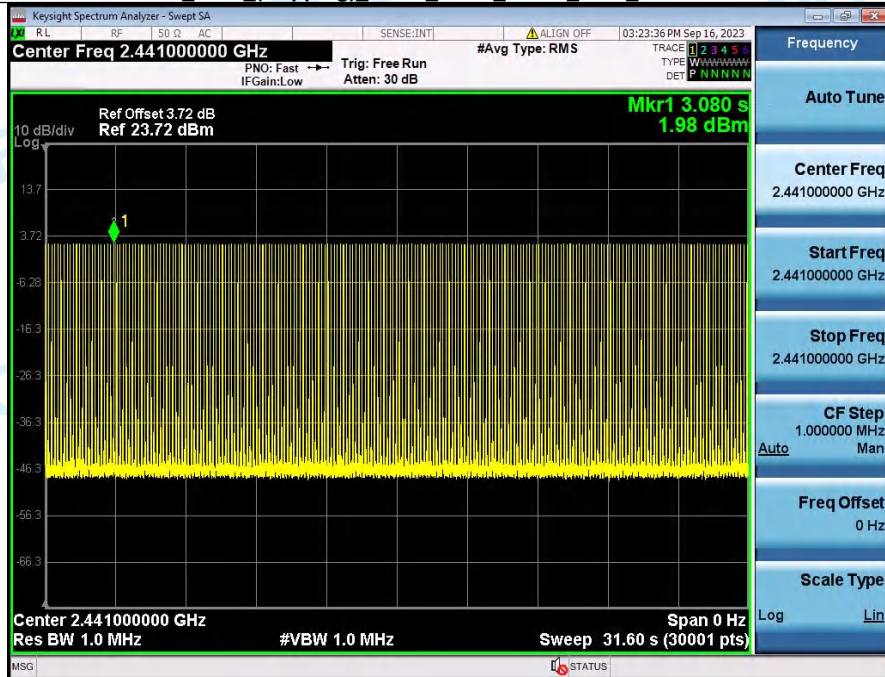
Dwell Time (Hopping) NVNT ANT1 1-DH1 2441 Accumulated

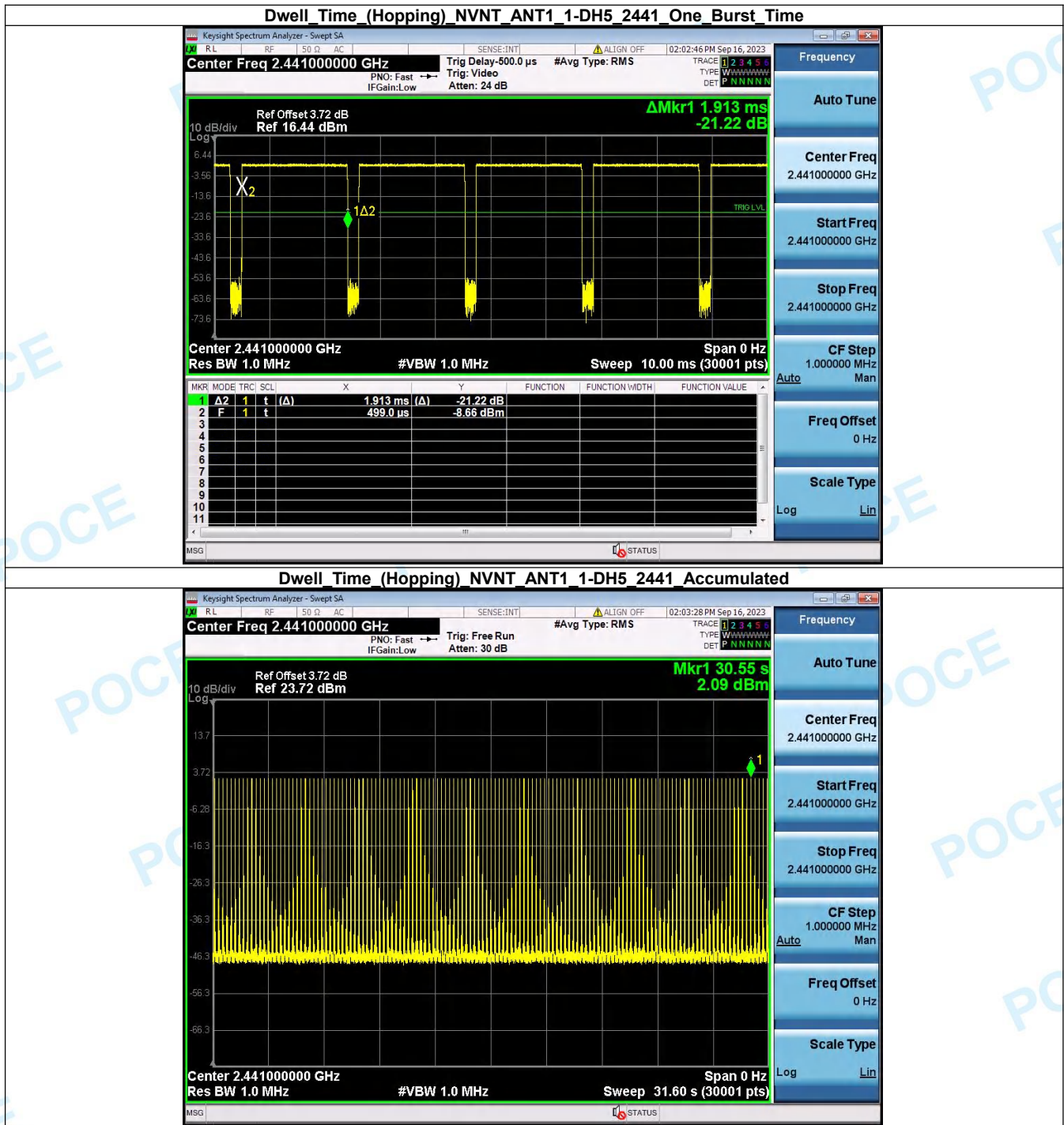


Dwell Time (Hopping) NVNT ANT1 1-DH3 2441 One Burst Time
