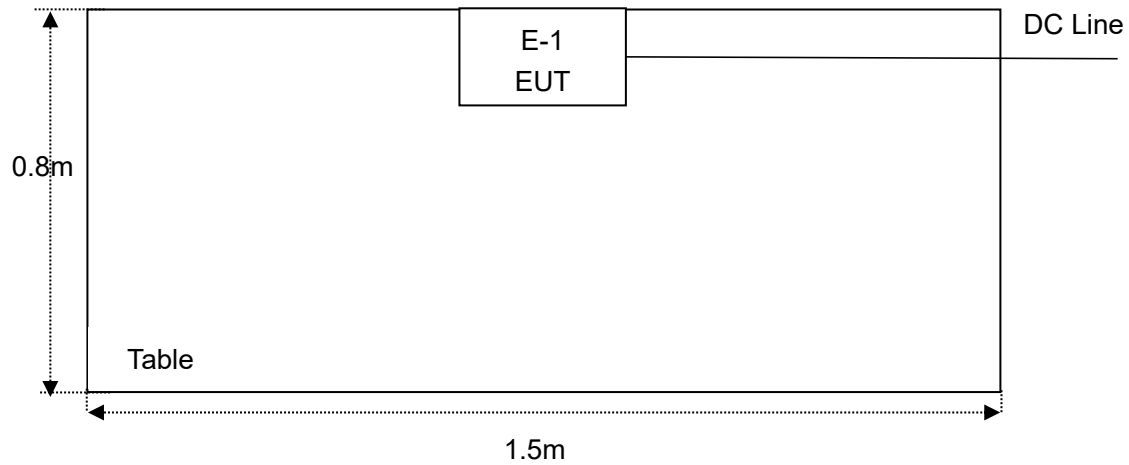

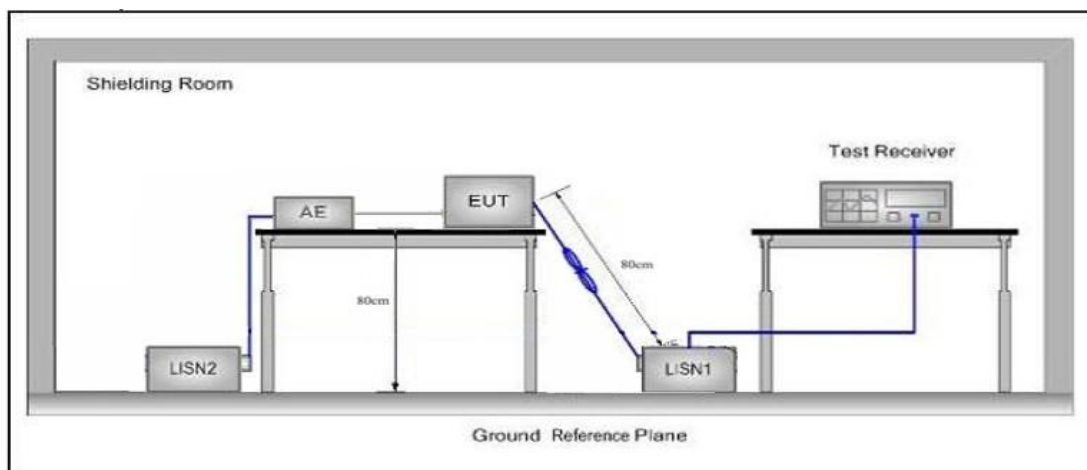

3.3. Test Procedure

The EUT system is connected to the power mains through a line impedance stabilization network (L.I.S.N.). This provides a 50ohm coupling impedance for the EUT system. Please refer the block diagram of the test setup and photographs. Both sides of AC line are checked to find out the maximum conducted emission. In order to find the maximum emission levels, the relative positions of equipment and all of the interface cables shall be changed according to FCC ANSI C63.10: 2020 on Conducted Emission Measurement.

The bandwidth of test receiver (ESCI) set at 9kHz.

The frequency range from 150kHz to 30MHz is checked.

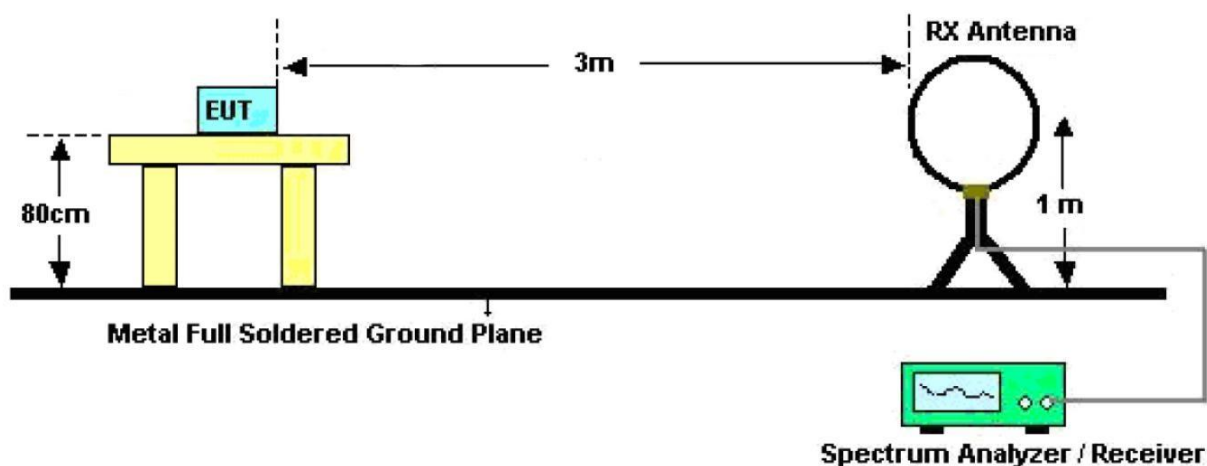


Figure 1. Below 30MHz



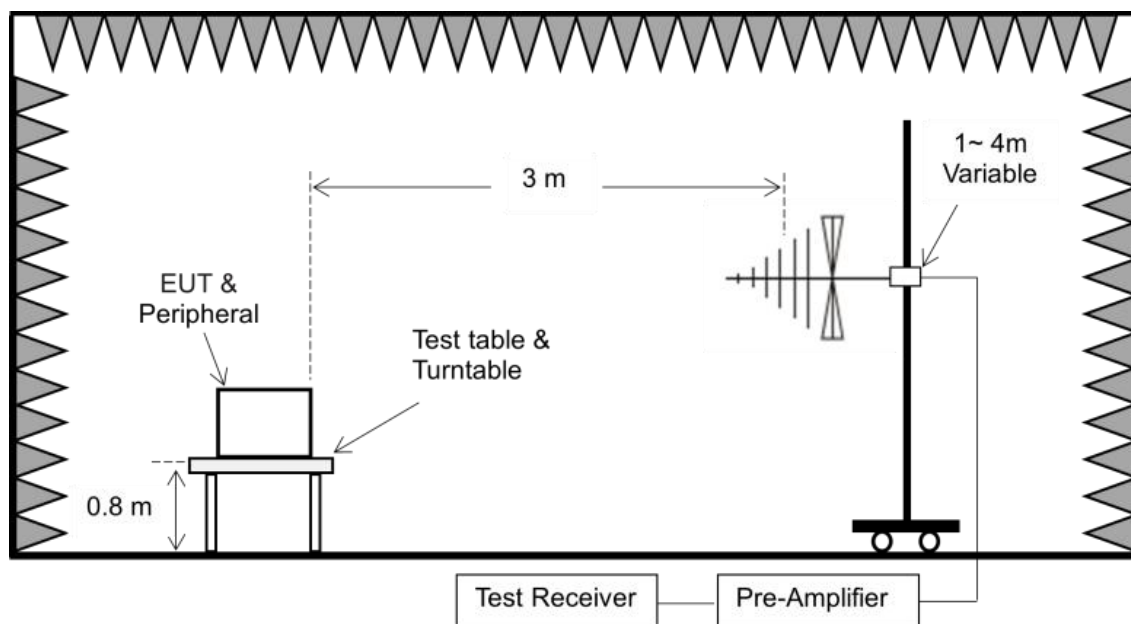


Figure 2. 30MHz to 1GHz

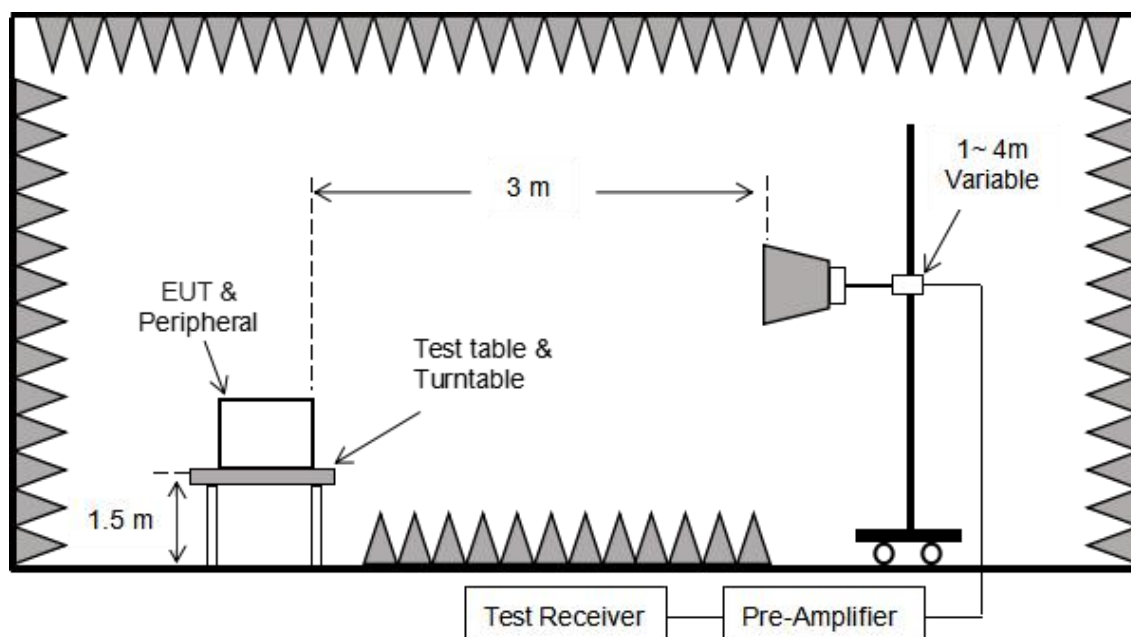


Figure 3. Above 1 GHz

4.3. Test Procedure

For below 1GHz: The EUT is placed on a turntable, which is 0.8m above the ground plane.

For above 1GHz: The EUT is placed on a turntable, which is 1.5m above the ground plane.

The turn table can rotate 360 degrees to determine the position of the maximum emission level. The EUT is set 3 meters away from the receiving antenna which is mounted on a antenna tower. The antenna can be moved up and down from 1 to 4 meters to find out the maximum emission level. Rotated the EUT through three orthogonal axes to determine the maximum emissions, both horizontal and vertical polarization of the antenna are set on test. The EUT is tested in 9*6*6 Chamber. The device is evaluated in xyz orientation.



For the radiated emission test above 1GHz:

Place the measurement antenna away from each area of the EUT determined to be a source of emissions at the specified measurement distance, while keeping the measurement antenna aimed at the source of emissions at each frequency of significant emissions, with polarization oriented for maximum response. The measurement antenna may have to be higher or lower than the EUT, depending on the radiation pattern of the emission and staying aimed at the emission source for receiving the maximum signal. The final measurement antenna elevation shall be that which maximizes the emissions. The measurement antenna elevation for maximum emissions shall be restricted to a range of heights of from 1 m to 4 m above the ground or reference ground plane.

For 9kHz to 150kHz, Set the spectrum analyzer as:

RBW = 200Hz, VBW = 1kHz, Detector= Quasi-Peak, Trace mode= Max hold, Sweep- auto couple.

For 150kHz to 30MHz, Set the spectrum analyzer as:

RBW = 9KHz, VBW = 30kHz, Detector= Quasi-Peak, Trace mode= Max hold, Sweep- auto couple.

For 30MHz to 1000MHz, Set the spectrum analyzer as:

RBW = 100kHz, VBW = 300kHz, Detector= Quasi-Peak, Trace mode= Max hold, Sweep- auto couple.

For above 1GHz, Set the spectrum analyzer as:

RBW = 1MHz, VBW = 1MHz, Detector= Peak, Trace mode= Max hold, Sweep- auto couple.

For average measurement:

–VBW=10Hz, When duty cycle is no less than 98 percent

–VBW $\geq 1/T$, when duty cycle is less than 98 percent where T is the minimum transmission duration over which the transmitter is on and is transmitting at its maximum power control level for the tested mode of operation, so refer to this clause 5.4 duty cycle.

4.4. Test Data

During the test, Pre-scan all kind of the place mode (X-axis, Y-axis, Z-axis), and found the X-axis is the worst case.

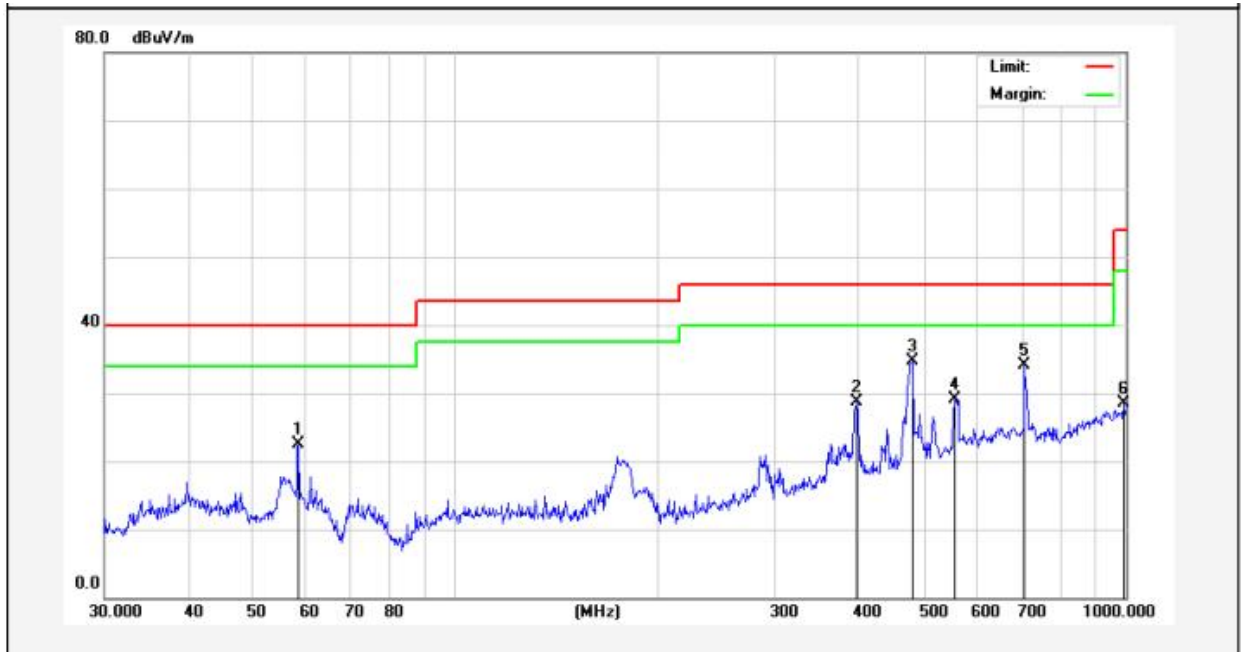

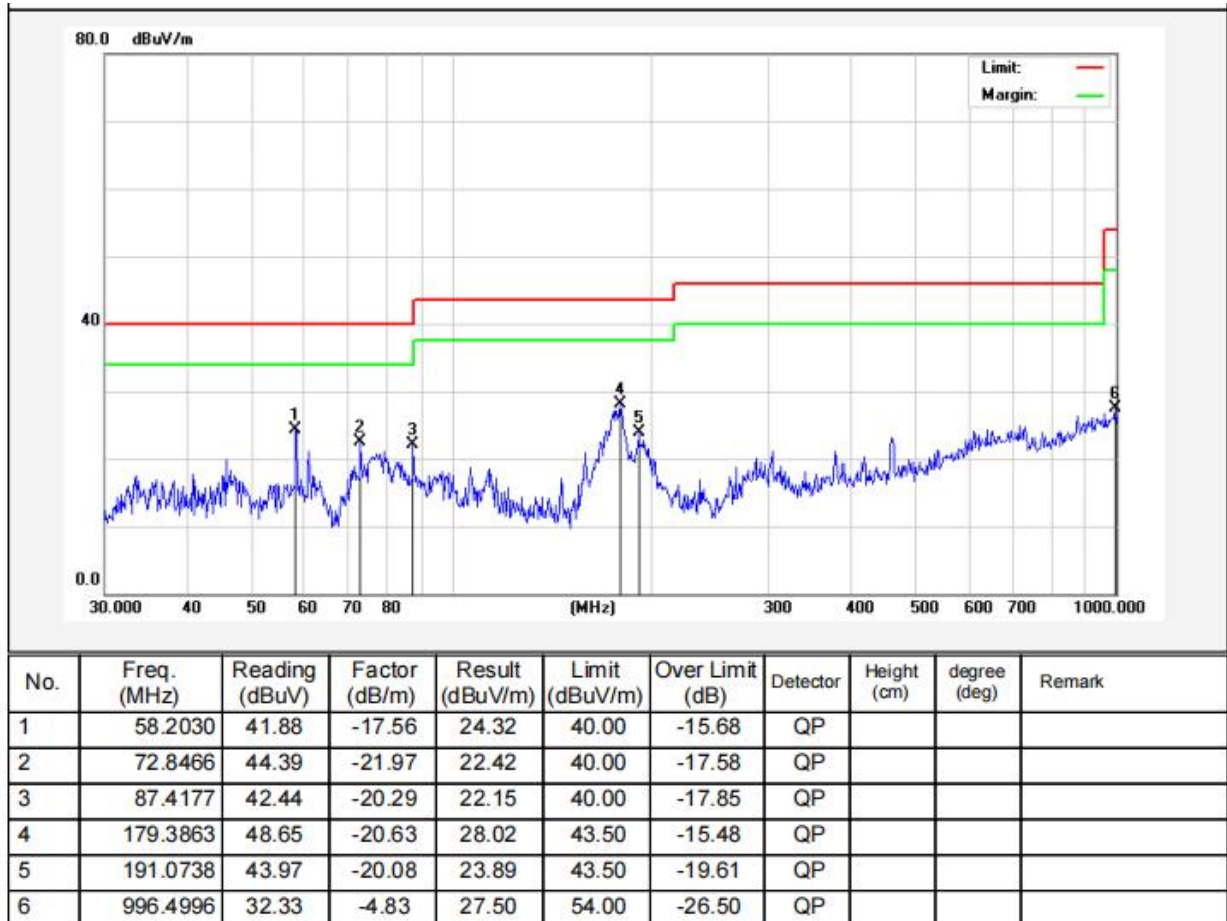

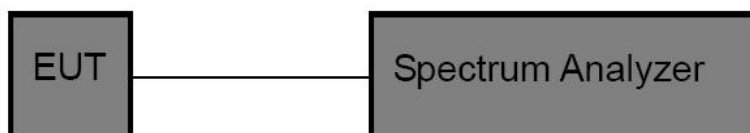

1. Measure the duty cycle D of the transmitter output signal.
2. Set span to at least 1.5 times the OBW.
3. Set RBW = 1% to 5% of the OBW, not to exceed 1 MHz.
4. Set VBW $\geq [3 \times \text{RBW}]$.
5. Number of points in sweep $\geq [2 \times \text{span} / \text{RBW}]$.
6. Sweep time = auto.
7. Detector = RMS
8. Trace average at least 100 traces in power averaging (rms) mode; however, the number of traces to be averaged shall be increased above 100 as needed such that the average accurately represents the true average over the ON and OFF periods of the transmitter.
9. Compute power by integrating the spectrum across the OBW of the signal using the instrument's band power measurement function with band limits set equal to the OBW band edges. If the instrument does not have a band power function, then sum the spectrum levels (in power units) at intervals equal to the RBW extending across the entire OBW of the spectrum.
10. Add $[10 \log (1 / D)]$, where D is the duty cycle, to the measured power to compute the average power during the actual transmission times.

Note: The cable loss and attenuator loss were offset into measure device as amplitude offset.

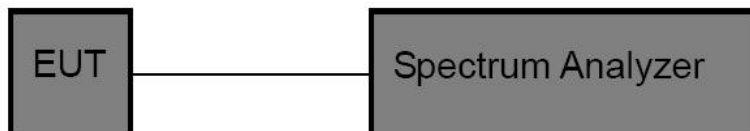

2. Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to the spectrum analyzer.
3. Set the spectrum analyzer as:
6dB Bandwidth:
 a) Set RBW = shall be in the range of 1% to 5% of the OBW but not less than 100 kHz.
 b) Set the VBW $\geq [3 \times \text{RBW}]$.
 c) Detector = peak.
 d) Trace mode = max-hold.
 e) Sweep = No faster than coupled (auto) time.
 f) Allow the trace to stabilize.
 g) Measure the maximum width of the emission by placing two markers, one at the lowest frequency and the other at the highest frequency of the envelope of the spectral display, such that each marker is at or slightly below the “-6 dB down amplitude”. If a marker is below this “-6 dB down amplitude” value, then it shall be as close as possible to this value.

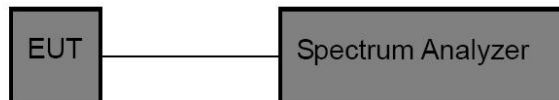

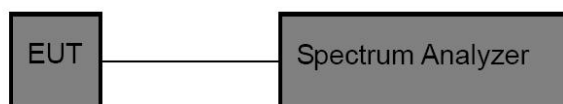

The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator, the manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited. 2) 15.247(c) (1)(i) requirement: Systems operating in the 2400-2483.5 MHz band that is used exclusively for fixed. Point-to-point operations may employ transmitting antennas with directional gain greater than 6dBi provided the maximum conducted output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6 dBi.

9.2. Antenna Connected Construction

The antenna is Ceramic Antenna which permanently attached, and the best case gain of the antenna is 1.35dBi. It complies with the standard requirement.
